## INDEPENDENT AUDITORS' REPORT

### Opinion

We have audited the financial statements of Oxbow Affiliated Companies Health Benefits Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the statements of net assets available for benefits and benefit obligations of Oxbow Affiliated Companies Health Benefits Plan as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). #### Note 1 – Description of Plan

The following description of the Oxbow Affiliated Companies Health Benefits Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan’s provisions.

**General** – The Plan provides health and other benefits covering all eligible employees, corporate officers and directors of the Oxbow Carbon LLC and certain of its wholly-owned affiliates (collectively, the “Company”) and their covered dependents. Certain affiliates’ retired employees are entitled to health benefits if they have at least 10 years of service with the Company after age 45 and retired employees hired after January 1, 1994 receive benefits if they have attained at least 20 years of service with the Company after age 35. As a result of the collective bargaining agreement (“CBA”) affecting certain participating employers, effective July 1, 2013, only active employees of the Company who were at least age 50 and had at least 15 years of service with the Company by December 31, 2016 are entitled to postretirement health benefits. All other active employees at July 1, 2013 and thereafter are no longer eligible for postretirement medical benefits.

The Plan was amended and restated as of January 1, 2019 in order to update the Plan to the latest compliance and regulatory laws.

The Plan’s assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Health Benefits** – The Plan provides self-insured health benefits (medical and prescription drug benefits) to eligible participants and their covered dependents. Retired employees are entitled to similar health benefits (in excess of Medicare coverage). The Plan also provides continuation of certain benefits upon termination of employment through medical and prescription drug benefits extension and the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

The Plan offers participants a Preferred Provider Organization (“PPO”) and high-deductible health plan (“HDHP”). The HDHP provides participants with a health savings account (“HSA”), which qualifies a tax-advantaged medical savings account. A participant who maintains an HSA account is the sole owner of that account balance. Accordingly, claims paid by participants from their HSA accounts and amounts transferred from employee payroll deductions or the Company’s general assets to the HSA are excluded from these financial statements.

The claims for self-insured benefits are processed by Blue Cross and Blue Shield of Florida, Inc. (“BCBS”) and Express Scripts, Inc. (“ESI”), the Plan’s third-party claims processors. BCBS operates under an administrative services agreement (“ASA”) with the Company that became effective as of January 1, 2017. ESI operates under a Pharmacy Benefit Management Agreement (“PBM”) with the Company that became effective as of January 1, 2018. Under the ASA and PBM, BCBS and ESI pay claims directly to or on behalf of participants and then are reimbursed by the Plan’s VEBA trust. Despite the Plan’s utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

**Contributions into the Plan’s VEBA Trust** – Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections (PPO or HDHP). The costs of the postretirement benefits are shared by the Company and retirees. Retirees contribute 20% of the estimated cost of providing their

postretirement benefits. Qualified individuals who utilize COBRA benefits must contribute 102% of the estimated cost to provide their postemployment benefits.

The Company contributes its share of the actuarially calculated premium which is used to purchase stop-loss coverage, fund claims, and other Plan operations.

#### **Note 2 – Summary of Accounting Policies**

The following accounting policies, which conform to accounting principles generally accepted in the United States of America ("GAAP"), have been used consistently in the preparation of the Plan's financial statements.

**Basis of Accounting** – The Plan's financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits** – Premiums payments are recorded when paid. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processor that have yet to be reimbursed by the Plan are recorded as amounts payable to claims administrators.

**Stop-Loss Insurance** – Premiums for stop-loss insurance are included in premiums paid. Stop loss refunds are netted with claims paid.

**Pharmacy Benefit Rebates** – The Plan utilizes pharmacy benefit scheme ("PBS") subcontractors from affiliates of ESI and BCBS who negotiate with drug manufactures for the purposes of prescription drug rebates. The PBS periodically makes rebates to the Plan based on the Plan's actual utilization pattern of specific prescription drugs. Rebates due from the Plan's PBS are recorded when earned. Rebates due as of December 31, 2024 and 2023 have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$1,292,916, have been netted with claims paid for the year ended December 31, 2024.

**Medicare Subsidy** – The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and the Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy in measuring its postretirement benefit obligations.

**Fair Value** – The carrying amounts of cash and pharmacy rebate receivable approximate fair value due to the short maturity of those instruments.

**Plan Termination** – Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**Risks and Uncertainties** – The Plan’s financial instruments that are exposed to concentrations of credit risk consists primarily of cash. The Plan places its cash with a high credit quality financial institution in order to minimize these risks. At times such deposits may be in excess of the Federal Deposit Insurance Corporations (“FDIC”) insurance limits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**Subsequent Events** – The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### Note 3 – Benefit Obligations

**Postretirement Benefit Obligation** – The postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents and (b) active employees and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 7.7% weighted-average annual rate of increase in the per capita cost of covered health care benefits was assumed for 2024; the rate was assumed to decrease gradually to 4.0% for 2050 and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligations at December 31, 2023.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by 1% in each year, it would increase the obligation as of December 31, 2024 and 2023, by \$791,282 and \$971,693, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of benefit obligations.

**Postemployment Benefit Obligations** – In addition, a postemployment benefit obligation has been recognized for health benefits for individuals currently on COBRA. COBRA benefit obligations as of December 31, 2024 and 2023 are estimated by management based on the number of employees utilizing COBRA benefits as of the year end, actual claims reported through August 2025, and prior year experience.

**Claims Payable and Claims Incurred But Not Reported** – Plan obligations as of December 31, 2024 and 2023 for claims payable and claims incurred but not reported are estimated by the Plan’s management with principles based on actual claims reported through August 2025 and prior year experience. These amounts are paid by the Plan only if claims are submitted and approved for payment.

### Note 4 – Stop-Loss Insurance Coverage

The Company contracts with ReliaStar Life Insurance Company (“ReliaStar”) in an effort to limit its exposure for self-insured benefits. Under the terms of the policy, the ReliaStar will reimburse 100% of eligible expenses in excess of \$125,000 per covered individual. The policy also provides up to \$2,000,000 of coverage after the minimum aggregate deductible of \$7,937,531 has been met. For the year ended December 31, 2024, reimbursements paid to the Plan and netted with claims paid totaled \$2,210,769.

#### Note 5 – Administrative Expenses

The Plan's administrative expenses consist of fees paid for regulatory requirements and fees paid to BCBS, ESI and others for services relating to claims processing. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan. The Plan paid amounts approximating \$260,000 to BCBS and \$115,000 to EXP under the ASA and PBM for the year ended December 31, 2024. Other miscellaneous administrative expenses totaled approximately \$8,000 for the year ended December 31, 2024.

#### Note 6 – Related Party and Party-in-Interest Transactions

As described in Note 1 and 5, the Plan has an arrangement with service providers for claims processing. These transactions are considered party-in-interest transactions under ERISA.

#### Note 7 – Tax Status

The Internal Revenue Service ruled in letters dated October 20, 2003 that the trusts established under the Plan qualify under Section 501(c)(9) of the Internal Revenue Code ("IRC") and, therefore, the trusts are not subject to tax under present income tax law. The Plan has been amended since receiving the exemption letter. The plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trusts were tax exempt at the financial statement date.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.
