INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lakeside Educational Network 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

The following description of the Lakeside Educational Network 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a 403(b) retirement plan covering employees of Lakeside Youth Service (the Company). Other than employees who work less than 20 hours per week, employees are immediately eligible to make elective deferrals to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Certain staff members of the Company, as designated by the board of directors, are responsible for oversight of the Plan. These staff members determine the appropriateness of the Plan's investment offerings and monitor investment performance.

CONTRIBUTIONS

Each year, participants may contribute from 1 percent up to a maximum of 100 percent of annual compensation, as defined in the Plan document, subject to the annual limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

All employees working more than 20 hours per week are eligible to participate in the Plan. Only employees 18 years of age and older who have successfully completed one year of service and work 24 or more hours per week are eligible to receive employer contributions. Contributions to the Plan are subject to certain limitations in accordance with federal income tax regulations. All participants receive a one-time employer basic contribution of \$100 upon the establishment of the participant's account. Employer matching contributions are made according to the following schedule:

5 years	50%	3%
10 years	50%	4%

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) the Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN, continued:

VESTING

Participants are immediately vested in all contributions plus actual earnings thereon.

PAYMENT OF BENEFITS

Upon termination of employment, death, disability, or retirement, a participant may elect to receive benefits from all sources and earnings in his/her participant account. Forms of benefits available to participants include purchase of annuity contracts and cash withdrawals. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and interest rates are set at the time of the loan. Interest rates are determined by the Plan Administrator based on the Prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. The loan term may not exceed five years unless the loan is used to acquire a principal residence.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are participant loans, measured at the unpaid principal balance plus any accrued but unpaid interest.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

The Plan paid administration fees of \$81,949 during the year ended August 31, 2024. All other administrative expenses, such as consulting and accounting fees, were paid by the Company.

3. FAIR VALUE MEASUREMENTS:

The Plan uses appropriate valuation techniques to determine fair value based on inputs available. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs consist of unadjusted market prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The Plan's only investments are mutual funds, which are valued at their daily closing prices as reported by each fund and are considered Level 1. There were no significant changes to valuation methodologies during the year.

4. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC (Empower), a qualified institution, has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of August 31, 2024 and 2023; the related interest income on notes receivable from participants and investment activity reflected in the statement of changes in net assets available for benefits for the year ended August 31, 2024; and the supplemental schedule of Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of August 31, 2024.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

6. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by Nova 401(k) Associates, Inc. The prototype plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTIES-IN-INTEREST:

Empower Retirement performs recordkeeping services for the Plan and receives compensation for its services; therefore, these transactions qualify as party-in-interest transactions. Total fees paid by the Plan to Empower Retirement totaled \$20,905 for the year ended August 31, 2024. In addition, the Plan paid \$61,044 to other parties-in-interest for investment advisor and contract administrator services.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 24, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
