### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of 401(k) Profit Sharing Plan of the Arc of Anchorage (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended June 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2022 and 2021, and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of Plan

The following description of 401(k) Profit Sharing Plan of the Arc of Anchorage (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective April 1, 2011 by the Arc of Anchorage. The Arc of Anchorage (the Organization or Employer) is the sponsor of the Plan. The Plan was most recently amended January 1, 2022. The Plan is a contributory defined contribution plan covering all eligible employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the applicable requirements of the Internal Revenue Code (IRC).

#### *Custodian and Administration of the Plan*

The custodian and recordkeeper of the Plan is Mutual of America Life Insurance Company (Mutual of America or custodian). The administrator of the Plan is the Organization. The custodian holds all assets of the Plan in accordance with the service provider contract with the Organization. The administrator determines the appropriateness of the Plan's investment offerings and monitor investment performance.

#### *Eligibility*

There is no service requirement for employees to participate in the employee deferral portion of the Plan; however, an employee must be 18 years of age to participate in the Plan. All employees are eligible to participate unless they are leased employees, independent contractors, classified as an on-call employee, or are a nonresident alien. An eligible participant can enter the Plan on the first day of the month coinciding or immediately following the date they were hired for purposes of employee deferrals. Employees are eligible to receive employer matching contributions and profit-sharing contributions upon completion of 12 consecutive months of employment, during which employees are credited with 1,000 hours of service. Participants must be employed on the last day of the Plan year in order to receive an employer contribution.

#### *Contributions*

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. The Plan also allows for Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Employer matching contributions and profit-sharing contributions are discretionary and are determined annually. For the year ended June 30, 2022, the Organization made discretionary matching contributions of 100% of participant contributions up to 3% of participant contributions for a total of \$53,284 in discretionary employer matching contributions.

### ***Participant Accounts***

Each participant account is credited with the participant's contributions, employer contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately 100% vested in their employee contributions plus actual earnings thereon. Discretionary employer matching contributions, profit-sharing contributions, and any earnings thereon vest according to a three-year cliff vesting schedule. In the event of death, permanent disability, or retirement, a participant's employer contribution account becomes fully vested.

### ***Payment of Benefits***

On termination of service for any reason, including due to death, disability, or retirement, a participant will receive a lump-sum payment of their vested balance. Distributions on account of hardship are permitted as defined in the Plan Agreement. In-service distributions are also allowed after attainment of age of 59-½. Participants with vested account balances of \$1,000 or less are automatically distributed in one lump sum. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an individual retirement account unless otherwise elected.

### ***Forfeited Accounts***

Forfeitures occur when participants terminate employment before becoming 100% vested with respect to their employer contributions. Forfeitures are allocated to participants. As of June 30, 2022 and 2021, the total unallocated forfeiture balance was \$10,733 and \$10,665, respectively. No forfeitures were allocated during the year ended June 30, 2022.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions*

Participant contributions and any related employer matching contributions are recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation. Profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

## **3. Information Certified by Mutual of America**

Certain information related to investments disclosed in the accompanying financial statements and Schedule H, Line 4a- Schedule of Assets (Held at End of Year), including investments held at June 30, 2022 and 2021, and net depreciation in fair value of investments and interest and dividends, for the year ended June 30, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America, and, in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2022 and 2021.

*Pooled Separate Accounts (PSAs)* - PSAs are valued at the net asset value (NAV) of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Mutual of America, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are not direct filing entities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- a) *Retirement Funds* - The objective of these portfolios is to provide income and capital appreciation appropriate for the asset allocation associated with its approximate year of retirement.
- b) *Equity Funds* - The objective of these portfolios is to provide investment results that correspond to the investment performance of diversified mix of the S&P Index.
- c) *Asset Allocation Funds* - The objective of these portfolios is to provide capital appreciation and current income.
- d) *Real Estate Funds* - The objective of these portfolios is to provide a high level of income and moderate long-term capital appreciation by tracking the performance of a benchmark index that measures the performance of publicly traded equity real estate investment trusts and other real estate-related investments.
- e) *Balanced Funds* - The objective of these portfolios is to provide capital appreciation and income by investing in a diversified portfolio of common stocks, debt securities and money market instruments.
- f) *Fixed Income Funds* - The objective of these portfolios is to provide a high level of current income.

## 5. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive guaranteed interest account with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investments contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract is a fully benefit-responsive investment and is reported at contract value in the statements of net assets available for benefits. Benefit-responsiveness is defined as the extent to which a contract's terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the contract, plus earning, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at June 30, 2022 and 2021 was \$72,321 and \$82,413,

respectively. The crediting interest rate is based on a formula agreed upon with the issuer but can never be less than 1%. The crediting rate is reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other Organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### 6. Tax Status

The Plan uses a pre-approved plan document sponsored by Mutual of America Financial Group. Mutual of America Financial Group received an opinion letter from the IRS, dated November 3, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are assets managed by Mutual of America Capital Management Corporation, a subsidiary Mutual of America. These transactions qualify as party-in-interest transactions as defined by ERISA. Any transactions involving these investments are on the open market at fair value, as outlined in Note 2. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. See Note 10 for non-exempt transactions with parties-in-interest.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their organization's contributions.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Organization's general assets. During the years ended June 30, 2019, 2020, 2021 and 2022, the Plan had \$85,090, \$59,615, \$25,404, and \$10,238, respectively, of contributions that were not remitted on a timely basis. Lost earnings are paid by the Organization, not from Plan assets. The Plan Sponsor corrected late contributions related to 2019 and 2020 Plan years by remitting lost earnings on these late remittances in 2023. The Plan Sponsor intends to correct the late contributions for 2021 and 2022 Plan years in 2025.

### 12. Subsequent Events

The Plan has evaluated subsequent events through November 7, 2025, the date on which the financial statements were available to be issued.

Effective July 1, 2023, the Plan management changed the Plan's recordkeeper and custodian from Mutual of America to ADP Retirement Services. In conjunction with the change in recordkeepers, the Plan adopted an ADP Plan document, which received a favorable opinion letter from the IRS on October 6, 2020, stating the Plan is designed in accordance with the applicable sections of the IRC. Notes receivable became available to participants as a result of the restatement.
