Opinion

NOTES TO FINANCIAL STATEMENTS
APRIL 30, 2025 AND 2024

NOTE 1 - DESCRIPTION OF THE PLAN

The Warehousemen's Health and Welfare Fund (the "Plan") is a multi-employer welfare benefit plan providing medical, dental, vision and prescription drug benefits to eligible employees and their dependents. Also, a life insurance and accidental death and dismemberment benefit is offered to active employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Active employees are eligible for those benefits specified in their collective bargaining agreement. Dependents of eligible active employees are also eligible to receive benefits. A limited number of retired employees covered under the eligibility rules for retired employees and their dependents are eligible for limited benefits under the Plan.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Monthly employer contribution rates per participant vary by coverage provided. Employer contributions as reported are contributions made by employers on behalf of employees for the hours worked during the month. Employer contributions receivable is based on contributions received subsequent to the end of the year for April and prior hours. No allowance is provided for estimated uncollectible accounts.

D. Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The Plan has instituted examinations of employers' payroll records under a separate payroll compliance program.

E. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

E. Investment Valuation and Income Recognition (Continued)

The Level 2 investments are recorded at cost, which approximates fair value.

F. Benefits

All benefits are funded by the payment of monthly premiums. The benefit obligation shown at year end reflects contributions received during the month prior to year-end, creating eligibility for the following month.

G. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal and state governments.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - MULTIEMPLOYER PENSION PLANS

The Plan contributes to the Employers' - Warehousemen's Pension Trust Fund and the Office and Professional Employees International Union Locals 30 & 537 Retirement Fund. These are multiemployer defined benefit pension plans under the terms of collective bargaining and participation agreements that cover the Plan's represented employees. Contributions to these plans are based on represented employee hours worked and rates from Plan contractual arrangements. The risks of participating in these multiemployer plans are different from single-employer plans in the following respects:

- Assets contributed to the plans by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the plans, the unfunded obligations of the plan may be borne by the remaining participating employers.
- If the Plan chooses to stop participating in the plans, the Plan may be required to pay the plans an amount based on the underfunded status of the plan, referred to as a withdrawal liability.

The Plan's participation in these plans for the years ended April 30, 2025 and 2024 is outlined in the table below. The information included in this table is as follows:

- The "EIN/Pension Plan Number" column provides the employer identification number ("EIN") and the three-digit plan numbers.
- The Pension Protection Act of 2006 ("PPA") zone status is based on information that the Plan received from the plans and is certified by the plans' actuaries. Among other factors, plans in the red zone are generally less than 65% funded, plans in the orange and yellow zones are less than 80% funded or are projected to become insolvent within 7 years, and plans in the green zone are at least 80% funded.
- The "FIP/RP Status" column indicates plans for which a funding improvement plan ("FIP") or a rehabilitation plan ("RP") is either pending or has been implemented.
- The column "Surcharge Imposed" indicates whether the Plan was required to pay a surcharge to the plan.
- The last column lists the expiration dates of the collective bargaining and participation agreements to which the plans are subject.

NOTE 5 - POSTRETIREMENT HEALTH BENEFITS

The Plan participates in a defined benefit multiemployer health plan that provides postretirement benefits to its retired plan employees. The cost of all health benefits provided to plan employees, which includes the cost of postretirement benefits was \$86,118 and \$71,471 in 2025 and 2024, respectively.

NOTE 6 - COMMITMENTS AND CONTINGENCIES

The Plan leases office equipment under two 60-month operating lease agreements through April 30, 2028, totaling \$896 per month. The future annual minimum lease payments are as follows:

NOTE 7 - RELATED PARTY TRANSACTIONS

The Plan rents office space from ILWU Local 26, a related party, for \$600 per month. The lease is month to month. The Plan also reimburses ILWU Local 26 for its portion of utilities and maintenance.

NOTE 8 - CONCENTRATION OF CREDIT RISK

During the year ended April 30, 2025, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 9 - RISKS AND UNCERTAINTIES

Plan investments are subject to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible changes in risk in the near term would materially affect the amounts reported in the financial statements.
