We have performed audits of the financial statements of Perfection Learning Corporation 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of January 31, 2025 and 2024, the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended January 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

---

The following brief description of the Perfection Learning Corporation 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Perfection Learning Corporation (the Company).

Employees are eligible to make salary deferral contributions and are eligible to receive discretionary matching and nonelective/profit-sharing contributions after attaining age 21 and completing 1,000 hours of service in the twelve month period following commencement of employment. Eligible employees may become participants on the first day of the month following the date on which the entry requirements were fulfilled. Employees must be actively employed on the last day of the Plan year and complete 1,000 hours of service to receive a nonelective/profit-sharing contribution.

#### ***Contributions***

Participants may make pre-tax and after-tax Roth voluntary salary deferral contributions up to the maximum dollar limits allowable by law. Participants are automatically enrolled with an initial 6% salary deferral contribution. At any time, a participant can elect not to contribute or may increase or decrease his or her deferral rate to any rate allowed under the Plan provisions. All participant salary deferral percentages will auto-escalate 2% up to a maximum rate of 16% on an annual basis. Employees have the option to choose their own salary deferral percentages and participation in the Plan before their respective automatic enrollment period begins and at any subsequent time during the Plan year. The Plan also provides for discretionary matching and nonelective/profit-sharing contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of a) the Company's discretionary contributions and b) Plan earnings and losses, and charged with an allocation of administrative expenses. The Company's discretionary matching contributions are allocated based upon each participant's elected salary deferral. The Company's discretionary non-elective/profit-sharing contributions are allocated among participants on the basis of the participant's eligible compensation to the aggregate compensation of all participants. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts. Investments are maintained in individual member accounts by Charles Schwab Trust Bank (Charles Schwab).

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's contributions credited to participants' accounts are vested based on years of continuous service. A participant becomes 100% vested in the Company's discretionary matching contributions after two years of continuous service. For the discretionary non-elective/profit-sharing contributions, a participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of service.

### ***Payment of Benefits***

Upon retirement, termination, disability, or death or attainment of age 59.5 (for certain in-service distributions), the participant or beneficiary may receive lump sum payments, partial payments, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan also allows for hardship distributions (as defined by the Plan document). Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses, to reduce the Company's discretionary contributions or be re-allocated to Plan participants. As of January 31, 2025 and 2024, there was \$29,282 and \$31,292 of forfeited, non-vested accounts available, respectively. During 2025 and 2024 the Company's discretionary contributions were reduced by \$31,167 and \$21,195 of forfeitures, respectively.

## **2. Summary of Significant Accounting Policies**

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the modified cash basis of accounting. All transactions other than those involving investments are accounted for on a cash basis. Under the 401(k) election, Company discretionary matching and non-elective/profit-sharing contributions are made in the fiscal year following the employee contribution.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements under the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Expenses***

Certain record-keeping, audit and administrative expenses are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits (modified cash basis) date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 22, 2025, noting no items requiring disclosure.

### 3. Information Certified by Charles Schwab

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Charles Schwab, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of January 31, 2025 and 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. The funds held are open-end funds and are registered with the Securities and Exchange Commission. These funds are required to publish its daily net asset value (NAV) and to transact at that price. These funds are deemed to be actively traded.

*Collective Investment Trust:* Valued at the NAV of units of the collective investment trust. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is in the Plan’s assessment that this fund meets those requirements, since the participants have the ability to redeem the fund at NAV as of the measurement date on a daily basis. There are no unfunded commitments at January 31, 2025 and 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and be distributed as soon as practicable after the termination date.

### 7. Related Party Transactions

---

Certain Plan assets are cash managed by Charles Schwab. Charles Schwab is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.
