NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following brief description of the Q.E.D. Systems, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all eligible employees (“participants”) of Q.E.D. Systems, Inc. (the “Company”). The Plan was established on January 1, 1990, and is administered on the basis of the Plan year, which is the 12-month period commencing each January 1 and ending on December 31. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 1, 2024, the Company changed the Plan’s third party administrator and trustee from State Street Bank and Trust Company (“State Street”) to Fidelity Management Trust Company (“Fidelity”). Effective June 1, 2024, the Plan was restated to exclude residents of Puerto Rico, change the minimum age requirement from 21 years of age to 18 years of age, and allow Roth contributions.

Administration – The Company is the Plan sponsor and Plan administrator. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan. The Company may reimburse the Plan for any administrative expenses incurred.

Eligibility – All employees except for leased employees, residents of Puerto Rico, and employees of any controlled group employer who have attained the age of 18 are eligible for participation in the Plan.

Participant Contributions – The Plan provides for participant contributions of pre-tax and Roth contributions of a specific dollar amount of annual compensation, as defined in the Plan. Participants of qualifying age may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations allowed under Section 402(g) of the Internal Revenue Code (“IRC”).

Employer Contributions – Each year, the Company may contribute to the Plan by making a matching contribution to all eligible participants who have elected to make salary reduction contributions. The amount of the matching contribution, if any, will be determined each Plan year by the Company. For the year ended December 31, 2024, the Company elected to make a matching contribution in an amount equal to 20% of each participant’s deferral election, up to the first 5% of the participant’s basic earnings. The Company may also elect to make an additional qualified, non-elective profit sharing contribution to the participants’ accounts. This contribution is made at the discretion of the Company. There was no additional discretionary profit sharing contribution made during 2024. Participants are subject to certain eligibility requirements to receive the Company’s discretionary-matching contributions and profit sharing contributions. In general, the Company contributions are only provided to eligible participants who have worked at least 1,000 hours during the Plan year and are employed as of the last day of the Plan year.

Vesting – Participants are 100% vested in their account balance and all Company contributions.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and Company contributions. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Each participant’s account is also allocated a portion of the Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participant accounts are segregated for purposes of determining the earnings or losses on each participant’s choice of investments.

Note 1—Description of the Plan (continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator on the date of the loan. Interest rates at December 31, 2024 ranged from 3.25% to 8.50%. Loans must be repaid within five years, except those used to purchase a primary residence which may be repaid within 10 years. Principal and interest are paid ratably through payroll deductions. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Investment Options – Upon enrollment in the Plan, a participant may direct employee and employer contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants as of December 31, 2024. Participants may change their investment options periodically as permitted by the Plan.

Payment of Benefits – Distribution of the vested portion of a participant’s account will occur upon the participant’s termination of service, retirement, death, disability, attainment of age 59½, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment, installment payments in an amount equal to the vested value of his or her account, or ad-hoc distributions. At December 31, 2024 a nominal amount of benefit payments requested had not been paid. At December 31, 2023 there were no benefit payments that had been requested but not yet paid.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally excepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value, except for fully benefit-responsive investment contract, which is reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan sponsor determines the Plan’s valuation policies using information provided by State Street and Fidelity.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. Delinquent notes are treated as distributions based upon the terms of the Plan document.

Note 2—Summary of significant accounting policies (continued)

Payment of Benefits – Benefits are recorded when processed and paid.

Contributions Receivable – The amount of employer contributions due and payable, but not yet deposited with the Plan as of year-end are reflected as employer contributions receivable in the Plan’s financial statements.

Administrative Expenses – The Plan permits payment of Plan expenses to be made from the Plan’s assets. If expenses are paid using the Plan’s assets, then the expenses will generally be allocated amount the accounts of all participants in the Plan.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 3—Information certified by the qualified institutions (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company as of May 31, 2024 and December 31, 2023 (for the period of January 1, 2023 through May 31, 2024) and Fidelity Management Trust Company as of December 31, 2024 (for the period of June 1, 2024 through December 31, 2024), the qualified institutions of the Plan, have certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, investments at contract value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, including unrealized gains and losses, dividends and interest, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i.

Note 4—Fair value measurements

U.S. GAAP defines the three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between levels during the year ended December 31, 2024.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 or 2023:

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Interest Bearing Cash – Valued at historical cost, which approximates fair value.

Pooled Separate Account – This investment is a public investment vehicle valued using the NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The fair value of the pooled separate account is stated at NAV as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Guaranteed investment contract

At December 31, 2023, the Plan held an investment in the New York Life Anchor Account 35 ("NYL 35"), which is a Guaranteed Investment Contract ("GIC"). New York Life maintains the contributions of NYL 35 in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported by New York Life. The issuer of the GIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is reset semi-annually and the minimum interest crediting rate is zero.

The GIC is fully benefit-responsive, and the contract value is the relevant measurement attribute, as described in note 2, for that portion of the net assets available for benefits attributable to the GIC. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the investment contract issuer. Such events include the following: (1) certain distributions resulting from employer-initiated events (including plan termination, bankruptcy and lay-offs); (2) termination by the contract holder if the contract holder fails to provide 12 months advance written notice of termination; or (3) termination by issuer due to loss of the Plan's qualified status. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's contract expired on June 1, 2024, at which time the fund was liquidated and total proceeds of \$4,483,671 were reinvested in New York Life Anchor Account 25 ("NYL 25"), a pooled separate account investment option offered by the Plan.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan would be allocated to participants of the Plan in amounts equal to the individual account balances.

Note 7—Federal income tax status

The Company adopted a prototype non-standardized profit sharing plan with a deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020 which stated the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Party-in-interest transactions

Certain administrative expenses are paid to the qualified institutions for recordkeeper and investment management services to the Plan. The Plan also pays fees to an investment advisor. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL's Rules and Regulations. Fees incurred by the Plan for investment management and advisory services are paid directly by the Plan and, therefore, do qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan to these parties in interest totaled \$92,087.

Notes receivable from participants also qualify as parties-in-interest.

Note 9—Subsequent events

The Plan sponsor has evaluated subsequent events for potential recognition and/or disclosure in the December 31, 2024 financial statements through November 7, 2025, which is the date the financial statements were available to be issued.
