Summary of Principal Plan Provisions

Effective Date:

The plan was established March 1, 1984.

Eligibility:

Participation begins on the March 1 or September 1 coincident with or next following the attainment of age 21 and completion of one year of service. **Eligibility was frozen as of March 1, 1991.**

Retirement Dates:

The Normal Retirement Date is the Participant's 55th birthday.

A Deferred Retirement Date is any date following the Normal Retirement Date.

There is no provision for an Early Retirement Date.

Retirement Benefit:

The annual normal retirement benefit is calculated as:

100% of a Participant's Three-Year Average Compensation.

A Participant who postpones his retirement will continue to accrue benefits according to the plan formula until such time as he retires.

Accrued Benefit:

The Accrued Benefit for a Participant, frozen as of May 1, 1991, is 100% of his highest Three-Year Average Compensation, divided by the number of years of service the Participant would have given from his date of hire to his Normal Retirement Date, multiplied by the number of years of service the Participant has given from his date of hire to May 1, 1991.

For years during which the plan is Top Heavy, the Accrued Benefit is the greater of the Accrued Benefit as described above or 2% of the Participant's final average salary, multiplied by his years of service (up to 10) while the plan was Top Heavy, irrespective of the frozen status of the Plan.

Vesting:

The Participant becomes 100% vested after three years of service. All participants were deemed 100% vested as of May 1, 1991.

Death Benefit:

Post-retirement death benefits are limited to those implicit in the selection of the form of annuity. The basic pre-retirement death benefit is 100% of the Participant's Accrued Benefit.

Form of Annuity Payment:

The normal form of payment is a life annuity.

Optional forms include joint and survivor annuities, certain and life annuities, period certain annuities, contingent annuities, and lump sum payouts. Conversions into these forms are effected by the actuarial equivalence of using the RP-2000 mortality Table for Males, projected to 2020, and a 5% discount rate.
