### Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit

We have performed audits of the accompanying financial statements of the Cobalt Civil, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 ("ERISA")*, as permitted by *ERISA Section 103(a)(3)(C)*. ### Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit

We have performed audits of the accompanying financial statements of the Cobalt Civil, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 ("ERISA")*, as permitted by *ERISA Section 103(a)(3)(C)*. The financial statements comprise the statements of net assets available for benefits as of April 25, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period January 1, 2025 through April 25, 2025, and the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF THE PLAN

The following description of the Cobalt Civil, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan was a defined contribution plan established for the benefit of the employees of Cobalt Civil, LLC (the “Company” or “Plan Sponsor”). Employees were eligible to participate in the Plan after 90 days of eligible service. Leased employees, non-resident aliens, and employees covered by a collective bargaining agreement were not eligible to participate. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974 (“ERISA”)*.

Effective April 25, 2025, all the Plan’s assets were merged into the DynaGrid Construction Group LLC 401(k) Profit Sharing Plan (“DynaGrid Plan”) due to the acquisition of the Company.

*Administration* – The Plan Sponsor designated certain employees, who served without additional compensation, to administer the Plan. The Plan administrator had the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and did designate one or more individuals to perform those responsibilities.

*Contributions* – Each year, participants could elect to defer on a pre-tax or after-tax Roth basis, eligible compensation up to the allowable limits established by the Internal Revenue Code (“IRC”). Participants age 50 and older were eligible to make additional catch-up contributions. The Plan also included an automatic enrollment provision for all eligible employees whereby a pre-tax deferral in the amount of 6% of eligible compensation was contributed to the Plan unless the employee elected a different percentage or elected to not contribute to the Plan. Participants could also contribute amounts from other qualified plans.

The Company could make a discretionary matching contribution to the Plan. For the 2024 Plan year, the Company matched 50% of the employee’s contribution up to 6% of compensation each eligible participant contributed to the Plan. The Company could also make a discretionary profit-sharing contribution to the Plan. Participants were eligible to receive a profit-sharing contribution if they completed at least 1,000 hours of service during the Plan year. In 2024, the Company did not make a profit-sharing contribution.

For the Plan period ended April 25, 2025, all contributions were remitted to the DynaGrid Plan.

*Participant Accounts* – Individual accounts were maintained for each Plan participant. Each participant’s account was credited with the participant’s contributions, the Company’s matching contributions, as well as the Company’s profit-sharing contributions, and Plan earnings, as applicable. Allocations were based on participant earnings, or specific participant transaction costs or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

*Investment Options* – Upon enrollment in the Plan, participants directed the investment of their accounts into various investment options offered by the Plan. They could change their investment options among those investments provided at any time during the Plan year.

## NOTES TO FINANCIAL STATEMENTS

**1. DESCRIPTION OF THE PLAN (continued)**

*Payment of Benefits* – Upon termination of service or attaining normal retirement age, a participant could elect to receive a lump sum amount equal to the value of the participant’s vested interest in their account. In-service and hardship withdrawals were also allowed as defined in the Plan document.

*Vesting* – Participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts was based on years of continuous service. A participant earned 20% vesting in Company contributions after one year of credited service, increasing 20% annually and reached 100% vesting after five years of credited service. Participants also became 100% vested in the event of death or disability.

*Forfeitures* – The non-vested portion of former participants’ accounts could be used to pay administrative expenses of the Plan or reduce the amount of Company contributions. Forfeited accounts totaled \$0 and \$8,864 at April 25, 2025 and December 31, 2024, respectively. During the Plan periods ended April 25, 2025, and December 31, 2024, forfeitures totaling \$0 and \$35,689 were used to reduce the Company’s contributions, respectively.

*Participant Loans* – The Plan did not allow for participant loans.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with GAAP required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan’s investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments included the Plan’s gains and losses on investments bought and sold as well as held during the Plan year.

*Investment Management Fees and Operating Expenses* – Investment management fees and operating expenses charged to the Plan for certain investments were deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses were reflected as a reduction of investment return for such investments.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

*Payment of Benefits* – Benefits were recorded when paid. There were no benefit payments requested and not disbursed at April 25, 2025 and December 31, 2024.

*Administrative Expenses* – Administrative expenses of the Plan were paid by the Company or the Plan participants, as defined in the Plan document.

#### 3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION (UNAUDITED)

The Plan administrator elected the method of annual reporting compliance permitted by *ERISA Section 103(a)(3)(C)* pursuant to *29 CFR 2520.103-8 of Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure* under *ERISA*. Accordingly, American United Life Insurance Company (“AUL”), a OneAmerica Company, a qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments at fair value and investments at contract value as shown in the statements of net assets available for benefits as of April 25, 2025 and December 31, 2024.
- Net appreciation (depreciation) in fair value of investments, and interest income, as shown in the statements of changes in net assets available for benefits for the period ended April 25, 2025 and year ended December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements.

#### 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at during 2024.

*Pooled separate accounts (“PSAs”)* – Valued at the net asset value (“NAV”) of units held by the Plan at year-end provided by the issuer of the account. The NAV was used as a practical expedient to estimate fair value and was based on the value of the underlying investment assets held through subaccounts of a separate account of an insurance company. This practical expedient was not used when it was determined to be probable that the account would sell the investment for an amount different than the reported NAV. PSAs were comprised, primarily, of shares of mutual funds held through sub-accounts of an insurance company at December 31, 2024. The PSAs sought to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA was named. Certain PSAs were target date funds which sought capital appreciation and income consistent with asset allocations that became more conservative over time to the specified retirement date. The investments were redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There were no redemption restrictions or unfunded commitments on these investments.

**COBALT CIVIL, LLC 401(k) PLAN****NOTES TO FINANCIAL STATEMENTS****4. FAIR VALUE MEASUREMENTS (continued)**

The preceding method described could produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

**5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan had a fully benefit-responsive traditional investment contract with AUL. AUL maintained the contributions in a general account. Specific securities within the general account were not attributed to the investment contract with the Plan. The general account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract was included in the financial statements at contract value as reported to the Plan by AUL. Contract value was the relevant measurement attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could direct the withdrawal or transfer of all, or a portion, of their investment at contract value. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

AUL's determination of credited interest rates reflected a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment could apply to amounts withdrawn at the request of the contract holder. The guaranteed investment contract did not permit AUL to terminate the agreement prior to a breach of the contract terms by the investor.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the Plan document (including complete or partial Plan termination or merger with another plan) (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under *ERISA*. The Plan administrator did not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants.

**COBALT CIVIL, LLC 401(k) PLAN****NOTES TO FINANCIAL STATEMENTS****6. INCOME TAX STATUS**

The Internal Revenue Service (“IRS”) ruled on June 30, 2020, that the pre-approved profit-sharing plan of CCH Incorporated, dba ftwilliam.com, upon which the Plan was based, was designed in accordance with the applicable sections of the IRC. The Plan administrator believes the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan was qualified and the related trust was tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 25, 2025, and December 31, 2024, there were no uncertain tax positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative services were provided by the Company at no costs to the Plan and certain administrative costs incurred by the Plan were paid by the Company. The Plan entered into various service agreements with parties-in-interest.

Certain Plan assets were investments managed by AUL. AUL was the custodian of the Plan and, therefore, these transactions qualified as party-in-interest transactions as defined by *ERISA*.

**8. RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities, in general, were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

**9. SUBSEQUENT EVENTS**

The Plan has evaluated all subsequent events through October 10, 2025, which is the date these financial statements were made available to be issued.
