To Whom It May Concern,

I am writing on behalf of Diana Wege LLC regarding Form 5500-SF for the 2023 plan year. I was recently notified that the form was not filed. Although the form was completed, it was not submitted by Paychex during the transition period when I terminated the 401(k) plan with Paychex and moved my nonprofit organization, We Oppose Violence Everywhere Now (WOVEN), to a multiple employer plan.

Unfortunately, I was not informed that I would need to file the form independently after the transition, as Paychex had previously handled all filings on our behalf. I respectfully request that any penalties associated with this late filing be waived as a one-time courtesy. Had I been aware of the requirement, I would have ensured timely submission.
