Opinion

Note 1 - Description of Plan

The following description of Petco Animal Supplies Stores, Inc. (the Sponsor) Group Benefit Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, as amended and restated effective February 1, 2016, provides for paid time off (PTO) benefits, major medical, dental, and vision plans, a life insurance program, accidental death and dismemberment coverage, auto, home and business travel insurance, hospital indemnity, short-term disability, long-term disability, and legal assistance.

Certain Plan assets are held in a voluntary employee's beneficiary association (VEBA) plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers employees of the Sponsor, based on various eligibility requirements, and covered dependents.

Benefits

The Plan offers fully insured medical, dental, vision, and term life plans to all employees in Hawaii, working 20 or more hours per week. Insurance premiums for these plans are funded through insurance contracts paid for by the Sponsor and Participant contributions. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan provides self-insured major medical, dental and pharmacy plans as well as fully insured medical, dental, vision, life, accidental death and dismemberment, auto, home and business travel insurance, hospital indemnity, short-term disability, long-term disability, and legal assistance plans to all full-time employees (those working, on an average, 30 hours per week) and covered dependents, with eligibility commencing on the first day of the month following 60 days of full-time employment. Medical and dental claims are funded by the Plan. Exposure to claims made under these plans is limited by additional insurance coverage above a per occurrence retention limit. These insurance policies have stated maximum coverage limits after which the Plan bears the risk of loss. Insurance premiums for the fully insured benefits are funded through insurance contracts paid for by the Sponsor and Participant contributions.

The Plan also provides PTO to all non-exempt employees and exempt store general managers who are paid 40 hours or more per bi-weekly pay period. The PTO Plan was amended on March 17, 2024, to remove a requirement of 120 days of consecutive employment prior to becoming eligible to participate in the PTO Plan. PTO is calculated from the employees' number of hours paid in each biweekly period multiplied by rates determined by location and years of service.

Experience-Rated Contracts

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Self-Insured Benefits

The Plan is “self-insured” for medical, dental, and vision benefits. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan’s VEBA trust or the general assets of the Sponsor. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Contributions

Sponsor and Participant contributions for medical and dental benefits vary depending upon the coverage selected. Contribution rates are based upon industry trends, historical experience, and other factors. The Sponsor makes contributions to the Plan as needed to fund claims in excess of Participants’ contributions as the claims are reported. Any deficiency of the Plan’s net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis. The Sponsor pays the full cost of basic life, short-term and long-term disability, and accidental death and dismemberment, while related supplemental coverages are paid for by Participants. The Sponsor also pays the full cost for the employee assistance program.

Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in the ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Sponsor or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as due to claims administrators in the accompanying statements of net assets available for benefits and are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Experience-Rated Contracts

For experience-rated contracts, premium surpluses are recorded as receivables from the insurance company. To the extent that premium surpluses are attributable to premiums paid by the Sponsor, a payable to the Sponsor is also recorded for surplus amounts attributable to Sponsor-paid coverage.

If the insurance company requires payment of additional premiums due to a premium deficit, an obligation for the additional premiums is included in benefit obligations. If the deficit relates to Sponsor-paid coverage, a receivable from the Sponsor is also recorded. Periodically, a premium deficit is due related to participant-funded coverage, but the trust is unable to pay the entire amount. In this case, the Sponsor pays the difference to the insurance company and a receivable from the Sponsor is recorded.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies and procedures utilizing information provided by investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statement of changes in the net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include bank charges. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are directly paid by the Sponsor, such as claims administration and professional fees, are excluded from these financial statements.

Benefit Obligations

Plan obligations at January 31, 2025 and 2024, for claims incurred by participants but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan year end. Such estimated amounts are included in the accompanying statements of Plan's benefit obligations in the amounts currently payable.

Plan obligations at January 31, 2025 and 2024, for PTO are calculated based on the total hours accrued and the applicable employee pay rates as of January 31, 2025 and 2024.

Subsequent Events

The Plan has evaluated subsequent events through November 10, 2025, the date on which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2025 and 2024.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Tax Status

The VEBA trust funding certain benefits of the Plan has received an exemption letter from the Internal Revenue Service dated June 14, 1993, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded during the year ended January 31, 2025 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Party In-Interest Transactions

There was no balance due to the Plan Sponsor at January 31, 2025 and \$1,515,881 at January 31, 2024, which consisted of \$1,562,254 in medical and dental benefit payments made directly by the Sponsor on behalf of the Plan, less \$48,675 in reserve balances returned from a carrier to the Plan Sponsor, plus \$2,302 in reserve balances paid for directly by the Plan Sponsor. There was no balance due from the Plan Sponsor at January 31, 2024 and \$157,249 at January 31, 2025, which consisted of reserve balances returned from a carrier to the Plan Sponsor.

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

The Plan has investments in a money market account managed by US Bank. These transactions qualify as exempt party-in-interest transactions under ERISA. Fees paid from the VEBA trust are reflected in administrative expenses.

Note 6 - Risks and Uncertainties

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. The estimated liability for accrued paid time off is a mathematical calculation using current hours and rate data. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 7 - Concentrations of Credit Risk

The Plan holds assets in a money market deposit account, the balance of which is periodically in excess of federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At January 31, 2025 and 2024, the Plan had approximately \$15,359,000 and \$4,160,000, respectively, in excess of FDIC-insured limits.


