Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Consolidated Managers Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from Empower Annuity Insurance Company of America, a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Consolidated Managers Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a multiple-employer defined contribution plan which covers all managers, store managers, senior assistant managers, training managers, assistant managers, and maintenance supervisors who have three months of service and are age 21 or older. The Plan covers active employees of the following companies: Paradise Foods, Inc.; Paradise Byrne, Inc.; River Road Restaurants, LLC; River Road Restaurant 3170, LLC; and Paradise Companies, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may defer a portion of their salaries to their accounts subject to the limitations of the Internal Revenue Code. The Plan is a defined contribution plan. Contributions are made separately by each adopting employer. Each Plan year, Paradise Foods, Inc. (the Company) determines the contribution rate and all adopting employers contribute at that rate. For the years ended December 31, 2024 and 2023, the employers contributed an amount equal to 2% of eligible wages.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the employer's contribution and Plan earnings (losses) and charged with an allocation of participant-related expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - On the participant's normal retirement date, he or she shall be entitled to retire from active service with the Company, and upon attaining age 65, 100% of the value of said participant's account shall vest in him or her. Participants shall become fully vested in their account balances upon disability or death. If a participant terminates his or her employment for any other reason than the ones previously mentioned, he or she shall be entitled to receive the vested percentage of their account balance. Participants are 100% vested after three years of credited service.

Payment of Benefits - A lump-sum distribution of benefits will be made, in accordance with the various forms of payment set forth in the Plan, upon determination of the Plan Administrator that a participant is eligible to receive payment of his or her account.

Forfeited Accounts - Forfeitures shall first be used to restore previously forfeited accounts of former participants. Any remaining forfeitures shall be used to reduce the employer contributions. The balance in forfeitures available to reduce employer contributions was \$16,199 and \$20,873 at December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$17,126 and \$13,867, respectively from the forfeited nonvested accounts.

Investment Options - Each participant shall have the authority to direct the investments of his or her accounts, which can be changed daily. The Plan Administrator shall provide information regarding the investment options available to him or her.

Administration - The Company serves as the Plan Administrator of the Plan. The Company has contracted Empower Retirement, LLC to function as the recordkeeper of the Plan. Empower Retirement, LLC is also the custodian of the assets.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review - Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting - The accompanying financial statements were prepared under the accrual method of accounting.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates - The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payments of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's expenses are paid by the Plan or the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, that are paid by the Plan, are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are reflected in net appreciation of fair value investments presented in the accompanying statements of changes in net assets available for benefits.

Pooled Separate Accounts

The pooled separate accounts are considered open-ended mutual funds and are held in separate investment accounts. These funds are valued using the Net Asset Value (NAV) provided by the Administrator of the fund. The NAV is based on the underlying assets owned by the fund, which include a mix of U.S. and international equities, fixed income investments, and cash. There are no restrictions on redemptions and no unfunded commitments. As the NAV is available to current investors and is the basis for current transactions, the pooled separate accounts have a readily determinable fair value.

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies on assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The three levels of valuation hierarchy are described below:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include—

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical or similar assets or liabilities in inactive markets,
- inputs other than quoted prices that are observable for the asset or liability, or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair values were certified by the Custodian.

NOTE 4 - INVESTMENTS

Unaudited Information Certified by the Plan Custodian

The December 31, 2024 and 2023 Statement of Net Assets Available for Benefits, the investment activities included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. NOTE 5 - INVESTMENTS REPORTED AT CONTRACT VALUE

The Plan has entered into a traditional fully benefit-responsive investment contract with the Administrator. The Administrator maintains the contributions in a general account. The Plan's investment in the contract meets fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfers of all or a portion of their investment at contract value. Under the terms of the Contract, the issuer guarantees the Plan a return of principal and a credited rate. The crediting interest rate as of the end of Plan years December 31, 2024 and 2023, was 2.80% and 1.35%, respectively.

Certain events could limit the ability of the Plan to transact at contract value with the issuers of the contract held by the fund which invests in fully benefit-responsive investment contracts. Such events could include, but are not limited to, the following: premature termination of contracts by this fund, Plan termination, bankruptcy, partial Plan termination or Plan mergers, early retirement incentives that could cause significant withdrawals from the Plan, and a failure of the Plan to qualify under the applicable sections of the Internal Revenue Code. The Plan Administrator does not believe that the occurrences of any of these events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Plan uses a pre-approved Plan document sponsored by Butler Snow, LLP. Butler Snow, LLP received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the pre-approved Plan document satisfies the applicable provisions of the Internal Revenue Code (IRC) of 1986, as amended. The Plan itself has not received a determination letter from the IRS, and the Plan document has been amended since the date of the IRS opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years ended prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has contracted with Empower to serve as insurance contract administrator, recordkeeper, and custodian. Consequently, Empower is a party-in-interest. Administrative fees paid directly to Empower by the Plan for these services amounted to \$0 and \$1,290 in 2024 and 2023, respectively. Certain Plan investments are pooled separate accounts managed by Empower. Purchases and sales of these pooled separate accounts are open market transactions at fair market value. Certain fees and expenses charged to the Plan in relation to these investments are deducted from income earned and are not separately reflected. Consequently, these fees and expenses are reflected as a reduction of the investment return for such investments. All of these party-in-interest transactions are exempt from the prohibited transactions rules under ERISA.

NOTE 10 - DELINQUENT FILER VOLUNTARY COMPLIANCE PROGRAM

Form 5500 For the Plan year ended December 31, 2022, was filed late. The Plan Administrator elected to participate in the Department of Labor's Delinquent Filer Voluntary Compliance Program (DFVCP). In conjunction with meeting the requirements for participation in the DFVCP, the Plan Sponsor remitted a penalty in the amount of \$2,000 to the Department of Labor.

Form 5500 For the Plan year ended December 31, 2023, was filed late. The Plan Administrator elected to participate in the Department of Labor's Delinquent Filer Voluntary Compliance Program (DFVCP). In conjunction with meeting the requirements for participation in the DFVCP, the Plan Sponsor remitted a penalty in the amount of \$2,000 to the Department of Labor.

Participation in the DFVCP does not relieve the Plan from late filing penalties imposed by the Internal Revenue Service under the Internal Revenue Code (IRC). However, the IRS may provide relief from any late-filing penalties for a delinquent Form 5500 if all of the applicable conditions of the DFVCP have been satisfied and all information concerning separated deferred vested participants for the applicable Plan year are reported to the IRS through Form 8955-SSA. The Plan Administrator believes that all requirements for penalty relief under the IRC have been met.

NOTE 11 - PLAN OPERATION FAILURE AND CORRECTION

During the Plan year ended December 31, 2023, Plan management determined that the Plan had failed to permit an eligible participant to make an elective deferral during the Plan year ended December 31, 2021. To correct the failure, the Plan sponsor will make a Qualified Nonelective Contribution (QNEC) in the amount of 50% of the missed deferral, plus earnings. The QNEC of \$11,700 is reflected in Employer's Contributions and Employer's Contributions Receivable for the year ended December 31, 2022, and has been remitted to the Plan during the 2024 Plan year.
