The Plan is a defined benefit multiple employer welfare arrangement (MEWA) sponsored by North Bay Builders Exchanges, Inc. (the Trust). The Plan was established on April 1, 2012 to provide health and other benefits to eligible full-time employees and covered dependents of participating employees that are members of an eligible contractor's exchange. Participation in the Plan by a member employer is voluntary, and each member employer can select the coverage it will provide for its employees. Certain Plan assets are held in a taxable trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In general, all employees scheduled to work at least 20 hours per week on a regular basis are eligible to participate.

**Contributions**

In addition to deductibles and copayments, participating employers and participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Employers are required to contribute a minimum of 50% of the lowest cost medical insurance premiums based on the current group rate premium cost. Participating employers pay the full cost of basic life insurance when selected as a benefit.

**Benefits**

The Plan provides health benefits (medical, vision, and dental), basic group life, long-term disability benefits, optional term life insurance, and accidental death and dismemberment benefits to eligible members and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Insured Benefits**

The Plan offers one health maintenance organization (HMO) through Kaiser Permanente (Kaiser) and a preferred provider organization (PPO) insurance policy through Anthem Blue Cross (Anthem) that participants can choose. The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Plan purchases annual insurance contracts for these insured benefits.

**Self-insured Benefits**

Dental benefits provided by the Plan are self-insured. The claims for dental benefits are processed by Anthem Dental. Anthem Dental pays claims directly to or on behalf of participants and then is reimbursed by the general assets of the Plan. Despite the Plan's utilization of Anthem Dental, ultimate responsibility for payments to providers and participants is retained by the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Cash**

Cash is held in demand accounts at a bank, and cash balances may exceed the federally insured amounts during the year.

**Administrative Expenses**

The Plan pays administrative expenses that consist primarily of professional fees, recordkeeper and custodian fees, and certain transaction fees which are paid by the Plan. These expenses are reported on the statements of changes in net assets available for benefits as Administrative Expenses.

**Payment of Benefits**

Claim payments are recorded when paid by the Plan to Anthem.

Premiums paid by the Plan are recorded as premium payments when paid in the accompanying the statements of changes in net assets available for benefits.

**Contribution Recognition**

Contribution revenue is earned in the month the underlying premiums relate to. Deferred contributions are contributions collected prior to the month for which the underlying premiums relate to. Accounting principles generally accepted in the United States of America require separate disclosure of employer and employee contributions. Each employer determines the cost allocation between employee and employer to provide benefits. Based on how the Plan is administered, it is not feasible to segregate the source of contributions and, consequently, that information is not disclosed in the financial statements.

**Subsequent Events**

The Plan has evaluated subsequent events through October 23, 2025, the date the financial statements were available to be issued.

**NOTE 3 BENEFIT OBLIGATIONS**

The Plan "self-funds" dental benefits provided to participants but insures medical, vision, life, accidental death and dismemberment, and long-term disability benefits. As of each January 31, there are self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable and claims incurred but not reported (IBNR) was estimated by Plan management using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.

**NOTE 4 TAX STATUS**

The Trust is a taxable trust and has never received a tax determination letter. The Trust currently does not generate any taxable income; therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Trustees have the right under the Plan to modify the benefits provided to, and contributions required of participating employers, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Trustees or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

Certain Trustees were also board members or management of the participating contractors' exchanges. Expenses were paid to the exchanges to defray their costs of managing the insurance programs. For the years ended January 31, 2025 and 2024, the Plan paid the exchanges approximately \$95,000 and \$172,000, respectfully.

As described in Note 2, the Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 RISKS AND UNCERTAINTIES**

The liability for claims payable and claims incurred but not reported (IBNR) was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.


