Hello,

My name is Marlene Vangelas, and I was the Managing Director of Jiffy Scripts RX LLC. The pharmacy was closed, and I thought the payroll company filed all the necessary forms that were due. I did not realize that the Final Form 5500-SF needed to be submitted by myself.

During 2022 I had a lot of personal matters to attend to. My daughter was expecting twins and had to be hospitalized. She was diagnosed with a rare condition called TRAP sequence. One of the twins' heart did not develop so my daughter needed to have fetal surgery to cut the blood supply so the other twin had a chance at survival. After the surgery, she was put on full bed rest. There are only two hospitals that handle this type of condition. I had to drive her to the Children's Hospital in Philadelphia (CHOP) which is a 2hr drive from her house, three times a week for scans. She was hospitalized again at 30 weeks and delivered her son at 32 weeks gestation. My grandson spent two months in the NICU. When he was finally released to go home to New Jersey, I continued to stay at my daughter's home to assist her.

Due to my personal circumstances with my family and the fact that I thought all the necessary Forms were being filed by my hired payroll company, the Final Form 5500-SF was not filed.
