Opinion

We have audited the accompanying financial statements of U.A. Plumbers and Steamfitters Local No. 22 Annuity Fund (the "Plan"), which comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of April 30, 2025 and 2024, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. Description of the Plan

The following description of the U.A. Plumbers and Steamfitters Local No. 22 Annuity Fund (the “Plan”) provides only general information. Participants should refer to the Plan agreement and subsequent amendments for a more complete description of the Plan’s provisions.

General– The Plan is a defined contribution multiemployer profit-sharing plan, administered by a Joint Board of Trustees (the “Trustees”), whose participating employers contribute to the Plan under terms of a collective bargaining agreement with the U.A. Plumbers and Steamfitters Local No. 22 (the “Union”). The Plan was established effective May 1, 2003, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Contributions to the Plan are provided primarily by employers in the construction industry in the Western New York area and are based on an hourly rate for hours paid in covered employment under the collective bargaining agreement.

The Plan accepts direct rollover distributions from qualified retirement plans, subject to the Trustees’ review.

Participant Accounts – Contributions received from employers are credited to individual participant accounts. Such accounts are also credited or charged with the participant’s share of earnings or losses on his or her self-directed investments and an equal portion of administrative expenses. Expenses incurred for or on behalf of a specific participant are charged directly to such participant’s account. Benefits to which participants or their beneficiaries are entitled are those benefits that can be provided from the participant’s vested account. Participants become 100% vested in their account balance immediately upon qualifying as a participant. Qualification as a participant occurs on the first day of the month after 12 consecutive months have passed since a participant became employed by a participating employer and he or she has accumulated at least \$100 in his or her Plan account.

Benefits – The Plan provides for a distribution of benefits to eligible participants. Eligibility is determined upon the occurrence of any of the following events: (1) retirement on or after age 55; (2) death; (3) hardship; (4) termination of employment, or (5) termination of the Plan.

Retirement Benefits – The Plan provides for retirement benefits upon attainment of age 55. Participants will receive the distribution of their vested benefit in a lump sum or in partial payments.

1. Description of the Plan (continued)

Death Benefits – If a participant dies prior to his or her retirement date, and is married at the time of death, the surviving spouse will receive a single lump sum payment equal to the entire account balance.

If a participant is not married at the time of his or her death or is married and has designated a beneficiary other than his or her spouse, the entire account balance shall be distributed to the surviving beneficiary designated by the deceased participant as a single lump sum payment.

Hardship Withdrawals – The only time an advance withdrawal of an account balance is permitted is due to hardship. Hardship includes medical care expenses, costs directly related to the purchase of a participant's primary residence, funeral expenses for a family member, payment of tuition, related educational fees, and room and board expenses for the next 12 months of post-secondary education of the participant or dependent, payments necessary to prevent eviction from or foreclosure on the mortgage of the participant's principal residence, and expenses for the repair of damage to the participant's principal residence that would qualify as a casualty.

A hardship distribution is limited to 100% of the account balance, or the total amount necessary to relieve the financial hardship, whichever is less, with a minimum distribution of \$500. The distribution will be made in a single lump sum payment and the participant may be charged a reasonable administrative fee.

Termination Benefits – If a participant has not completed an hour of service for a consecutive 12-month period, he or she is eligible for a termination benefit. The distribution will be made in a single lump sum and is limited to the participant's vested account balance.

All benefits are paid directly from the net assets of the Plan.

Plan Termination – Although they have not expressed any intent to do so, the Trustees have the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, after payment of all obligations and administrative expenses, the Trustees shall pay to each participant the total value of his or her account in accordance with the provisions of the Plan and of ERISA.

Tax Status – The Plan received its latest determination letter from the Internal Revenue Service ("IRS"), dated July 17, 2015, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"), and the trust established under the Plan is qualified pursuant to Section 501(a) of the Code and is tax exempt.

Accordingly, no provision for income taxes has been included in the accompanying financial statements. The Plan has been amended since the effective date of the IRS determination letter. However, the Plan Administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition – Plan investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Units held in the guaranteed interest account consist of holdings in a fully benefit-responsive investment contract and are reported at contract value in the accompanying statements of net assets available for benefits. Contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on an ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on disposition of investments are based upon actual costs and selling prices.

Employer Contributions Receivable – Contributions receivable from participating employers are recorded at net realizable value. Management closely monitors outstanding balances and estimates uncollectibility based on specific existing economic conditions.

Upon management's determination of uncollectibility, the specific outstanding balance or the portion of outstanding balance of such account is written off through the allowance for expected credit losses for potentially uncollectible employer contributions. At April 30, 2025 and 2024, there were no amounts determined to be uncollectible by Plan management.

2. Summary of Significant Accounting Policies (continued)

Office Equipment, net – Office equipment is stated at cost, net of accumulated depreciation. Depreciation is computed using the straight-line method over the approximate economic useful lives of the assets, which are five years. The Plan’s capitalization policy requires purchased property with a useful life of three or more years and a cost exceeding \$5,000 to be capitalized.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Expenses necessary to administer the Plan are paid for by the Plan and are charged equally to each participant’s account. Fees paid were based on customary and reasonable rates for such services.

Party-in-Interest Transactions – Empower Retirement (“Empower”) provided administrative and investment management services to the Plan during the years ended April 30, 2025 and 2024. The Plan currently offers the Empower Guaranteed Income Fund as an investment option. At April 30, 2025 and 2024, the value of such investment held by the plan totaled \$2,326,855 and \$1,575,059, respectively. There were no direct fees paid to Empower during years ended April 30, 2025 and 2024, as fees are paid directly by the investment fund.

Risks and Uncertainties – Investments are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Subsequent Events – Plan management has evaluated subsequent events, for recognition or disclosure, through August 15, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was necessary.

3. Fair Value Measurements

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date. All assets held by the Plan, measured at fair value, utilize Level 1 inputs as their primary measure of fair value at April 30, 2025 and 2024.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets of the Plan that were valued using Level 2 inputs at April 30, 2025 and 2024.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that were valued using Level 3 inputs at April 30, 2025 and 2024.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Mutual Funds: The Plan invests in both open-end mutual funds and closed-end mutual funds. Open-end mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. Closed-end mutual funds are valued at the closing price reported on the active market on which the individual securities are traded. The mutual funds held by the Plan are deemed to be actively traded.

4. Guaranteed Investment Contract with Insurance Company

The Plan has entered into a traditional fully benefit-responsive investment contract (the “Contract”) with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented in the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at April 30, 2025 and 2024 was \$2,326,855 and \$1,575,059, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis.

Certain events limit the Plan’s ability to transact at contract value with Empower. Such events include (1) amendments to the Plan documents (including complete and partial Plan termination or merger with another plan); (2) changes to the Plan’s prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption under ERISA. The Plan administrator believes that any events that limit the Plan’s ability to transact at contract value with participants are not probable of occurring.

7. Related Party Transactions

The Plan has an agreement with U.A. Plumbers and Steamfitters Local No. 22 Health Fund (the "Health Fund"), an affiliated benefit fund, whereby the Plan reimburses the Health Fund for shared office and administrative expenses incurred on its behalf. Reimbursements to the Health Fund for its share of expenses, which are based on management estimates, amounted to \$98,256 and \$80,320 for the years ended April 30, 2025 and 2024, respectively. The unpaid balance of allocated costs amounted to \$22,766 and \$22,532 at April 30, 2025 and 2024, respectively.

8. Reconciliation with Form 5500

The accompanying financial statements, which are prepared in accordance with U.S. GAAP, calculate realized gains and losses on sales of securities and unrealized gains and losses (change in market value on securities held at year end) using historical cost. However, Form 5500, Annual Return/Report of Employee Benefit Plan, requires the calculation of such gains and losses to be measured on the basis of revalued cost on Schedule H. Revalued cost is calculated based on the market value of a security on the first day of the fiscal year plus the cost of any current year purchases, less the beginning market value of any current year sales. In total, however, the financial statement calculation of gains and losses and the calculation for Form 5500 are the same.

In the statements of changes in net assets available for benefits, investment fees are offset against investment income. On Form 5500 Schedule H, such fees are included as administrative expenses.
