We have performed audits of the financial statements of the Pepsi-Cola Bottling Co. Corbin, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). ("ERISA Section 103(a)(3)(C) audit") The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements

### Pepsi-Cola Bottling Co. of Corbin, Inc. 401(k) Plan

#### (1) Description of Plan

The following description of the Pepsi-Cola Bottling Co. of Corbin, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

##### (a) General

The Plan is a defined contribution retirement plan covering all employees of Pepsi-Cola Bottling Co. of Corbin, Inc. and its wholly owned subsidiaries, Breaktime Vending, Southeast, LLC, and Breaktime Distributing, LLC (the "Companies"). Participants become eligible for participation coinciding with or immediately following attainment of age eighteen and the completion of ninety days of service. The participant will be enrolled the first day of the following month after eligibility is obtained. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### (b) Contributions

Each year, participants may contribute up to 100% of their annual compensation subject to certain statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Catch-up contributions will be taken into account in determining any employer matching contributions. Participants hired after July 1, 2007 were not eligible to participate in the companies' defined benefit plan. However, these participants are eligible to receive a discretionary matching contribution equal to a uniform percentage or dollar amount of the participant's elective deferrals determined on an annual basis. Employees are eligible for the matching contribution after one year of service. For 2024 and 2023, the match was as follows: (a) 100% match on the first 2% contributed and (b) 50% match for contributions in excess of the first 2% contribution up to 6%. The Companies may make discretionary matching contributions which are determined annually by management. Company contributions may not exceed the maximum amount allowable for federal income tax purposes.

(c) Investment Options

Upon enrollment in the Plan, a participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds and a money market fund, as investment options for participants.

(d) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contributions, and (b) Plan earnings (losses), and is charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participant contributions from previous plans are fully vested. For termination of service for other reasons, the Companies' matching portion of their accounts and the related earnings vest 20% each year, beginning after two years and are fully vested after six years of credited service.

(f) Payment of Benefits

On termination of service due to death, disability or retirement, a participant receives a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

(g) Forfeited Accounts

Forfeited non-vested accounts may be used by the Plan to pay Plan expenses or to reduce the amount of matching contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,035 and \$891, respectively. During the years ended December 31, 2024 and 2023, \$958 and \$1,597 of forfeitures, was used to pay administrative fees, respectively.

(h) Hardship Withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½ unless certain exceptions apply. Hardship withdrawals are limited to the participant's vested account balance.

(i) Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan and discontinue its contributions at any time subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balances. Participants are entitled to a distribution of their entire vested benefit, and such distribution shall be made directly to the participant or, at their direction, may be transferred directly to another qualified retirement plan or IRA.

(j) Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America ("GAAP").

(b) Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### (e) Events Occurring After Reporting Date

The Plan's management has evaluated events and transactions that occurred between December 31, 2024, and Report Date, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

#### (3) Certified Information

Certain information related to investments presented and disclosed in the accompanying financial statements and supplemental schedule, including cash and the fair value of investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, income from stable value fund, dividends and interest, and other income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A. ("Alerus")

#### (4) Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- ***Money Market and Mutual funds:*** Valued based on the funds' reported closing net asset values of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.
- ***Stable Value Fund:*** The fair value of the stable value collective trust fund is based on the underlying investments' net asset value at the close of the day multiplied by the number of units in the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(6) Income Tax Status**

The Companies have adopted a pre-approved profit-sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020 which stated that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) Party-in-Interest Transactions**
