

## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tri-Area Community Health 401(k) Safe Harbor Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 21, 2025 and May 31, 2024, and the related statement of changes in net assets available for benefits for the period ended January 21, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tri-Area Community Health 401(k) Safe Harbor Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 21, 2025 and May 31, 2024 and for the period ended January 21, 2025, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tri-Area Community Health 401(k) Safe Harbor Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**


Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tri-Area Community Health 401(k) Safe Harbor Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### Note 1 – Plan Description

---

The following description of Tri-Area Community Health 401(k) Safe Harbor Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Tri-Area Community Health (the “Organization”), who are at least 21 years of age and who have completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Plan Merger*

In November 2024, the Plan Sponsor signed an agreement to participate in the RMS EasyPlan (“PEP”), a pooled employer plan sponsored by Alerus Financial, N.A. and Access Plans, LLC. Beginning January 1, 2025, contributions were remitted to the PEP. Effective January 21, 2025, the Plan’s assets merged into the PEP.

#### *Contributions*

Prior to January 1, 2025, participants contributed up to the maximum allowable under the *Internal Revenue Code (IRC)* as pretax or ROTH deferrals, as defined in the Plan. Participants also contributed amounts representing distributions from other qualified plans. The Organization made a matching contribution of 100% of the first 1% of compensation that a participant contributed. The Organization also made a safe harbor non-elective contribution of 3% of eligible compensation. Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain limitations.

#### *Participant Accounts*

Prior to January 1, 2025, each participant’s account was credited with the participant’s contribution and allocations of the Organization’s matching and safe harbor non-elective contributions, plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled was the benefit that could be provided from the participant’s vested account.

#### *Vesting*

Prior to January 1, 2025, participants were immediately vested in their contributions and the Organization’s matching and safe harbor non-elective contributions, plus earnings thereon.

#### *Notes from Participants*

Prior to January 1, 2025, participants could borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance from rollover, elective deferral, and safe harbor non-elective sources. Note terms ranged from one to five years unless the note was for purchase of a primary residence, in which case the term could exceed five years. Notes were secured by the balance in the participant’s account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates ranged from 4.25% to 9.50% for loans transferred to the PEP on January 21, 2025. Principal and interest were paid ratably through payroll deductions.

*Payment of Benefits*

Prior to January 1, 2025, on termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. In-service and hardship withdrawals were allowed, as defined by the Plan document.

*Administrative Costs*

Prior to January 1, 2025, Plan administrative expenses were paid by the Organization or the Plan on a discretionary basis.

**Note 2 – Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Valuation of Investments and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Payment of Benefits*

Benefit payments are recorded when paid.

### Note 3 – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of May 31, 2024. As a result of the merger, there were no assets held at the end of the period January 21, 2025. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### *Level 1 Fair Value Measurements*

The fair values of mutual funds and pooled separate accounts are based on quoted net asset values of the shares held by the Plan at May 31, 2024.

### Note 4 – Investment Contracts

The Plan had investments in the Principal Global Investors Trust Company Principal Stable Value Fund through March 2024. Included in this fund were certain guaranteed investment contracts and synthetic investment contracts. These contracts were considered to be benefit-responsive and were presented at fair value. The average yield for this fund was 2.26% for the year ended May 31, 2024.

The objective of the Principal Stable Value Fund was to provide diversification of investments consistent with a stable fixed-income methodology and the careful and prudent assumption of investment risk providing for preservation of capital, stability and predictability of returns, liquidity to pay plan benefits, and high credit quality. The percentage of contributions allocated to the stable value fund was determined by the participants.

---

### Note 5 – Related Party Transactions

---

Officers or employees of the Organization perform certain administrative functions. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Prior to the plan merger, Plan participants could direct their investments in funds issued and managed by the Plan Custodian. Investments in funds issued by the Custodian were considered related party transactions. Fees paid by the Plan for investment management and administrative services amounted to \$9,123 for the period ended January 21, 2025.

---

### Note 6 – Plan Termination

---

Although it has not expressed any intent to do so, the Organization had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. A plan termination did not occur prior to the Plan merger in 2025.

---

### Note 7 – Tax Status

---

The Plan is an adoption of a pre-approved plan sponsored by Cherry Bekaert LLP. The Plan is designed in accordance with applicable sections of the *IRC*. The Organization has obtained the most recent favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Organization believes that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as the period ended January 21, 2025 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
