We have performed audits of the financial statements of Eversheds Sutherland (US) LLP Retirement Plan A (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Eversheds Sutherland (US) LLP Retirement Plan A (the “Plan” or “Plan A”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan qualified under Section 401(a) of the Internal Revenue Code (IRC). Partners and eligible employees of the firm of Eversheds Sutherland (US) LLP (the “Partnership”) are eligible to participate in the 401(k) feature of the Plan on the first day of the month on or after the date they are employed. Partners and eligible employees, excluding associates, are eligible to participate in the profit-sharing feature of the Plan on the January 1 on or next following completion of one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants were able to make salary deferral contributions up to \$23,000 in 2024. Unless elected otherwise, newly eligible employees are automatically enrolled in the Plan at a 3% deferral rate. After 12 months of participation, upon the first day of each Plan year following the participant’s automatic enrollment in the Plan, the initial automatic enrollment rate will automatically increase by 1% not to exceed 6%. Plan participants age 50 and above were able to make catch-up contributions up to a maximum of \$7,500 in 2024. Automatic enrollment and automatic increase of contributions are not applicable to Partners.

In accordance with the allocation formula set forth in the plan document, the Partnership contributes a discretionary percentage of participants’ compensation for the portion of the year for which he or she is eligible, plus an additional percentage of eligible compensation that exceeds the participant’s integration compensation, as defined in the Plan. Participants must be employed as of December 31 to receive a contribution. The Partnership also contributes a match, equal to 50% of the first 5% of contributions made to the Plan for eligible staff and paralegals. The Partnership’s contributions for the year ended December 31, 2024 were \$5,038,375, net of forfeitures and the pre-funded balances as discussed below.

Effective December 31, 2021, the Eversheds Sutherland (US) LLP’s Defined Benefit Plan for Partners and Non-Legal Personnel (“Defined Benefit Plan”) was terminated. The Plan was amended effective January 1, 2023, to allow the excess assets remaining in the Defined Benefit Plan following its final liquidation to be transferred to the Plan. The excess assets were to be allocated to participant accounts in the following manner: 50% of the assets, plus earnings thereon, to be used to satisfy the Partnership discretionary contribution as of December 31, 2023; the remaining assets, plus earnings thereon, were to be used to satisfy the Partnership discretionary contribution as of December 31, 2024. As a result, a total of \$1,251,938 and \$1,130,229 from the transferred assets, net of earnings, was used to satisfy the Partnership discretionary contribution as of December 31, 2024 and 2023, respectively. As of December 31, 2024, all of the excess assets, plus earnings thereon, transferred into the Plan from the Defined Benefit Plan have been exhausted.

Master Trust: The Plan participates in the Eversheds Sutherland (US) LLP Master Retirement Trust (the “Master Trust”) with the Eversheds Sutherland (US) LLP Retirement Plan B (“Plan B”). Each participating retirement plan holds units of participation in the Master Trust. The assets of the Master Trust were held by Matrix Trust Company (the “Trustee” through June 30, 2024) and were transferred to Charles Schwab Trust Bank effective July 1, 2024, which now serves as the Trustee. Investment income or loss is based on each Plan’s investments at the beginning of the year, net of each Plan’s actual contributions, benefit payments, and administrative expenses. Common administrative expenses are allocated based on each Plan’s allocated share of investments at the end of the year.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of the Partnership's contributions and investment earnings and is charged with his or her withdrawals and an allocation of investment income, administrative expenses paid by the Plan, and expenses related to participant directed activities such as participant loans and individually directed accounts (IDAs). Each participant directs the investment of his or her account to any combination of investment funds offered by the Plan and IDAs.

Vesting: Participants are immediately vested in all contributions to their account, plus actual earnings (losses) thereon.

Payment of Benefits: On termination of service due to death, disability, or other termination, a participant may elect to receive either a lump-sum amount equal to the value of the participant's balance in his or her account or installment payments over a selected period, not to exceed the life expectancy of the participant or beneficiary, if applicable. The Plan also permits in-service lump-sum or periodic distributions for participants who have reached age 59 1/2 and in other specified circumstances as defined by the Plan.

Notes Receivable from Participants: Active participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's aggregate vested account balance, whichever is less. Loan terms range up to 5 years or up to 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 2%. Principal and interest are paid through payroll deductions.

Administrative and Investment Management Expenses: Fees for notes receivables and IDAs are generally charged against participant accounts and are reflected in the financial statements as administrative expenses of the Plan. Trustee fees and other administrative fees are paid by the Plan, to the extent not offset by revenue sharing from 12b-1 fees and shareholder servicing fees.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: Master Trust investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held by the Master Trust during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Master Trust holds various investment securities. Investments are exposed to various risks such as interest rate, market, liquidity, credit risks, and the risks associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Participant and Partnership Contributions Receivable: The fair value of participant and Partnership contributions receivable approximates carrying value due to the short-term duration of the receivable.

NOTE 3 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 4 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including the Plan's interest in Master Trust investments and notes receivable from participants held at December 31, 2024 and 2023, and participation in net income of the Master Trust and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank as of December 31, 2024 and for the period from July 1, 2024 through December 31, 2024 and by Matrix Trust Company as of December 31, 2023 and for the period January 1, 2024 through June 30, 2024.

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan and those held as underlying investments of the Master Trust. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Plan interest in Master Trust: The fair value of the Plan's interest in the Master Trust reflects the Plan's interest in the fair value of the underlying net assets of the Master Trust.

Money market funds and mutual funds: The fair values of money market fund and mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Individually directed accounts: Accounts primarily consist of mutual funds, common stocks, and exchange traded funds for which fair values are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1). Additional investments include preferred stocks valued at the quoted market price of the issuer's unrestricted preferred stock less an appropriate discount, U.S. government securities and agencies based upon recent bid prices or the average of recent bid and asked prices when available (Level 2 inputs), and life insurance policies that are valued based on the cash surrender value of the policies. The policies are not readily marketable (Level 3 input).

Collective trust funds: The fair values of participation units in the collective trust funds are based upon the NAV, which is a practical expedient for fair value, of such fund, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the funds. The funds provide for daily redemptions by the Plan at reported NAV per share.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Administrative expenses paid to the Trustee qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Partnership. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Partnership. Fees paid by the Plan during the plan year to Schwab Retirement Plan Services, Inc., and affiliate Charles Schwab Trust Bank, the Plan trustee, and OneAmerica Retirement Services LLC for recordkeeping services also qualify as party-in-interest transactions. The Master Trust also holds investment funds issued by certain investment managers which also qualify as exempt party-in-interest investments. Certain investments held by the Plan include revenue sharing arrangements. Any revenue received from such investments is allocated directly to participants' accounts based on their proportional share of the respective investment. These transactions qualify as exempt party-in-interest transactions. Fees paid to other service providers also qualify as exempt party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 8 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Partnership by a letter dated April 23, 2014 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or assets) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

NOTE 9 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.
