## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
Laborers' Union Local 1174 Health and Welfare Fund

### *Opinion*

We have audited the accompanying financial statements of Laborers' Union Local 1174 Health and Welfare Fund, an employee benefit plan subject to Employee Retirement Income Security Act of 1974 (ERISA), which comprise the Statements of Net Assets Available for Benefits and of Benefit Obligations as of January 31, 2025 and 2024 and the related Statement of Changes in Net Assets Available for Benefits and Changes in Benefit Obligations for the year ended January 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the Net Assets Available for Benefits and Benefit Obligations of Laborers' Union Local 1174 Health and Welfare Fund as of January 31, 2025 and 2024, and the Changes in its Net Assets Available for Benefits and Changes in Benefit Obligations for the year ended January 31, 2025, in accordance with accounting principles generally accepted in the United States of America.

### *Basis for Opinion*

We conducted our audits in accordance with the auditing standards generally accepted in the United States of American (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Laborers' Union Local 1174 Health and Welfare Fund and meet our other ethical responsibilities, in accordance with the relevant requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Laborers' Union Local 1174 Health and Welfare Fund's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of Laborers Local Union 1174 Health and Welfare Fund (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a multiemployer collectively bargained welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established February 1, 1960, pursuant to a collective bargaining agreement between the Construction and General Laborers' Local Union 1174 and the General Contractors Association of Lehigh Valley, Inc. The Plan provides health and welfare benefits to those employed by an employer under the terms of the collective bargaining agreements and full time participants of the union and the plan. Members of Laborers Local Union 130 and Laborers Local Union 1180 entered the Plan on January 1, 2024. The Plan is governed by a Board of Trustees comprised of an equal number of employer and union representatives.

Merger:

On April 1, 2004, the assets of Laborers Local Union 471 Health and Welfare Fund were merged with the assets of Laborers' Union Local 1174 Health and Welfare Fund. As a result, all investments in stocks and bonds were transferred from Laborers Local Union 471 Health and Welfare Fund into Laborers' Union Local 1174 Health and Welfare Fund on that date.

Benefits:

The Plan provides health benefits (medical, surgical, major medical and prescription drug benefits) dental, vision, disability, death, accidental death, dismemberment and loss of sight benefits under self-insured programs. Prescription, dental and vision claims are processed by contracted third party claim processors. All other benefit claims are processed by the Plan's contract administrator. Despite the use of third party processors, the ultimate responsibility for payments is retained by the Plan.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan (Continued)

Postretirement Benefits:

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the plan to employees' service rendered to date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the plan's participating employers and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

Per capita costs for healthcare benefits were actuarially determined using the Getzen Model of long-run medical cost trends. Under this model, healthcare cost trends vary over a long period. The initial rate of 7.50% in 2024 decreases to an ultimate rate of 4.036% in 2075 and later. These costs reflect comprehensive medical, prescription drug, dental and vision benefits and include administrative fees.

If the healthcare cost-trend rate assumption is increased by 1%, the benefit obligation would increase by \$870,711 as of January 31, 2025.

The foregoing assumptions are based on the presumption that the plan will continue. Were the plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Other Plan Benefits:

Plan obligations at January 31 for health claims incurred by active and retired participants but not reported at that date are stated at actual value based on subsequent payments.

Plan obligations at January 31 for accumulated eligibility credits for active participants are estimated by the plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported at present value, based on a 5.35% and 4.80% discount rate at January 31, 2025 and 2024, respectively.

Contributions:

The Plan is being funded by contributions from employers who have signed the collective bargaining agreement, and in some cases, by covered employees. Employers contribute monthly based on a fixed hourly contribution rate. Self-contributions by covered employees may be made for every dollar short of the required eligibility contribution. The collective bargaining agreement requires a contribution for each hour worked by a member as follows:

Plan Termination:

The Plan's Board of Administration has the right under the Plan to modify the benefits provided to employees. The Plan may be terminated only by joint agreement between the employer and the union, subject to the provisions set forth in ERISA. Upon dissolution or termination of the Plan, the administrator shall continue to pay the expenses and provide the benefits in effect to all eligible employees, beneficiaries, and dependents until the Plan's assets are exhausted.

Note 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Employer Contributions and Contributions Receivable:

Revenue from employer contributions is determined by hours of work reported by participating employers and the contractual employer contribution rates in effect. Employer contributions are included in revenue during the period in which the work is performed. The accounts receivable represents uncollected contributions for hours worked through January 31.

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. The custodian and investment advisor are "fiduciaries" as well as "parties of interest" as defined by the Employee Retirement Income Security Act - Section 3 (14) P.L. 93-406.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are classified as dividends.

Benefit Payments:

Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Reciprocal Contributions, Payments and Agreements:

Reciprocal Plan contributions represent payments received from other local health and welfare plans for work performed by participants out of the local union's area of operation. Reciprocal payments represent contributions received by participating employers for members of other local unions that are paid to other local benefit plans.

The benefit fund of each local enters into a cooperative contractual arrangement to allow the contributions to be transferred to the employee's home benefit fund. The agreement determines the amount of contributions that will be transferred to or from the benefit fund. The participant must sign an authorization to transfer the contributions to the participant's home benefit fund.

Administrative Expenses:

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. See the Supplementary Schedule of Administrative Expenses for detail on the types and amounts of expenses incurred. Certain investment-related expenses are included in the net appreciation in fair value of investments and as a reduction to investment income on the statement of net assets available for benefits.

Note 3. Stop-Loss Insurance

The Plan has entered into an insurance contractual arrangement to limit expenses related to the self-insured medical and prescription benefits. The Plan is contracted with United States Fire Insurance Company. This contract reimburses for expenses in excess of \$125,000. During the year ended January 31, 2025, the Plan paid premiums for the stop loss coverage of \$871,776 and reduced the medical claim expenses amount by \$451,620 from reimbursements for claims in excess of the deductible amount.

Note 4. Claims Incurred but not Reported

Plan obligations at January 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC (820) are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at January 31, 2025 and 2024.

Money Market: Valued at the net asset value of the underlying shares.

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual Funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are deemed to be actively traded.

Note 6. Federal Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated March 1962 stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2025 fiscal year for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the Internal Revenue Code to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the related trust is tax-exempt.

Note 6. Federal Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan Administrator believes it is no longer subject to income tax examination for years prior to 2023.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8. Concentration of Credit Risk

The Plan maintains bank accounts with First National Bank. Accounts at the institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Cash at January 31, 2025 exceeded the federally insured limits by \$250,000. Cash at January 31, 2024 did not exceed the federally insured limits. Management is utilizing a sweep account to transfer cash in excess of \$500,000 to other banks to increase the FDIC insurance coverage without opening additional bank accounts.

The Plan receives most of the employer contributions from companies located in Pennsylvania. Three of the employers contribute approximately 42% of the total contributions for the Plan.
