Notes to Financial Statements

Year Ended December 31, 2024

NOTE A--DESCRIPTION OF PLAN

The following brief description of the Harbin Clinic Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and subsequent amendments for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Harbin Clinic, LLC (Harbin Clinic) who have completed at least one year of service and at least 1,000 hours of service in a Plan year. The Plan is subject to the provisions of the Employee Income Security Act of 1974 (ERISA), as amended.

In April 2024, the plan sponsor, Harbin Clinic, LLC, merged with Atrium Health Floyd Medical Center, part of the North Carolina-based Atrium Health System.

Contributions: Participants may elect to contribute to the Plan up to 50% of their eligible compensation on a tax-deferred basis, subject to certain limitations as determined annually by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Harbin Clinic matches participant elective contributions to the Plan up to 2% of a participant's eligible compensation. Harbin Clinic contributes an annual safe harbor contribution to the Plan, which was 4.17% of eligible income for the year ended December 31, 2024. Harbin Clinic also makes discretionary profit-sharing contributions to the Plan on behalf of eligible participants in an amount determined annually by the Harbin Clinic Board of Managers. The discretionary contribution for the year ended December 31, 2024, was between 11.18% and 14.01% of eligible income, based on the age of each eligible participant. Participants may direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, Harbin Clinic's matching, safe harbor, and discretionary contributions, and Plan earnings, and each participant's account is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their elective contributions and safe harbor contributions, plus actual earnings thereon. Participants are fully vested in Harbin Clinic's matching and discretionary contributions upon attaining normal retirement age or due to disability or death. Otherwise, matching and discretionary contributions made to the Plan are vested based on years of service as follows:

Year Ended December 31, 2024

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may generally receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or an annuity. For termination of service due to other reasons, a participant may generally receive the value of the vested interest in his account as a lump-sum distribution.

Forfeitures: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,616 and \$19,051, respectively. Forfeitures of terminated participants' non-vested accounts are used to reduce Harbin Clinic's future matching contributions. During 2024, \$38,439 of forfeitures were used to reduce employer contributions.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates between 3.25% and 8.50% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Plan Termination: Although it has not expressed any intent to do so, Harbin Clinic has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balance.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition: Investments in registered investment companies are stated at fair value based on the quoted market values of the shares held by the Plan as determined by the trustee.

Units of interest in a retirement savings trust are reported at the net asset value of the underlying assets in the trust. The net asset value is used as the practical expedient to estimate fair value as participant transactions occur daily at this value. This practical expedient would not be used if it was determined to be probable that the redemption of units would be at a different value.

Life insurance contracts are valued at contract value as reported by Northwestern Mutual Life Insurance Company, the counterparty to the contracts. The contract value is defined as the cash surrender value which includes the value of any dividend additions or accumulations and is net of any outstanding policy indebtedness.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are stated at their unpaid principal balance plus accrued interest. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Certain other significant administrative expenses are paid by Harbin Clinic.

NOTE C--INFORMATION CERTIFIED BY TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Vanguard Fiduciary Trust Company (Vanguard), the trustee of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments and notes receivable from participants as shown in the accompanying Statements of Net Assets Available for Benefits of \$309,769,205 and \$1,611,736, respectively as of December 31, 2024, and \$274,069,057 and \$1,912,746, respectively, as of December 31, 2023.
- Net appreciation in fair value of investments of \$19,794,960 as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and interest, dividend, and other income of \$16,386,302 included in interest, dividend, and other income in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- All investment-related information held by Vanguard in the accompanying supplemental Schedule H, Line 4i – Schedule of Assets Held at Year End as of December 31, 2024.

Life insurance contracts as shown on the accompanying Statements of Net Assets Available for Benefits of \$351,435 as of December 31, 2024 and 2023, have not been certified as complete and accurate by the trustee. There was no change in value of these life insurance contracts and therefore no amount was included in interest, dividends, and other income on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets and liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the valuation hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The investment valuation methods described in Note B may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

Investments Measured Using the Net Asset Value as a Practical Expedient: The Plan offers a collective investment trust option to participants through the Vanguard Retirement Savings Trust Fund, which invests solely in the Vanguard Retirement Savings Master Trust (Master Trust). The underlying investments of the Master Trust are primarily pools of investment contracts that are issued by insurance companies and commercial banks. At December 31, 2024 and 2023, the Plan's interest in the total net assets of the Master Trust was approximately 0.025% and 0.033%, respectively. Investment income is allocated based upon the amount of time the Plan's assets were invested in the Master Trust; \$165,191 was allocated to the Plan for the year ended December 31, 2024. Participants may initiate contributions to or withdrawals from the Vanguard Retirement Savings Trust Fund daily at the net asset value. Certain Plan directed withdrawals may be subject to market value adjustments calculated in accordance with the provisions of the investment contracts.

NOTE E--RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies or units of interest in a retirement savings trust fund managed by the trustee, and these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Vanguard totaled \$56,720 for the year ended December 31, 2024.

NOTE F--INCOME TAX STATUS

The Internal Revenue Service has determined and informed Harbin Clinic by a letter dated April 23, 2013, that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The

Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and could materially affect the participants' account balances and the amount reported in the Statements of Net Assets Available for Benefits.

NOTE H--SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.
