Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Fresh Air Fund Pension Plan, (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended January 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

1. Description of the Plan

The following summary description of the Fresh Air Fund Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete description of the plan's provisions.

General

The Plan is intended to qualify under Code Section 401(a) a money purchase pension plan for the eligible employees of Fresh Air Fund (the "Organization" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees of the Organization other than residents of Puerto Rico and individuals classified by the Organization as independent contractors or otherwise not classified as common-law employees (even if subsequently reclassified) become eligible to participate on the first day of the month following completion of one year of service (1,000 hours).

Contributions

The Plan provides only an employer nonelective contribution. Eligible employees receive an Employer contribution equal to 4% of eligible compensation for the Plan Year after satisfying the Plan's eligibility requirements. The Plan does not permit employee contributions or rollovers.

Participant Accounts

Each participant's account is credited with the Organization's contributions and the related net earnings and losses thereon and are charged for withdrawals and certain administrative expenses.

Vesting

A participant is 100% vested in all accounts at all times.

Payment of Benefits

Benefits are payable upon termination of employment including retirement, disability, or upon death. In addition, participants are subject to required minimum distribution rules once they reach the required beginning date. The normal form of payment is a qualified joint and survivor annuity or a single-life annuity if unmarried; with the required waiver and spousal consent if married, benefits may instead be paid as a lump sum, in installments, or as another annuity form allowed by the Plan.

1. Description of the Plan (*Continued*)

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their vested account balance, up to the lesser of 50 percent of such balance or \$50,000 (reduced by recent outstanding loan balances). Only one loan may be outstanding at a time. Loans bear a fixed, reasonable interest rate determined by the Plan Administrator and are repayable in level installments over a period not exceeding five years, except for primary residence loans which may extend up to fifteen years. Loans are secured by the participant's vested account balance, and defaults are treated as taxable distributions.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At January 31, 2025 and 2024, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds and money market FUND are valued at the daily closing price on an active market.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan has a self-directed brokerage account which allows participants to invest in various investments that are not part of the Plan's investment platform. As of January 31, 2025 and 2024, the Plan's self-directed brokerage accounts consisted of mutual funds and non-interest bearing cash.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at January 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended January 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Party-in-Interest Transactions

Certain investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Fidelity Workplace Services LLC is the record-keeper for the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer, FMR LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the

IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
