Independent Auditors' Report

To the Board of Directors and Participants
Ingenovis Health 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Ingenovis Health 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ingenovis Health 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Ingenovis Health 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution plan, under which participants may direct their contributions into various investment options offered by the Plan. The Plan covers employees of U.S. Nursing Corporation (the “Plan Sponsor” or “The Company”). On January 1, 2023, employees from Vista Staffing Solutions, Inc. were added to the Plan and on January 1, 2024, employees from Springboard, Inc. were added to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”). BOK Financial (“BOKF”) serves as the Plan recordkeeper and trustee. The Employee Benefits Committee (composed of Plan Sponsor management) is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Eligibility

Employees who have reached 21 years of age and are not union, leased, or non-resident alien employees are eligible for participation in the Plan. Employees may enter the Plan on the first day of the next calendar month following the fulfillment of eligibility requirements. There is no service requirement for employees to make elective deferrals, but employees must complete 12 months of service to be eligible for employer matching contributions.

Contributions

Participants may make elective deferrals of up to 86 percent of their annual eligible compensation. This maximum percentage may be reduced by the plan administrator in certain circumstances. The Plan permits employees to make pre-tax and Roth elective deferrals. Provided requirements are met, withdrawals of Roth 401(k) contributions and any earnings are tax free to the participant. A participant's combined pre-tax and after-tax contributions cannot exceed the maximum annual amount allowed by law. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Employee contributions to the Plan are made through regular payroll deductions. Participants may change their elective deferral contributions at any time during the year.

The Company makes a safe harbor matching employer contribution equal to 100 percent of the first 3 percent of employee deferral contributions and an additional 50 percent up to 5 percent (for a maximum match of 4 percent) of eligible compensation to the Plan on a per pay period basis. Participants are eligible to receive safe harbor matching employer contributions on the first day of the month coincident with or following the date one year after their date of hire.

Rollovers from other qualified plans are permitted.

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions, safe harbor employer matching contributions, and earnings thereon. Any discretionary non-safe harbor matching employer contributions made on or after January 1, 2010 (including forfeitures) and the earnings or losses thereon vest as follows:

Less than 3	0%
3 or more	100%

A participant's account becomes 100 percent vested upon death, attaining the normal retirement age of 65 while an employee (except for Vista Staffing Solutions, Inc. employees hired prior to January 1, 2023 which age is 63), retirement due to disability, or termination of the Plan.

Payment of Benefits

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Benefits are recorded when paid.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the Company. Hardship withdrawals are permitted (except from safe harbor matching contributions and qualified non-elective contributions). The Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan. The IRS has required minimum distributions once a participant reaches age 73.

Forfeited Accounts

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. Forfeitures in the amount of \$113,591 was applied to pay administrative fees during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited account balances totaled \$184,544 and \$21,786, respectively.

Party-in-Interest Transactions

Certain plan assets are in investment funds managed by BOKF, N.A. or its affiliates. BOKF, N.A. is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Notes Receivable from Participants

Loans are not permitted under the Plan. Due to Vista Staffing Solutions, Inc. and Springboard, Inc. employees being added to the Plan January 1, 2023 and 2024, respectively, all existing loans were grandfathered in. No new loans will be permitted going forward.

2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for further discussion of fair value measurements. Investments in mutual funds are reported at the last reported sale price at the end of the respective periods using quoted market values.

Net appreciation or depreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the Plan's gains or losses for instruments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles. The financial statements present the net assets available for benefits and changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

The Company paid for certain direct Plan administrative and other expenses, which are excluded from these financial statements. Additionally, Company employees provide certain administrative duties at no charge to the Plan. Certain fees are paid through the Plan for recordkeeping and trustee services provided by BOKF.

Notes Receivable from Participants

In accordance with FASB ASU 2010-25, Reporting Loans to Participants by Defined Contribution Pension Plans, the Plan has classified loans to participants as notes receivable. The loans are recorded at principal plus any accrued and unpaid interest. Interest income is recorded when earned. Management of the Plan estimates that these notes receivable from participants are fully collectible and therefore has no reserve for bad debt against them.

3. Tax Status

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The Plan has not individually sought its own determination letter.

4. Information Prepared and Certified by Trustee

Plan management has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by the Trustee and was not subjected to any auditing procedures performed by the independent public accountants:

- Investments, notes receivable from participants, cash and cash equivalents
 - Net appreciation in investments, and other investment income
 - Information presented in the accompanying supplemental schedule

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions (i.e. any non-Safe Harbor contributions).

6. Partial Plan Termination

As a result of a reduction in the workforce in 2024, the Plan sponsor has determined that a partial termination of the Plan occurred in 2024. The Plan sponsor performed a review and determined that there were no affected participants that were not already 100% vested and no action was required.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 from those used in the prior year.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

8. Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Delinquent Participant Contributions

As reported on Schedule H, line 4a, Schedule of Delinquent Participant Contributions for the year ended December 31, 2023, certain participant contributions were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.53-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. Delinquent participant contributions in the amount of \$268,892 was made to the Plan outside of the time frame specified by the DOL. The Company is working to calculate the lost earnings amount on the delinquent participant contributions remitted.

The Company is in the process of filing IRS form 5330 to report and pay an excise tax with respect to the 2024 late remittances as required pursuant to Section 4975 of the Code.

10. Subsequent Events

Management has conducted a review of subsequent events for possible disclosure in or correction of these financial statements through November 6, 2025, the date the financial statements were available to be issued.
