Opinion

We have audited the accompanying financial statements of Moody Dunbar, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of January 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1

Description of Plan

The following description of the Moody Dunbar, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the employees of Moody Dunbar, Inc. and its subsidiaries (Dunbar Foods Corporation and Saticoy Foods Corporation) who are at least twenty-one years old or older with 1,000 hours of service during a consecutive twelve-month period and are employed on the Plan entry date of February 1st. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year the company’s board of directors approves a contribution in the amount they deem advisable. This amount is subject to certain limitations.

Participant Accounts

Each participant’s account is credited with an allocation of (a) the company’s contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as defined by the Plan, according to the following schedule:

Administration

Empower Trust Company, LLC is the trustee of the Plan. Empower Retirement, LLC performs participant record keeping and other administrative duties for the Plan. The Board of Directors of Moody Dunbar, Inc. oversees the Plan’s operations.

Payment of Benefits

Upon termination of service, a participant with a vested account balance of \$1,000 or less will receive a lump sum payment equal to the vested value of his or her account. If the terminated participant’s vested account balance is greater than \$1,000, he or she may elect to receive a lump sum payment equal to the vested value of his or her account. Effective September 1, 2015, the Plan permits in-service distributions if deemed a severance distribution in accordance to the terms of the Plan.

Forfeited Accounts

At January 31, 2025 and 2024, forfeited nonvested accounts totaled \$14,152 and \$18,710, respectively. The Plan Administrator may allocate participant forfeitures to reduce nonelective contributions and/or to pay reasonable plan expenses.

Note 2

Summary of Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments of the Plan, except for EI Fixed Account – Series Class II, are stated at fair value as determined by quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan.

Subsequent Events

Management has evaluated events and transactions occurring subsequent to the date of the statement of net assets available for benefits for any items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through November 11, 2025, which is the date these financial statements were available to be issued.

Note 3 Investments

The Plan's investments are held by a bank-administered trust fund.

The following table presents the general type of investments held by the Plan:

The mutual funds appreciated (depreciated) in value by \$1,745,033 and \$1,235,962 during the years ended January 31, 2025 and 2024, respectively. Stable value funds approximate \$1 per share and held no change in net appreciation/depreciation for either year.

Note 4 Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4

Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for instruments measured at fair value. There have been no changes in the methodologies used at January 31, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Funds: Measured according to net asset value per share as a practical expedient and is not considered within the fair value hierarchy. The net asset value is generally obtained directly from the fund house or other investment provider.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's assets consisted of mutual funds, considered Level 1 within the fair value hierarchy, at \$12,284,557 and \$10,531,572 and stable value funds, considered Level 2 within the fair value hierarchy, measured at net asset value per share as a practical expedient at \$1,296,734 and \$1,183,385 at January 31, 2025 and 2024, respectively.

Note 5

Related-Party Transactions

It is noted that certain Plan investments are shares of funds managed by Empower Trust Company, LLC, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$54,039 and \$49,970 for the years ended January 31, 2025 and 2024, respectively. Additionally, \$14,152 and \$18,710 as of January 31, 2025 and 2024, respectively, reflects forfeited assets.

Note 6

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7

Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

Note 7

Tax Status (continued)

The Plan follows the accounting guidance for uncertainty in income taxes using the provision of FASB ASC Topic 740, *Income Taxes*.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ending January 31, 2023 through January 31, 2025, the years that remain subject to examination by major tax jurisdictions as of January 31, 2025.

Note 8

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
