Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Financial Condition of Plan Sponsor

As discussed in Note 10 of the financial statements, the Plan Sponsor has experienced recurring operating losses and has a working capital deficiency and a net asset deficiency. The Plan Sponsor also continues to experience operational profitability challenges and the auditors' report on its December 31, 2024 financial statements contained an emphasis of matter paragraph regarding substantial doubt about its ability to continue as a going concern. Our opinion is not modified with respect to the aforementioned matter.

1. Description of Plan

The following description of the CenterLight Healthcare, Inc. 403(b) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of CenterLight Healthcare, Inc. (the "Plan Sponsor" or "Employer"). An employee is eligible for participation in the Plan upon their date of hire. Employees who work more than seventeen and one-half (17 ½) hours per week and who have completed a year of service are eligible to receive employer matching contributions. Employees are not eligible for employer matching contributions if they are: union employees, leased employees, or per diem workers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan provides retirement benefits to all eligible employees for the following controlled group of employers:

CenterLight Healthcare, Inc.
Best Choice Home Health Care, Inc.
CenterLight Health System, Inc.
CL Healthcare, Inc.
CenterLight Certified Home Health Agency

On January 1, 2024, Plan assets and recordkeeping, held and performed by Transamerica Financial Life Insurance Company ("TFLIC") and Transamerica Retirement Solutions Corporation ("TRSC") were transferred to Ascensus Trust Company ("Ascensus").

Effective January 1, 2024 the Plan name was changed from the CenterLight Health System 403(b) Retirement Plan to the CenterLight Healthcare, Inc. 403(b) Retirement Plan and the Plan Sponsor was changed from CenterLight Health System to CenterLight Healthcare, Inc. due to restructuring.

Contributions

Employees may defer a percentage or fixed amount of their compensation as 403(b) elective deferral contributions subject to Internal Revenue Service ("IRS") limitations on a pre-tax basis or on an after-tax (Roth) basis, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Prior to April 1, 2020, for most employees, the Employer contributed seven percent of an employee's compensation (as defined by the Plan document), provided that he or she worked more than seventeen and one half hours per week, was not represented by a bargaining unit which had bargained with the Employers in good faith on the subject of retirement benefits and had completed one year of service. For certain employees, depending on their title or the company for which they worked, contributions ranged from seven percent to eleven percent of their eligible compensation. Effective April 1, 2020, for employees who have a year of service, the Employer matched 50% of each eligible participant's contributions (excluding catch up contributions) up to 3% of eligible compensation.

1. Description of Plan *(continued)*

Contributions (continued)

Upon completing a year of service the employees are eligible for the match on the first day of the month on or after the requirements are met. Effective January 1, 2024, for employees who have a year of service, the Employer contributes a Safe Harbor Nonelective contribution of 3% of each eligible participant's eligible compensation. Upon completing a year of service the employees are eligible for Safe Harbor Nonelective contribution on the first day of the month on or after the requirements are met.

Compensation consists of taxable wages as reported on Form W-2, paid to an employee with certain exclusions.

Vesting

Participants are 100% vested immediately in their contributions plus actual earnings thereon. All participants are fully vested in the Employer contribution and matching portion of their accounts after they have completed three years of service (cliff vesting). During 2016, 2017, 2018 and 2019, the Plan incurred a partial termination due to staff reductions, thus any participant that was terminated during 2016, 2017, 2018 and 2019 became 100% vested in Employer contributions. Participants that were actively employed by CenterLight Certified Home Health Agency as of the date of its sale to Cassena Care, LLC on January 1, 2021 also became 100% vested in Employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to disability or retirement, a participant (or a designated beneficiary) may elect to receive the vested interest in his or her account as a partial; or full lump-sum amount. For termination of service resulting from other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or maintain his or her vested interest within the Plan. Upon heavy and immediate financial need, a participant is also eligible to take a hardship distribution.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$195,481 and \$352,926. Forfeited accounts resulting from termination of employment are applied to administrative expenses and future Employer contributions. In 2024, forfeitures of \$285,898 were used to reduce Employer contributions and \$99,331 were used to reduce administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets, and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the guaranteed investment contracts, which are reported at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. Investments in pooled separate accounts are valued at NAV, as provided by the trustees of the funds, which are used as a practical expedient. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Guaranteed Interest Account, Guaranteed Income Account and the Insurance Company/General Account are guaranteed investments contracts and are valued at contract value, which represents deposits made to the contracts, plus earnings at guaranteed crediting rates, less withdrawals and fees. Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts.

Investment Valuation and Income Recognition (continued)

Variable annuity funds are valued at a daily calculated unit value. Personal choice retirement accounts are considered to be self-directed accounts and are valued based on the account's underlying investments held as of the end of the plan year. The personal choice retirement accounts consist of: mutual funds, and money funds.

Purchases and sales of investments are recorded on a trade- date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan expenses consist primarily of distribution fees, loan fees and Plan service charges. Investment related expenses are included in the NAV of the respective investment vehicles and, consequently, those expenses are not separately reflected but are a component of net appreciation in value of investments.

Expense Budget Account

The Plan and Transamerica Retirement Solutions, LLC ("TRS") entered into an arrangement whereby a portion of the revenue earned by TRS from certain funds is passed through to the Plan for payment of permitted plan expenses or allocation to participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay plan expenses, the Employer created the Expense Budget Account. The Expense Budget Account is an account within the Plan, similar in design to forfeiture accounts, and is used to record keep the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The Expense Budget Account balance was \$0 and \$12,417 at December 31, 2024 and 2023. During 2024, \$12,617 were used to pay plan expenses.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date November 12, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TFLIC, Ascensus LLC, as agent for Ascensus Trust Company, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America (“Empower”), qualified institutions.

TFLIC held a portion of the Plan’s investment assets and notes receivable from participants and executed investment transactions as of December 31, 2023 and for the period from January 1, 2024 to January 19, 2024 and Ascensus Trust Company, LLC held the Plan’s investment assets and notes receivable from participants and executed investment transactions for the period January 20, 2024 to December 31, 2024.

5. Benefit-Responsive Contracts

Guaranteed Income Fund

The Empower Guaranteed Income Fund is a group annuity product issued by Empower. Empower maintains the contributions in a general account, which is credited with earnings and charged with participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Benefit-Responsive Contracts (*continued*)

Guaranteed Income Fund (continued)

Plan management believes that events that could limit the ability of the Plan to transact at contract value are not probable of occurring. Empower is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Empower. Such interest rates are announced in advance and guaranteed for a six month period. Given these provisions, the Account is fully benefit-responsive.

The Empower Guaranteed Income Fund represents approximately 18% and 22% of the Plan's net assets available for benefits at December 31, 2024 and 2023.

Guaranteed Interest Account

The Plan has a Guaranteed Interest Account (the "Account") with Prudential. Under the group annuity account that supports this Account, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. The Account is effected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, the Account is fully benefit-responsive.

When establishing crediting interest rates, Prudential considers current economic and market conditions, the general interest rate environment and the experience within the Prudential general account. The crediting interest rates are announced in advance and are guaranteed for at least one year and cannot be less than the minimum rate.

A plan sponsor initiated termination of the Account is an event that could limit the ability of the Plan to transact at contract value paid within 90 days. In this instance, contract value could be paid over time, or at the plan sponsor's discretion, paid over a period not to exceed one year from the date of application of market value adjustments. Plan management believes that events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time are not probable of occurring.

TFLIC Insurance Company/General Account

As of December 31, 2023, the Plan had investments in the TFLIC Insurance Company/General Account, which is a fully benefit-responsive guaranteed investment contract ("GIC"). TFLIC maintained the contributions in a general account, which was credited with earnings and charged for participant withdrawals and administrative expenses. TFLIC was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Plan management believes that events that could limit the ability of the Plan to transact at contract value were not probable of occurring. The investment was fully liquidated prior to December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. During 2016, 2017, 2018 and 2019, there was a partial Plan termination whereby any participant that terminated during 2016, 2017, 2018, or 2019 became 100% vested.

7. Tax Status

Effective January 1, 2024, the Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated January, 1, 2018, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Employer believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is subject to examinations by the applicable taxing jurisdictions, however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the Insurance Company as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Certain plan investments are held in trust by Ascensus Trust Company, which serves as the plan's recordkeeper and directed trustee. These transactions are treated as exempt party-in-interest transactions under ERISA.

In April of 2022, Empower completed its acquisition of the Prudential Financial, Inc.'s retirement business.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

10. Financial Condition of Plan Sponsor

The Plan Sponsor has experienced recurring operating losses and has a working capital deficiency and a net asset deficiency at December 31, 2024 (the most recent audited financial statements available). The Plan Sponsor also continues to experience operational profitability challenges. As such, these factors raise doubt about the Plan Sponsor's ability to continue as a going concern.

In the event of the Plan Sponsor's bankruptcy, participant's accounts are protected from the Plan Sponsor's creditors under ERISA.
