## **INDEPENDENT AUDITOR’S REPORT**

To the Trustees,

### **Opinion**

We have audited the accompanying financial statements of Domino Sugar Corporation and Local 1101 United Food and Commercial Workers Union Health and Welfare Trust Employee Benefits Plan (the “Plan”) subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of January 31, 2025 and 2024, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the statements of benefit obligations and net assets available for benefits of the Plan as of January 31, 2025 and 2024, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

**Note 1 - DESCRIPTION OF PLAN**

The following description of the Domino Sugar Corporation and Local 1101 United Food and Commercial Workers Union Health and Welfare Trust Employee Benefits Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**a. General**

The Plan provides certain health, disability, and death benefits covering active employees of The American Sugar Refining Company (formerly Domino Sugar Corporation) (the “Employer”), their spouses, and their dependents and retirees and their spouses. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**b. Benefits**

The Plan provides life insurance, medical, dental, vision, prescription drug (until age 65), and hospitalization benefits on a fully insured basis to employees and retirees of the Employer who are in the bargaining unit represented by Local 1101. Disability and death benefits are self-funded by the Plan. Employees are eligible for the Plan after 90 days of employment.

**c. Contributions**

Under a collective bargaining agreement, which was extended on February 12, 2024 through February 10, 2027, the Employer contributes to the Plan a fixed monthly amount for each regular full-time employee on the active payroll to provide benefits to covered participants. For the years ended January 31, 2025 and 2024, the fixed monthly contribution was \$1,191. The fixed monthly contributions for subsequent years are as follows:

The Plan receives employee and retiree contributions to offset the increase in healthcare costs. Employee contributions by participants vary based on elected coverage. Retirees are responsible for funding 100% of their post-retirement benefits. Terminated employees are eligible to continue their insurance coverage through contributions under COBRA.

**d. Other**

The Plan's Board of Trustees has the right under the Plan to modify the benefits provided to active employees. The Plan may be terminated only by joint agreement between the Employer and the union, subject to the provisions set forth in ERISA.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**a. Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual method of accounting.

**b. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**c. Post-retirement Benefits**

The post-retirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to January 31, 2025 and 2024. Post-retirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their spouses and (2) active employees and their spouses after retirement from service from the Employer. Prior to an active employee's full eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 8.0% annual rate of increase in the per capita cost of covered health care benefits was assumed for the year ended January 31, 2025. The rate is assumed to decrease gradually to 4.50% through the year ending January 31, 2040. The administrative expenses are assumed to increase 3.0% each year. A 6.75% annual rate of increase in the per capita cost of covered health care benefits was assumed for the year ended January 31, 2024; then the rate was assumed to gradually decrease to 4.50% through the year ended January 31, 2034 was assumed.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-retirement benefit obligation.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**d. Tax Status**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and, accordingly, the Plan's net investment income is exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service and the plan sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that it is no longer subject to examinations for years prior to January 31, 2022.

**e. Reclassifications**

Certain amounts in the 2024 financial statements have been reclassified to conform with the 2025 financial statement presentation.

**f. Subsequent Events**

Management evaluates events subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**Note 3 - CONCENTRATION OF CREDIT RISKS**

The Plan maintains cash balances at a local financial institution where they are insured by the Federal Deposit Insurance Corporation up to \$250,000 per institution. As of January 31, 2025, there were no cash deposits in excess of the insured limits.

**Note 4 - BENEFIT OBLIGATIONS**

The Plan's excess of benefit obligations over net assets as of January 31, 2025 and 2024 is primarily attributable to the post-retirement benefit obligations, the funding of which is not covered by the contribution rate provided by the current bargaining agreement.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligations as of January 31, 2025 and 2024 by approximately \$923,000 and \$933,000, respectively.

**Note 5 - RISKS AND UNCERTAINTIES**

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
