Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hopkins & Carley 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 20, 2025, December 31, 2024, and December 31, 2023, and the related statements of changes in net assets available for benefits for the period ended February 20, 2025 and the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hopkins & Carley 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the period ended February 20, 2025, and the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hopkins & Carley 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 of the financial statements, Hopkins & Carley 401(k) Plan merged with the Lathrop GPM LLP 401(k) Plan and Lathrop GPM Retirement Plan effective January 1, 2025. On February 20, 2025, all assets of the Hopkins & Carley 401(k) Plan were merged into the Lathrop Plans. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Hopkins & Carley 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

NOTE 1 – THE PLAN AND ITS SIGNIFICANT ACCOUNTING POLICIES

General – The following description of Hopkins & Carley 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established in 1985 by Hopkins & Carley, a Law Corporation (the Company), to provide benefits to eligible employees, as defined in the Plan document. The Plan was designed to be qualified under the applicable requirements of the Internal Revenue Code (the IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective October 1, 2024, Lathrop GPM LLP combined with the Company. Hopkins & Carley's 401(k) Plan remained active through December 31, 2024. Effective January 1, 2025, certain former employees of the Company become participants in the Lathrop GPM LLP 401(k) Plan or the Lathrop GPM Retirement Plan and Trust (the Lathrop Plans) based on their eligibility to participate in the respective Plan. On February 20, 2025, plan assets of approximately \$78,833,000 were transferred into the Lathrop Plans.

Administration – The Company had appointed its Executive Committee (the Committee) to manage the operation and administration of the Plan. The Company had contracted with Charles Schwab Trust Bank (Schwab) to act as the trustee and a related entity to be the third-party administrator to process and maintain records of participant data. Plan administrative expenses were paid by the Plan and the Company.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Forfeited accounts – Forfeited nonvested accounts at December 31, 2024 and 2023 totaled approximately \$116,000 and \$48,000, respectively. These amounts could be used to pay Plan administrative expenses or reduce future employer contributions. Forfeitures of approximately \$140,000 were used to partly fund the Company's contributions for the year ended December 31, 2024. Any remaining forfeitures were transferred to the Lathrop Plan in February 2025.

Investment valuation and income recognition – The Plan's investments are stated at fair value. The Plan's trustee, Schwab, certified the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Contributions – Contributions from participants and corresponding employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the Plan document. No allowance for credit losses had been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Income taxes – The Plan has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service dated September 21, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Management has evaluated the Plan's tax positions and does not believe the Plan had any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events – The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Hopkins & Carley 401(k) Plan Notes to Financial Statements

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds (valued as noted above) and common stocks that are valued on the basis of readily determinable market prices.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – RELATED PARTY TRANSACTIONS

Schwab served as the Plan’s trustee investment custodian. An affiliate of Schwab was the Plan’s third-party administrator. Such transactions, while considered party-in interest transactions under ERISA regulations, were permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 – PARTICIPATION AND BENEFITS

Participant contributions – Participants could have elected to have the Company contribute their eligible pre-tax or Roth after-tax compensation to the Plan up to the amounts allowable under the Plan document and current income tax regulations. Participants who had the Company contribute a portion of their compensation to the Plan agreed to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld were invested in accordance with the participant’s direction.

Participants were also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions were deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

Employer contributions – The Company was allowed to make contributions to the Plan in the form of matching contributions, as defined in the Plan, and as approved by the Committee. In 2024, the Company matched 50% of each eligible participant’s contribution up to a maximum of \$3,000 for non-shareholders. The shareholders did not receive employer matching contributions for the year ended December 31, 2024.

The Company was also allowed to make contributions to the Plan in the form of discretionary profit sharing contributions, as defined in the Plan and as approved by the Board of Directors. For the year ended December 31, 2024, the Company contributed the following:

The profit-sharing contribution receivable for the 2024 Plan year was deposited in the participants accounts in the Lathrop Plan in June 2025.

Vesting – Participants were immediately vested in their contributions and employer matching contributions. Discretionary profit sharing contributions were fully vested after six years of credited service.

Participant accounts – Each participant’s account was credited with the participant’s contribution, Plan earnings or losses, and an allocation of the Company’s contributions, if any. Allocation of the Company’s matching contributions were based on participant contributions, as defined in the Plan. Allocation of discretionary profit sharing contributions were based on eligible employee compensation, except for shareholders and the executive director, who received a flat amount, as defined in the Plan.

Payment of benefits – Upon termination, the participants or beneficiaries could have elected to leave their account balance in the Plan or receive their total benefits in a lump-sum amount or annual, semiannual, quarterly, or monthly installments over a period of years equal to the value of the participant’s vested interest in their account. The Plan allowed for the automatic lump-sum distribution of participant vested account balances that do not exceed \$5,000.

Notes receivable from participants – The Plan allowed participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable were secured by the participant’s vested balance. Such notes receivable bore interest at the available market financing rates and were required be repaid to the Plan within a five-year period, unless the proceeds were used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The specific terms and conditions of such notes receivable were established by the Committee. Outstanding notes receivable at December 31, 2024, carried interest rates ranging from 4.25% to 10.00% with various maturities through November 2034. Effective February 20, 2025, participants either paid off outstanding loans or transferred the outstanding balances into the Lathrop Plans.

NOTE 5 – CERTIFIED INVESTMENT INFORMATION

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Schwab, a qualified institution:

- Investments and notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable reflected on the accompanying statements of changes in net assets available for benefits for the period ended February 20, 2025 and the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.
