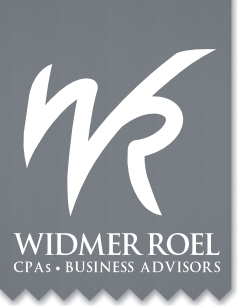

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Wheeler Manufacturing Co. Inc. Profit Sharing/401(k) Trust**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended January 31, 2025, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

JANUARY 31, 2025 AND 2024

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Wheeler Manufacturing Co. Inc. Profit Sharing/401(k) Trust (the “Plan”) provides only general information. Participants should refer to the defined contribution volume submitter plan document and related adoption agreement for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Wheeler Manufacturing Co. (the Company) who have six months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan, limited to the maximum allowed under the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions, limited to the maximum amount allowed under the IRC. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing contributions from other qualified defined contribution plans (rollover). The Company may make a discretionary contribution that is determined on an annual basis. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (1) Company’s contribution, and (2) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and employer match contributions plus actual earnings thereon. Additional discretionary contributions made by the Company vest based on years of continuous employment. Participants who receive discretionary contributions are 20% vested after one year, with an additional 20% for each year thereafter up to 100% vested after five years.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of the offered investment options. Participants may change their investment options daily.

Payment of Benefits

In the event a participant terminates employment due to separation of service, retirement, disability, or death, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a fixed number of years. For termination of service due to other reasons, a participant may receive a distribution of all or any part of the value of the vested interest in his or her account. For participants whose age exceeds 73 years, the Internal Revenue Service required minimum distribution rules may apply. Distributions may be made at the participants election prior to termination upon attainment of age 59 ½.

If, upon termination of employment due to separation of service, retirement, or disability, if the account balance is less than \$5,000, the participant may elect to receive either a lump-sum distribution of the entire account balance or rollover the account into an IRA or to another qualified account. If no election is made and the balance is less than \$5,000 but greater than \$1,000, the funds will be rolled over into an IRA in the participant's name with a provider selected by the Plan administrator. If no election is made upon termination of service and the participant's account balance is less than \$1,000, the account balance will be distributed to the participant.

Participants may take hardship withdrawals to satisfy an immediate and heavy financial need and subject to certain limitation as defined in the Plan.

Administrative Fees

The Plan trustee assesses a per-transaction fee for certain types of distributions. These fees were deducted from the individual participant's account balance and recorded as Plan administration expense. The Plan trustee also assesses a fee for the administration of the Plan. Administrative fees are deducted from individual participant accounts based on account balance and recorded as Plan administration expenses for the year ending January 31, 2025.

Forfeited Accounts

Employer contributions were reduced by \$499 January 31, 2025, from forfeited non-vested accounts. Administrative expenses were reduced by \$-0- January 31, 2025, from forfeited non-vested accounts.

At January 31, 2025 and 2024, forfeited non-vested accounts totaled \$-0-. Forfeitures are available to reduce future employer contributions or pay administrative expenses, as provided by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Subsequent Events

Management has evaluated subsequent events through the date of the auditor's report, which is the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by the trustee, Principal Trust Company (Trustee).

The Plan Trustee has certified its statements of accounts as of January 31, 2025 and 2024 and for the year ended January 31, 2025. The statements of accounts include beginning and ending balances of investments held and detail of all transactions during the years, including investment earnings.

NOTE 4 – FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy in accordance with ASC 820 *Fair Value Measurements* are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active or inactive markets and inputs other than quoted prices that are observable for the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds – Valued at the NAV of units of an insurance company collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Pooled Separate Accounts – Valued at the NAV unit price adjusted periodically to reflect investment results under the separate account, which approximates fair value. Fair value is determined based on the underlying value of investments held within the pooled separate account. The Plan’s interest in the account is the cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account.

NOTE 5 – GUARANTEED INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with Principal Life Insurance Company. The contract is an insurance company issued general account backed group annuity contract. There are not any specific securities in the general account which back the investments in the account. All transactions are at contract value, including discontinuance of the contract.

Principal Life Insurance Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.55%. Such interest rates are reviewed on a semi-annual basis for resetting and are guaranteed for six months.

Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at January 31, 2025 and 2024 was \$917,462 and \$183,098, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

The contract permits the insurance company to terminate the agreement with 60 days advanced written notice.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the termination of the Plan, participants become immediately vested in all accrued benefits and are entitled to a distribution of those benefits.

NOTE 7 – TAX STATUS

On June 30, 2020, the Internal Revenue Service issued an opinion by letter that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended and restated since adopting the prototype. However, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of January 31, 2025 there are no uncertain tax positions taken.

NOTE 8 – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Company provides certain accounting and administrative services to the plan, for which no fees are charged.

Certain plan investments are in shares of investment funds managed by the trustees, as defined by the plan and therefore, these transactions qualify as exempt non-prohibited party-in-interest transactions.

Fees incurred by the Plan to the third-party administrator for expenses related to Plan operations are considered exempt party-in-interest transactions.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

As of January 31, 2025 and 2024, the Plan had investments of \$917,462 and \$1,782,111 which were concentrated in one fund and two funds, respectively.

NOTE 10 – NONEXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During the year ended January 31, 2024 employee deferrals of \$733 were withheld from a payroll cycle and not remitted on a timely basis (as defined by the Department of Labor) by the Plan Sponsor. The Plan Sponsor has confirmed that all such deferrals, and lost earnings associated with such deferrals have been deposited into the trust.
