INDEPENDENT AUDITOR'S REPORT

To the Plan Management of the
Parkview Orthopaedic Group, S.C. Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Parkview Orthopaedic, S.C. Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statements of net assets available for benefits as of January 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended January 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of January 31, 2025 and 2024, and for the year ended January 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Parkview Orthopaedic Group, S.C. Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering all full-time employees of Parkview Orthopaedic Group, LLC (the “Employer”), and related entities through common control, who are at least 21 years old and have two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The assets of the Plan are managed and administered under the terms of an agreement between the Plan and Fidelity Management Trust Company (the “Trustee”). The Trustee is a qualified institution pursuant to ERISA, and is responsible for the investment of such assets and the accounting for all related receipts and disbursements.

Contributions. The Plan is funded through participant contributions, as well as Employer matching and profit-sharing contributions. Participants may contribute up to 20% of their compensation on a pre-tax basis and up to 100% of bonuses. Roth after-tax deferrals are also permitted. Total contributions are subject to Internal Revenue Service (“IRS”) limits. The Plan also provides for Employer discretionary matching and profit-sharing contributions. The Employer did not elect to make any matching contributions for the year ended January 31, 2025. The Employer elected to make a profit-sharing contribution of \$516,881 for the year ended January 31, 2025, which was received by the Plan subsequent to January 31, 2025.

A participant must be employed on the last day of the Plan year in order to share in Employer discretionary profit-sharing contributions for the Plan year unless the participant retires at or after age 65, dies, or becomes permanently disabled during the year.

The Plan accepts rollovers and transfers in accordance with certain rules. Rollover contributions consist of contributions from other qualified plans which participants have elected to include with the Plan.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocation of the Employer contributions, if any. Plan earnings or losses and administrative fees are allocated to participant accounts based on their proportionate share of identified fund balances and other Plan assets.

Investment Options. Participants may direct their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to Plan provisions.

Vesting. Participants are immediately fully vested in their contributions. Vesting in Employer contribution portion of their accounts, plus earnings thereon, is based on years of continuous service, at 20% per year beginning after one year of service has been completed. A participant is fully vested in these contributions after completion of five years of credited service, or upon death, disability, or normal retirements.

Notes Receivable from Participants. The Plan provides that a participant may borrow from their vested account balance. Outstanding loans may not exceed the lesser of 100% of the participant’s vested balance or \$100,000. Loan terms shall not exceed five years unless used to purchase a primary residence. Payments are to be made not less frequently than quarterly. The loans are secured with up to 100% interest in the vested portion of the account balance and bear a reasonable rate of interest as determined by the Plan’s administrator (“Plan Administrator”).

NOTE 1 – DESCRIPTION OF PLAN (Concluded)

Forfeitures. Forfeited nonvested accounts totaled \$153,849 and \$113,484 as of January 31, 2025 and 2024, respectively. These accounts may be used first to pay administrative expenses and then to reduce future Employer contributions. Forfeitures totaling \$2,753 were used to pay Plan administrative expenses for the year ended January 31, 2025. Subsequent to year-end, the Company used \$105,945 of forfeitures to offset Employer matching contributions for the year-ended January 31, 2025.

Benefits. Benefit payments are generally made in lump sum upon termination, death, retirement, or resignation. The Plan permits hardship withdrawals and in-service distributions if certain criteria are met.

Recent Legislation. In December 2022, SECURE Act 2.0 (“SECURE 2.0”) was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The Internal Revenue Service (“IRS”) has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual method of accounting.

Estimates and Assumptions. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits at the date of the financial statements and the changes in net assets available for Plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentrations of Credit Risk. Substantially all the Plan’s assets are held by the Trustee.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between willing market participants as of the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold (realized), as well as held during the year (unrealized).

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments. Benefits are recorded when paid.

Administrative Expenses. Administrative expenses pertaining to the operation of the Plan are primarily paid by the Employer. Additionally, various administrative, legal, and accounting services are performed by Employer personnel on behalf of the Plan for which no charges are made to the Plan, and for which the Employer does not intend to obtain reimbursement. Investment expenses, however, are charged against the Plan’s investment income.

The Plan Administrator has obtained certification from the Trustee that such information is complete and accurate.

- Investment income (loss) and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended January 31, 2025.

- The schedule of assets held at end of year as of January 31, 2025, as shown on Form 5500, Schedule H, Part IV, Line 4i.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of January 31, 2025 and 2024.

Mutual Funds. Valued at closing price reported on the active market on which the mutual funds are traded.

Stable Value Collective Trust Fund. The stable value fund is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the collective trust (“NAV”). The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of January 31, 2025 and 2024. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

While the Employer has not expressed any intent to discontinue its contributions or terminate the Plan, it is free to do so at any time, subject to the provisions of ERISA and the Plan document. In the event of Plan termination, all participants will become fully vested in all their accounts.

NOTE 6 – EXEMPT PARTY-IN-INTEREST

Certain Plan investments are shares of mutual funds managed by the Trustee. These transactions are allowable party-in-interest transactions under ERISA and the regulations promulgated thereunder.

NOTE 7 – INCOME TAX STATUS

The Plan as adopted is a prototype non-standardized profit-sharing plan. The sponsoring organization has received an opinion letter covering the prototype plan, dated June 30, 2020. A separate determination providing that the Plan, as adopted, and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "Code") has not been sought from the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, registered investment companies and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9 – DELINQUENT REMITTANCES

The Employer inadvertently failed to deposit participant contributions and loan repayments totaling \$3,191 to the Plan timely during the year ended January 31, 2024. The Plan is currently calculating the correction amounts related to these delinquent contributions. The Employer plans to use the self-correction program to make corrections and remit lost earnings to the Plan and file Form 5330 with the IRS to pay applicable excise taxes, all of which will be paid from Employer funds and not Plan assets.

NOTE 10 – SUBSEQUENT EVENTS

Management has evaluated all known subsequent events from January 31, 2025 through November 11, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period.
