We are required to be independent of Skyland Coop, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
December 31, 2024

NOTE 1—DESCRIPTION OF PLAN

The following description of Skyland Coop, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Skyland Coop, Inc. 401(k) Plan is a defined contribution plan originally established on September 1, 2017, by Skyland Grain, LLC. During the year ended December 31, 2024, the Plan's name was changed from Skyland Grain, LLC 401(k) plan. The Plan covers all employees of Skyland Co-op, Inc. (the Cooperative). Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following the date of hire unless considered an excluded employee. Excluded employees include leased employees, and part-time, temporary, or seasonal employees with fewer than 1,000 hours of service in the computation period and less than one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Each year participants may elect to defer up to 70% of eligible compensation, as defined in the Plan, subject to the maximum amount allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to make after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Cooperative Contributions

The Cooperative may make a discretionary contribution equal to a uniform percentage or dollar amount of participant elective deferrals. Each year the Plan sponsor will determine the amount of discretionary matching contribution. For the year ended December 31, 2024, the Cooperative did not provide a discretionary matching contribution.

In order to meet annual discrimination testing requirements, the Cooperative may make a qualified nonelective contribution (QNEC). For the year ended December 31, 2024, the Cooperative made no applicable QNEC contributions.

Investment Options

Participants direct the investment of their contributions as well as the Cooperative's contributions, when applicable, into various investment options offered by the Plan. If not directed by the participant, accounts will be invested in accordance with the default investment alternatives established under the Plan. The Plan currently offers Mutual Funds, Common Collective Trust Funds, and Fixed Annuities as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Cooperative's contributions, when applicable, and an allocation of Plan earnings, charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Cooperative's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Upon attainment of normal retirement age, death, or disability of the participant, all amounts are fully vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding balance of loans from the Plan during the year ending the day before the date of the new loan, or 50% of their vested account balance. The maximum number of loans the participant may have outstanding at any one time is three. The loans are secured by the balance of the participant's account and bear annual interest at the prime rate plus 1%. Loans used to purchase a residence are to be repaid in a period determined by the administrator not to exceed thirty years. Loans for all other purposes must be repaid within five years. Principal and interest is paid ratably through payment terms specified in each note agreement. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance may be reduced and a benefit payment recorded based on the terms of the Plan document.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, a partial withdrawal, or payment in installments. Participants with a vested benefit not exceeding \$5,000 will be distributed as a single lump sum payment.

In-service distributions are allowed by meeting certain conditions, including attaining age 59 ½ or incurring a financial hardship.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid interest. Delinquent participant loans, if any, are classified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See also Note 3—Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses (realized and unrealized) on investments bought and sold as well as held during the year. See Note 3.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability and are included in benefits paid to participants.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Operating Expenses

Certain administrative expenses of maintaining the Plan are paid by the Cooperative.

Date of Management's Review

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

NOTE 3—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end Mutual Funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are considered to be actively traded.

Fixed Annuities: this is an EI Fixed Account that is backed by the general account assets of Empower Annuity Insurance Company of America. The reported values are reported daily as calculated by the annuity provider.

Common Collective Trust Funds: are valued at the NAV as determined by the trustee of such funds based upon the underlying securities stated at fair value. The NAV as provided by the trustee of the fund is used as a practical expedient to estimate fair value.

NOTE 5—PLAN TERMINATION

Although it has not expressed any intention to do so, the Cooperative has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6—TAX STATUS

The Plan has adopted a prototype-standardized plan designed to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the prototype plan has received an opinion letter dated October 6, 2020, that this Plan is relying on. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, exempting it from income taxes.

NOTE 7—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8—RELATED PARTY TRANSACTIONS

The Cooperative absorbs significant expenses of administering the Plan, including general administration and recordkeeping costs.
