- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Jeff Wyler Automotive Family, Inc. Health and Welfare Benefit Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of February 28, 2025 and the supplemental schedule of reportable transactions for the year ended February 28, 2025 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN:

The following description of the Jeff Wyler Automotive Family, Inc. (Company) Health and Welfare Benefit Trust (Plan) provides general information about the Plan. Participants should refer to the plan document for a more complete description of plan provisions.

General

The Company has established a group health plan to provide medical, dental, vision, prescription, disability and group life insurance benefits to eligible employees of the Company and their covered dependents. Participants may enter the Plan on the first day of the month following 60 days of employment. The Plan assets are held in a voluntary employees' beneficiary association ("VEBA") trust. The VEBA trust was established on February 28, 1986, to collect contributions from the Company and participants to cover the cost of benefits. The funds from the trust may be used for the following purposes: (1) to pay the necessary expenses of the trust; (2) to pay premiums on the policies issued to the Plan; and (3) to provide health care and prescription benefits for covered employees and their dependents and to set aside funds for such purposes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan does not offer any postretirement benefits.

Contributions and funding policy

The Plan is funded by contributions from the Company and through employee withholdings. Employees contribute to the Plan based upon the level of coverage elected. Fully insured group life insurance premiums are paid 100% by the Company. Fully insured voluntary life, vision, dental, and disability insurance premiums are paid 100% by participating employees. The Company also pays for loss limitation insurance to cover large losses in any one year or on any one claim.

Additionally, under provisions of the Consolidated Omnibus Budget Reconciliation Act, or COBRA, terminated employees may elect to extend coverage for a period not to exceed eighteen months from date of termination by contributing specified amounts as determined annually by the plan administrator.

As of February 28, 2025 and February 29, 2024, net assets available for benefits exceeded benefit obligations by \$775,041 and \$1,091,928, respectively. This surplus includes a significant estimate for claims incurred but not reported (\$1,721,148 and \$1,658,594 as of February 28, 2025 and February 29, 2024, respectively). The Company plans to make additional contributions should the net assets available for benefits be insufficient to cover current claims and expenses.

Self-insured benefits

Medical and prescription benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under an administrative service arrangement. The claims processors pay claims directly to or on behalf of participants and are reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-loss coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The individual stop loss limit was \$250,000 for the year ended February 28, 2025. During 2025, the Plan received stop loss reimbursements of \$839,696, which are recorded as a reduction of health claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Administration and premiums

On behalf of the Plan, Anthem Insurance Company (Anthem) pays participant medical and pharmacy claims and secures certain group insurance policies for stop-loss coverage and vision benefits. Lincoln Financial Group provides group insurance policies for dental, disability, and group life insurance benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements are presented on the accrual basis of accounting.

Cash

Cash consists of funds on deposit in the VEBA trust checking account.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan benefits

Eligible medical claims of participants and their dependents are processed by Anthem. Pharmacy claims of participants and their dependents are processed by OptumRx. Claim payments are recorded when paid by Anthem or OptumRx. The liability for health claims incurred but not reported is estimated based on claim lag reports and actual claims experience during the year.

Insurance premiums

Premiums for aggregate and specific contract stop loss reinsurance coverage are expensed as incurred and are included as administrative expenses. Premiums for dental, vision, life insurance, and disability are expensed as incurred.

Administrative expenses

Participant enrollment, claim processing fees, custodial, and administrative fees totaling \$584,747 were paid by the Company on behalf of the Plan for the year ended February 28, 2025 and are included in administrative expenses. Certain other administrative expenses are paid directly by the Company on behalf of the Plan and are excluded from these financial statements.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

The liability for benefits is particularly sensitive to recent claims frequency, claims severity, and reinsurance coverage. The Trustees believe that the liability for benefits is adequate to cover the benefits to date, but the liability is based on estimates and the amount ultimately paid may be more or less than such estimates. The estimates are continually reviewed and adjusted as necessary as experience develops or new information becomes known. Such adjustments are included in current operations, as known.

Subsequent events

The Plan has evaluated subsequent events through October 30, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY TRUSTEE:

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, PNC Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of benefits obligations and net assets available for benefits as of February 28, 2025 and February 29, 2024, the supplemental schedule of assets (held at end of year) as of February 28, 2025, the related investment activity reflected in the statement of changes in benefits obligations and net assets available for benefits for the year ended February 28, 2025, and the information reflected on the supplemental schedule of reportable transactions for the year ended February 28, 2025.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and February 29, 2024.

Money market funds: Valued at cost which approximates fair value.

Registered investment companies: Valued at daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of February 28, 2025 and February 29, 2024. Classification within the fair value hierarchy table is based on the lowest of any input that is significant to the fair value investment:

5. PLAN TERMINATION:

It is the intent of the Company to continue the Plan indefinitely; however, the Company reserves the right to terminate the Plan at any time. In the event of termination of the Plan, the trustee shall apply the net assets to pay any and all obligations of the Plan and the remainder, if any, will be used to provide benefits under the terms of the Plan until all funds are exhausted.

6. TAX STATUS:

The VEBA trust funding the benefits of the Plan received a determination letter dated November 29, 1989, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. The Plan Sponsor does not believe that the Plan incurred any unrelated business income that would result in income taxes during the year ended February 28, 2025.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

7. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain Plan investments are managed by PNC Bank. PNC Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

8. RISK AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect investment account balances and the amounts reported in the statements of benefit obligations and net assets available for benefits.
