As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Fidelity Management Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material

respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of W.K. Dickson & Company Employee Savings & Protection Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about W.K. Dickson & Company Employee Savings & Protection Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

As described in Note 6 to the financial statements, the governing body of W.K. Dickson & Company Employee Savings & Protection Plan approved a plan of liquidation on August 30, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN:

The following description of the W.K. Dickson & Company Employee Savings & Protection Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is sponsored solely by W.K. Dickson & Company, Inc. (the Employer).

General - The Plan is a defined contribution retirement savings plan under Section 401(k) of the Internal Revenue Code and covers all full-time employees who have at least one month of service and are at least twenty-one years of age at the plan entry date. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is not covered by the Pension Benefit Guarantee Corporation (PBGC). Additionally, the Plan assets have no other form of insurance. The Plan provides several investment options, all of which are participant directed. The Employer allows eligible employees to enter the Plan on the first of each month.

Contributions - Salary deferral contributions may be made by all eligible employees. Salary deferral contributions shall not exceed the amounts prescribed by the Secretary of the Treasury. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they have affirmatively elected not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation unless changed by the participant. The automatic deferral increases 1% per year to a maximum of 6%, unless affirmatively changed by the participant. Employer matching contributions equal a percentage as determined annually by the Employer. The Employer matching contributions for 2024 and 2023 were 50% of the first 6% of deferrals on eligible compensation. Additional profit-sharing contributions may be contributed to the Plan at the Employer's discretion. In 2024 and 2023, there were no profit-sharing contributions. All Employer contributions are subject to the vesting percentage. Voluntary contributions by plan participants in excess of salary deferral contributions are not permitted.

Participant accounts - Each participant's account is credited with the participant's contributions, the Employer's contributions and the net earnings or losses of the participant's investment account. Allocated earnings are based on participant account balances as defined in the Plan. The benefits to which a participant is entitled are the benefits that can be provided from the participant's account. Changes in the underlying value of investments selected by participants will affect the benefits to which a participant is entitled.

Vesting - A participant is 100 percent vested in Employer contributions and related earnings upon the occurrence of any of the following:

- attaining normal retirement age
- becoming totally disabled, as defined in the Plan
- employment terminates as a result of death

If a participant's employment terminates prior to retirement for any reason other than death or disability, then vesting is based on a six-year schedule, with increments of 20 percent vesting beginning in the second year and continuing until the participant is 100 percent vested after the sixth year. Each participant is immediately 100 percent vested in his or her salary deferral contribution and related earnings. Forfeitures are used to reduce employer matching contributions and to pay administrative expenses.

Notes receivable from participants - The Plan allows for loans to participants. The minimum amount for each loan is \$1,000 and the maximum is the lesser of 50 percent of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at market rates. The loans are repaid ratably through payroll deductions over the terms of the loans.

Payment of benefits - If the vested account is not more than \$5,000, the vested account will be paid to the participant in a single lump sum. For accounts over \$5,000, there are several forms of payment that can be elected by participants. These are outlined in the Plan's summary.

Administrative expenses - Administrative expenses of the Plan are paid by the Employer and the participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates - The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments - Investments of the Plan consist of Fidelity Management Trust Company's (Fidelity's) funds held in cash, common and collective trust funds, and mutual funds which are stated at fair value. See Note 4 for discussion of fair value measurement.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits - Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY PLAN CUSTODIAN:

The plan administrator has elected the alternative method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Certain plan investments are funds managed by Fidelity. Fidelity is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

4. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements Topic of the Financial Accounting Standards Board (FASB) Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS:

The Plan administrator has chosen to rely on an opinion letter from the third-party administrator that the Plan is qualified under Internal Revenue Code Section 401. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

6. PLAN TERMINATION:

On August 30, 2024, the Employer sold substantially all of its assets to an unrelated third party. Substantially all employees will become employees of the unrelated third party and the Plan will be terminated; therefore, management determined that liquidation is imminent. Final distributions will be determined based on all participants being 100% vested and will be made as soon as possible after the termination date. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

7. FORFEITURES:

As of December 31, 2024 and 2023, the Plan had forfeiture amounts of approximately \$450 and \$500, respectively, available to reduce future employer matching contributions and to pay administrative expenses. During the years ended December 31, 2024 and 2023, respectively, approximately \$92,200 and \$38,900 of forfeitures were used to reduce employer matching contributions.

8. PARTIES-IN-INTEREST:

In addition to the party-in-interest transactions with Fidelity as referenced in Note 3, other party-in-interest transactions occurred with the Plan's auditors and an investment advisor. The Employer pays the auditor's fees.

9. RISKS AND UNCERTAINTIES:

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

10. SUBSEQUENT EVENTS:

Events and transactions occurring after December 31, 2024 have been evaluated to determine proper recognition and disclosure in the financial statements. Subsequent events and transactions were evaluated through October 14, 2025, which represents the date the financial statements were available to be issued.
