***Basis for Opinion***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to the Financial Statements

### 1. Description of Plan

The following brief description of the Christian Appalachian Project, Inc. (the Plan Sponsor) Employee Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the *Plan Document* for more complete information.

#### General

The Plan is a defined contribution retirement plan subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as well as applicable sections of the *Internal Revenue Code* (IRC). The Plan became effective June 1, 1985 and was restated effective December 1, 2021. The Plan is administered by a trust. The trustee is Fidelity Institutional Asset Management (Fidelity). The Plan is a single employer, defined contribution plan that covers substantially all employees of Christian Appalachian Project, Inc. (the Plan Sponsor and Plan Administrator). Effective March 18, 2020, the Plan excludes part-time, temporary, and seasonal employees from being eligible to participate in the Plan.

#### Eligibility

Employees are eligible to participate in the Plan on the date the employee completes the eligibility requirements of reaching the age of 21 and completing one month of service. At that time, participants can begin deferring compensation into the Plan, and become eligible for both the employer matching and employer nonelective contributions.

#### Contributions

The Plan is funded with employee salary deferral, rollover and Plan Sponsor contributions. Participants may elect to contribute, in whole percentages, up to 75% of their annual compensation to their individual accounts on a pre-tax basis. The Plan Sponsor will withhold an automatic deferral amount of 6% from all new participants' compensation each payroll period unless the participants make a contrary election. In 2024, the Plan Sponsor made a matching contribution on behalf of eligible participants equal to 100% of the participant contributions up to 6% of each participant's annual compensation. In addition, the Plan Sponsor may elect to make a discretionary contribution, as determined each year. The additional contribution is allocated to each eligible participant's account in proportion to his or her compensation as a percentage of the compensation of all eligible participants. The total contribution to a participant's account for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service regulations. Discretionary contributions of \$42,453 were paid during 2024, which are included in employer contributions on the statement of changes in net assets available for benefits.

### 1. Description of Plan, continued

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and Employer safe harbor, non-elective and matching contributions as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined by the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

The benefit to which a participant is entitled is the benefit that can be provided from the participant's account, which includes participant and sponsor contributions and related earnings thereon. Earnings are allocated on a daily basis in the manner described above. Participants are immediately vested 100% in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

In addition, participants become 100% vested upon termination of service due to death, disability, or the attainment of normal retirement age as defined in the *Plan Document*.

#### Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant with an available account balance of less than \$1,000 will receive the full value in his or her account as a lump-sum distribution. Optional distribution forms are not permitted.

Upon approval by the Plan Sponsor, participants may make hardship withdrawals. Hardship withdrawals are limited to the determined level of need not to exceed the available account balance.

Upon reaching the age of 59 1/2 or older, a participant may elect an in-service distribution from his or her account.

### 1. Description of Plan, continued

#### Forfeited Accounts

Forfeitures may be used to pay Plan administrative expenses or reduce Plan Sponsor contributions. Any portion not used to pay Plan administrative expenses or reduce Plan Sponsor contributions shall be allocated among the accounts of eligible participants. As of December 31, 2024 and 2023, forfeited accounts totaled \$33,884 and \$42,453, respectively. Amounts previously forfeited were reallocated to participant accounts, as additional Plan contributions, in the amount of \$42,453 during 2024. Amounts forfeited on participant balances during 2024 totaled \$32,406.

#### Risk and Uncertainties

The Plan provides for various participant-directed investment options. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing the information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

### 2. Summary of Significant Accounting Policies, continued

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Certain administrative expenses are paid by the Plan. All other administrative expenses are paid by the Plan Sponsor.

The Plan has established a revenue credit program (RCP) account with Fidelity, who calculates the revenue credit each quarter to be placed into the RCP account. The amounts received by the Plan under the RCP reduce administrative expenses. As of December 31, 2024 and 2023, the cumulative balance remaining in the RCP account totaled \$1,335 and \$1,212, respectively. In 2024, the Plan received \$730 under this arrangement that was placed in the RCP account. Qualified expenses of \$658 were paid from the RCP account during 2024.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through September 15, 2025, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Trustee

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Fidelity, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that investment information provided to the Plan Administrator by the trustee related to the investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and supplemental schedule.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at cost, which approximates fair value.

There were no changes in the methodologies used to measure fair value at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. Fair Value Measurements, continued

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

### 5. Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest.

Additionally, indirect fees are paid to Fidelity based on investment account values. These fees range from 0.02% to 1.03% of the investment account value. These fees are included with the net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

### 6. Tax Status

The Plan uses a prototype plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The prototype plan has been amended since receiving the determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 7. Priorities Upon Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.
