Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Greenfield Rehabilitation Agency, Inc. Employees 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

(1) Description of Plan

The following description of the Greenfield Rehabilitation Agency, Inc. Employees 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General - The Plan is a defined contribution plan sponsored by Greenfield Rehabilitation Agency, Inc. (the "Company") for the benefit of its employees who have completed three consecutive months of employment from the date of employment and completed 250 hours of service and are age twenty-one or older. If the employee does not complete 250 hours of service within the first 90 days of employment, the service requirement is satisfied after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may make pre-tax and Roth elective deferrals of their annual compensation, as defined in the Plan, up to limits determined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan.

The Company may make discretionary matching contributions on behalf of participants proportionate to the elective deferrals made by participants. The Company may also make non-elective discretionary contributions. Contributions are subject to certain limitations. During fiscal 2025 and 2024, the Company made matching contributions of 25% of the first 6% of employee deferrals.

Participant investment account options - Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits – Benefits are recorded when paid. On termination of service due to death, disability, or retirement, a participant may elect to receive benefits based on various payment options of the Plan. Participants may also receive benefits upon obtaining retirement age. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allows for distributions of salary deferrals for financial hardship and in-service withdrawals after participants reach age 59½.

Notes receivable from Participants - Effective July 1, 2019, Plan participants are permitted to borrow from their Plan accounts in accordance with the loan provisions and applicable interest rate as outlined in the Plan. Interest on participant loans is fixed for the term of the loan and is based on prime plus 1%. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of fifty percent (50%) of a participant's account balance at the time of the loan request or \$50,000. Only one loan may be outstanding at any one time. The maximum repayment period is generally five years, unless it was used for the purchase of a primary residence. There was no allowance for credit losses recorded at January 31, 2025 and 2024. Principal and interest are paid ratably through payroll deductions.

Forfeited accounts - Forfeitures are used to supplement employee account balances. Forfeitures decreasing employer matching totaled \$32,549 during fiscal 2025, and \$13,469 during fiscal 2024. Forfeited non-vested accounts were \$56 and \$175 at January 31, 2025 and 2024, respectively.

(2) Summary of significant accounting policies

Basis of accounting and presentation - The financial statements of the Plan are prepared under the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Use of estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement. Quoted market prices, if available, are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses - Certain expenses of maintaining the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits.

Subsequent events – The Plan has evaluated subsequent events through November 13, 2025, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). This hierarchy consists of three broad levels:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access and have the highest priority.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant for the asset or liability.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The fair value of mutual funds is based on quoted net asset values of the shares held at plan year end as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The Stable Value Option fund is valued at fair value, which is determined based on the contract value as provided by the trustee, and is based on the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses.

Collective trust funds are valued at net asset value (NAV) of the Plan's interest in the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell its investments for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The collective trust funds that were measured at NAV have not been classified in the fair hierarchy table presented below.

The change in fair value of investments for the years ended January 31, 2025 and 2024 are reported in net appreciation (depreciation) in fair value of investments.

(4) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(5) Information prepared and certified by the trustees

Plan management has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan through June 30, 2024, Transamerica Trust Company, the custodian subsequent to June 30, 2024 and Transamerica Financial Life Insurance Company, as holder of certain assets of the plan, have certified that the following data for the years ended January 31, 2025 and 2024 and included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments for the period:

- Investments
- Cash and collective trust funds
- Loans receivable
- Net appreciation (depreciation) in fair value of mutual funds
- Dividend and interest income
- Schedule of assets (held at end of year)

(6) Tax status

The Plan uses a non-standardized plan document which was restated and submitted to the Internal Revenue Service (“IRS”) for review. The IRS determined and issued a letter dated June 30, 2020 stating that the plan document is qualified under the appropriate sections of the Internal Revenue Code (the “IRC”). Effective June 24, 2021, the Plan completed the Cycle 3 Restatement by adopting the non-standardized plan document. There were no significant changes to the Plan provisions. The Plan Administrator and third-party administrator believe that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to fiscal 2021.

(7) Transactions with Parties-In-Interest

Fees for professional services rendered to the Plan may be paid by the Company at its discretion. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Certain of the Plan's investments are managed by the trustee and/or their agent and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party in interest transactions.

(8) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of January 31, 2025 and 2024, the Plan had investments of \$8,310,312 and \$7,083,262, respectively, that were concentrated in two funds.
