Dear Sir/Madam,

I am writing to request an abatement of any penalties that may be imposed for the late Filing of Form 5500SF for tax year 2023 and 2024.

When we formed the plan in 2019, we contracted a company called Newport Financial to file required forms. They did this through 2022 but failed to file for 2023 or 2024. We were not aware of this and were only notified of the delinquency when we received a letter from the IRS dated 11/10/2025. Since we can no longer reach Newport, I have self-prepared this filing and have filed today.

We are a small employer, with only 18 participants in the plan with plan assets of under \$500,000. Our intention was to be in compliance and believed that Newport was keeping us so. Please abate any penalties proposed in light of our good faith efforts to meet IRS filing guidelines and immediate response to the notification that we were not in compliance.
