Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Centro, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 17, 2025 and June 30, 2024, and the related statements of changes in net assets available for benefits for the period ended January 17, 2025 and year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Centro, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 17, 2025 and June 30, 2024, and for the period ended January 17, 2025 and year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Centro, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter

As discussed in Note 1 to the financial statements, the Plan was merged into Tank Holding Corp. 401(k) Plan effective January 17, 2025, and substantially all of its assets were transferred to the successor plan on that date. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Centro, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements


In performing an audit in accordance with GAAS, we:

NOTE 1 DESCRIPTION OF PLAN

The following description of the Centro, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective July 1, 1980. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective July 1, 2024. The Plan excludes leased employees, reclassified employees, nonresident aliens, and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors (Board) is responsible for the oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board.

Eligibility

Employees of Centro, Inc. (the Company) are eligible to participate in the deferral and match components of the Plan upon completing three months of service. Effective October 1, 2017, the Plan was amended to exclude part-time, temporary, and seasonal employees who are regularly scheduled to work less than 1,000 hours during the year. Employees meeting the eligibility requirements, enter the Plan on the first payroll next following or coinciding with meeting the eligibility requirements. Participants are eligible for the profit-sharing contribution once they complete one year of service. To be credited with one year of service, participants must be credited with 1,000 hours of service during the Plan year. To receive an allocation of the discretionary contributions, participants must have completed 1,000 hours during the year and be employed on the last day of the Plan year unless severed from employment due to death, disability, or retirement. Employees meeting the profit-sharing requirements of the Plan enter the Plan on the first day of the Plan year immediately preceding or coincident with the date the employee completes the eligibility requirements.

Contributions

The Plan includes a salary deferral arrangement under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes matching contributions of 50% of the first 6% of compensation that a participant contributes to the 401(k) portion of the Plan. The Company may also elect to make qualified nonelective contributions and discretionary contributions to the Plan. There were no qualified nonelective contributions during 2025 and 2024. There were no discretionary contributions during 2025 or 2024.

Contributions (Continued)

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and rollover contributions and in any qualified nonelective contributions, plus actual earnings thereon. Vesting in the Company's matching contributions and any discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Transfer of Assets

The Company acquired Solar Plastics from Tank Holdings Corp. Employees from Solar Plastics were participants in the Tank Holding Corp. Retirement Plan. On June 12, 2024, the President authorized the merger of Plan assets from the Tank Holding Corp. Retirement Plan for the Solar Plastics employees into the Centro, Inc. 401(k) Profit Sharing Plan. The Solar Plastics participants in the Tank Holding Corp. Retirement Plan merged into Centro, Inc. 401(k) Profit Sharing Plan, effective October 3, 2024, and transferred \$365,960 to Centro, Inc. 401(k) Profit Sharing Plan on that date.

The Company was acquired by Tank Holdings Corp. in 2023, which became the parent company of Centro, Inc. Tank Holding Corp. has a retirement plan with a plan name of The 401(k) Plan. (Tank Holding Corp. 401(k) Plan). On September 5, 2024, the President authorized the merger of Plan assets of Centro, Inc. 401(k) Profit Sharing Plan into the Tank Holding Corp. 401(k) Plan. The Centro, Inc. Profit Sharing Plan assets were then transferred to the Tank Holding Corp. 401(k) Plan effective January 16, 2025 and January 17, 2025 and transferred \$67,795,169 and \$1,688,238 to Tank Holding Corp. 401(k) Plan, respectively.

Transfer of Assets (Continued)

Effective January 1, 2025, participants in the Plan were eligible to participate in Tank Holding Corp. 401(k) Plan.

Benefit Payments

Upon termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his/her account, or payment in monthly, quarterly, or annual installments over a fixed period of time not exceeding the life expectancy of the participant and the named beneficiary. Participants receive lump sum distributions if their vested account balance does not exceed \$5,000 at the time of their termination of service. Participants receive rollover of balances less than \$1,000 at the time of their termination of service. In-service withdrawals and deemed service distributions are also allowed for participants who are at least 59½ years old.

Forfeitures

Forfeited nonvested accounts are used to reduce future Company contributions. Forfeitures were used to reduce the Company's matching contribution to the 401(k) accounts by \$254,835 and \$277,393 for the period ended January 17, 2025 and the year ended June 30, 2024, respectively. At January 17, 2025 and June 30, 2024, there were \$-0- and \$7,019, respectively, of forfeitures available to reduce Company contributions in future years.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Significant accounting policies followed by the Plan are presented below.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 17, 2025 and June 30, 2024. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through November 13, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Delaware Charter Guarantee & Trust Company dba Principal Trust Company, the trustee and qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of January 17, 2025 and June 30, 2024, the statements of changes in net assets available for benefits for the period ended January 17, 2025 and year ended June 30, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at January 17, 2025 and June 30, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Due to the transfer of assets into Tank Holding Corp. 401(k) Plan, the Plan had no investments as of January 17, 2025. The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of June 30, 2024:

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

As described in Note 1, the Plan was terminated and fully vested assets transferred to Tank Holding Corp. 401(k) Plan on January 17, 2025.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of funds managed by Principal Financial Group. Principal Financial Group is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan to Principal Financial Group for the investment management and administrative services were \$93,625 and \$165,335 for the Plan period ended January 17, 2025 and year June 30, 2024, respectively.
