**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of New York RHB LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1 DESCRIPTION OF PLAN**

The following description of the New York RHB LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of New York RHB LLC and affiliated entities in the controlled group (the “Plan Sponsor”), who have attained the age of twenty-one and have completed one year of eligibility service. This includes completing at least 1,000 hours of service within a consecutive 12-month period beginning with the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Administration**

The Plan is administered by a third-party administrator, Associated Pension Consultants, Inc. Voya Retirement Insurance and Annuity Company and Voya Services Company (collectively, “Voya” or the “Trustee”) is responsible for the custody and management of the Plan’s assets.

**Contributions**

*Participant Contributions*

Eligible employees may contribute up to 100% of pre-tax or post-tax annual compensation with a limit of \$23,000 in 2024, as defined in the Plan. Contributions must be made through payroll deductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e., rollover contributions). Participants who have attained age 50 before the end of the plan year are eligible to make tax-deferred catch-up contributions.

*Company Contributions*

Matching contributions are made on a per payroll basis. The Company will match 100% on the dollar of the first 3% of employee contributions and will match 50% on the dollar of employee contributions that exceed 3% but only up to 5% to their 401k retirement account.

The Plan Sponsor also may make discretionary profit-sharing contributions. The Plan Sponsor made discretionary contributions of \$82,201 and \$81,155 for the years ended December 31, 2024 and 2023, respectively. The amounts were funded subsequent to year-end.

**Participant Accounts**

Each participant’s account is funded with the participant’s contributions and allocations of the Plan Sponsor’s contributions, if any, and allocations of Plan earnings or losses. Allocations are based on participant account balances, as defined by the Plan. Participants are entitled to the vested portion of their account.

**Vesting**

Participants are immediately vested in their contributions and earnings thereon. Participants begin vesting in their portion of the Plan Sponsor’s profit-sharing contribution and employer matching contributions, plus actual earnings thereon after two years of service. The vesting percentage is as follows: i) less than two years, 0% vested, ii) two years but less than 3 years, 20% vested, iii) three years but less than four years, 40% vested, iv) four years but less than five years, 60% vested, v) five years but less than six years, 80% vested, vi) six or more years, 100% vested.

**Note 1 DESCRIPTION OF PLAN (continued)**

**Participant Loans**

Participants may borrow from their accounts and may have up to four outstanding loans at any time. The minimum loan amount is \$1,000. When adding to the outstanding balance of all loans, a loan may not exceed the lesser of i) \$50,000 minus the difference between the highest outstanding loan balance of loans in the past twelve months and the outstanding balance of loans from the Plan on the date the loan is made, or ii) 50% of their vested account balance. These loans may be for a maximum of five years. Loans made for a purchase of a primary residence may have a maximum term of twenty years. The loans are secured by the balance in the participant's account and bear interest at 1.5% above the prime rate, fixed at the time of the loan, as defined. Principal and interest are repaid through payroll deductions.

**Investment Options**

Plan investments are participant directed. Upon enrollment in the Plan, a participant may direct contributions in any of the then available investment fund options. Participants may change or transfer their investment options at any time via a secure internet website.

**Payment of Benefits**

Vested account balances are payable upon retirement, death or disability, or termination of employment. In-service distributions are also permitted after meeting certain requirements in accordance with Plan provisions. Distributions may be made in a lump sum payment.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce future Plan Sponsor contributions or plan expenses. Unallocated amounts at December 31, 2024 and 2023 totaled \$591 and \$17,174 respectively. Current year forfeitures were \$2,207. The Plan Sponsor used \$18,790 of forfeitures to offset its contributions in 2024.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The Plan's financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Management Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (see Note 3). Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold, and held at year-end.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Participant Loans**

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

**Operating Expenses**

Certain expenses incurred maintaining the Plan are paid directly by the Plan Sponsor and excluded from these financial statements. Investment-related expenses are included in net investment gain/(loss) of investments. Certain participant services and recordkeeping fees are charged to the participants' account.

**Note 3 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques must maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Note 3 FAIR VALUE MEASUREMENTS (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value/Fixed Income Fund:* Valued at the net asset value of the of the underlying units invested by the insurance company (Voya) through its general fund. The net asset value is used as a practical expedient to estimate the fund’s fair value. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that the securities liquidations needed to fund such a withdrawal would be carried out in an orderly manner.

The methods described above may produce a fair value calculation that may not be indicative of net asset value or reflective of future fair value. Furthermore, while the Plan’s valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different estimates of fair value at the reporting date.

**Note 4 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan for distribution and loan administration services totaled \$4,405 and \$3,280 for the years ended December 31, 2024 and 2023, respectively. Participant loans also qualify as party-in-interest transactions.

**Note 5 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contribution accounts.

**Note 6 TAX STATUS**

The Plan has adopted a Volume Submitter Plan sponsored by United Retirement Plan Consultants dated December 31, 2018. The Plan is qualified under Code Section 401(a) of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Tax returns are generally open for a three-year period after being filed. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 ERISA SECTION 103(a)(3)(C) AUDIT**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the following information was certified as complete and accurate by the trustee, Voya, as of December 31, 2024 and 2023 and for the years then ended:
