Opinion

NOTES TO FINANCIAL STATEMENTS

June 30, 2025 and 2024

1. DESCRIPTION OF PLAN

The following description of WAICU Benefits Consortium, Inc. Health Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General

The Plan provides health and welfare benefits to eligible employees, and their dependents, of member colleges and universities of the Plan (collectively, the Colleges). Wisconsin Association of Independent Colleges and Universities Inc. (WAICU) is the Plan administrator. The Plan is funded through a voluntary employee's beneficiary association (VEBA) trust fund. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Cardinal Stritch University exited the Plan effective August 31, 2023. As of this date, Cardinal Stritch University had an accumulated net assets balance of approximately \$688,000, which was used to pay any remaining claims, expenses or returned to the university. As of June 30, 2024, Cardinal Stritch University's remaining accumulated net assets was \$558,324 and is included as payable due to former members within the statement of net assets available for benefits as of June 30, 2024. The Plan distributed a total of \$734,856 to Cardinal Stritch University during the year ended June 30, 2025. The excess total between the distributions during the year ended June 30, 2025 and the payable due to former members as of June 30, 2024 was \$176,532 and is included as distribution of net assets – former members within the statement of changes in net assets available for benefits as of June 30, 2025. There was no remaining net assets for Cardinal Stritch University as of June 30, 2025.

1. DESCRIPTION OF PLAN (Continued)

General (Continued)

Marian University exited the Plan effective December 31, 2023. As of this date, Marian University had an accumulated net asset balance of approximately \$973,000, which was used to pay any remaining claims, expenses or returned to the university's qualified plan. As of June 30, 2024, Marian University's remaining accumulated net asset balance was \$673,667 and is included as payable due to former members within the statement of net assets available for benefits as of June 30, 2024. The Plan distributed a total of \$717,589 and \$391,000, respectively, to Marian University during the years ended June 30, 2025 and 2024. The excess total between the distributions during the year ended June 30, 2025 and the payable due to former members as of June 30, 2024 was \$43,922 and is included as distribution of net assets – former members within the statement of changes in net assets available for benefits as of June 30, 2025. There was no remaining net assets for Marian University as of June 30, 2025.

Benefits and Eligibility

The Plan provides medical, prescription, dental and vision benefits for eligible employees of the Colleges and their dependents. The benefits provided are self-insured. The claims for these benefits are processed by the third-party claims processors under administrative services only (ASO) arrangements. The claim processors pay claims directly to or on behalf of the participants and are then reimbursed by the Plan's VEBA trust. Ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

An eligible employee is defined as an employee who averages at least 30 hours of service per week and has been informed by his or her employer that he or she is eligible for coverage, an employee who has been informed by the employer that he or she is eligible for coverage based on that employer's own eligibility criteria and determinations, an employee on an approved leave of absence who was covered as of the period immediately preceding the approved leave of absence, a former employee during a period immediately following and continuous with employment during which the employee is receiving a severance benefit from the employer or an employee on an approved sabbatical.

Retired employees are generally entitled to similar health care benefits provided they participated in the Plan during the one-year period immediately prior to retirement and were actively at work on the day prior to retirement, are at least 55 years of age and have 15 years of continuous service with the employer or are over 55 years of age and the sum of his or her age and years of full-time service equals at least 70.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

1. DESCRIPTION OF PLAN (CONTINUED)

Contributions

The Colleges and their employees make any required contributions toward the cost of the participants and any covered dependents. The amount of the respective contributions is set forth in notices from the Plan administrator and may be changed from time to time by the Board of Directors.

The cost of the postretirement benefit plan is shared by the Plan's participating employers and retirees. In addition to deductibles and copayments, retiree contributions were as follows:

(1) Ripon College	For single coverage, retirees under 65 years old make 5% contributions if enrolled in the bronze level of coverage and contribute 15% and 25% of estimated costs of providing their postretirement benefits if enrolled in the silver and gold levels of coverage, respectively. For any other type of coverage, retirees under 65 years old contribute 15% of estimated costs of providing their postretirement benefits if enrolled in bronze and 26% and 36% if enrolled in silver and gold coverage, respectively. Retirees over 65 years old contribute 100% of estimated costs of providing their postretirement benefits.
(2) MSOE - Prior to July 1, 1996	All retirees contribute approximately 67% of estimated costs of providing their postretirement benefits.
(3) MSOE - July 1, 1996 and after	As of June 30, 2025 and 2024, retirees on average contribute approximately 89% and 93%, respectively, of estimated costs of providing their postretirement benefits.

Retirees of the remaining colleges and universities contribute 100% of the estimated costs of providing their postretirement benefits for the years ended June 30, 2025 and 2024.

Funding Policy

The Plan administrator monitors the funding needs of the Plan. Claim payments, stop-loss insurance premiums, administrative fees and expenses are paid from the VEBA trust. Employee contributions are withheld through payroll deductions at the Colleges and forwarded to the Plan administrator. All expenditures in excess of employee contributions received are funded through contributions from the Colleges.

1. DESCRIPTION OF PLAN (Continued)

Stop-Loss

The Plan was self-funded for the first \$250,000 in annual major benefits per participant and for annual major benefit level for the covered group of employees for the years ended June 30, 2025 and 2024. Benefit payments in excess of the self-funded amounts are covered by insurance contracts.

Administrative Expenses

The cost of administering the Plan is paid by the Plan. In accordance with a reimbursement of services agreement, the Plan reimburses WAICU for a proportionate share of the salaries and other direct expenses associated with the services of officers and staff of WAICU utilized to administer the Plan. Expenses reimbursed to WAICU by the Plan for the years ended June 30, 2025 and 2024 were \$468,231 and \$492,772, respectively. Included in administrative expenses payable at June 30, 2025 and 2024, are amounts due to WAICU of \$4,115 and \$41,373, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Cash

Cash is defined as currency on hand, in demand deposits.

Use of Estimates

The preparation of financial statements is in accordance with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, estimated health claims incurred but not reported or approved (IBNR), postretirement benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

The Plan's liability for IBNR claims represents actual unprocessed claims at year-end as well as estimated claims incurred but not yet reported as of year-end. The estimate is calculated by an independent actuary and takes into consideration prior claims experience and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates (Continued)

Estimates that are particularly susceptible to significant change in the near-term are the liabilities for IBNR, and the postretirement benefit obligations. Although it is not possible to measure the degree of variability inherent in these estimates, management believes that the liabilities reported are adequate. Any adjustment determined to be necessary is reflected in current operations.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims' processor. Amounts due to claims processors that were not reimbursed by the Plan as of June 30, 2025 and 2024 totaled \$629,001 and \$609,610, respectively, and are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

The Plan utilizes CVS Caremark to process all prescription drug claims, UMR to process all other claims incurred and to perform other necessary functions with respect to the general administration of the medical and vision benefits of the Plan and Delta Dental of Wisconsin, Inc. to process all dental claims. The third-party administrators process claims submitted by participants and determine the benefits to be paid based on the provisions of the Plan. Fees paid to these third-party administrators totaled \$888,252 and \$770,317 for the years ended June 30, 2025 and 2024, respectively.

Premiums for stop-loss insurance are included in stop-loss insurance payments in the accompanying statements of changes in net assets available for benefits and are recorded when paid. Stop-loss insurance premiums paid were \$1,327,844 and \$1,339,090 for the years ended June 30, 2025 and 2024, respectively. Stop-loss refunds totaling \$260,856 and \$2,055,716, respectively, have been netted with claims paid in the accompanying statements of changes in net assets for the years ended June 30, 2025 and 2024.

Rebates

Rebates due from the Plan's PMB are recorded when known and earned, with the offset against health and prescription drug benefits. Pharmacy rebates owed to the Plan as of June 30, 2025 and 2024 totaled \$391,401 and \$400,000, respectively, and have been included in receivables in the accompanying statements of net assets available for benefits. Pharmacy rebates totaling \$1,555,367 and \$1,853,909, respectively, have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024.

Subrogation and medical refunds are recorded when received. Subrogation and medical refunds are netted with claims paid in the accompanying statements of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Claims Incurred but Not Reported

Plan obligations at June 30 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Concentrations

The Plan maintains its cash balance in financial institutions, which at times may exceed federally insured limits. As of June 30, 2025 and 2024, the Plan had \$3,522,300 and \$484,191, respectively, deposited in excess of the FDIC insurance limits. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash.

Two colleges accounted for approximately 53% and 48%, respectively, of the Plan's contributions for the years ended June 30, 2025 and 2024.

As of June 30, 2025 and 2024, the Plan had investments that represented more than 10% of net assets of \$5,747,747 and \$5,573,057, respectively, that were concentrated in three and two funds, respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies and procedures utilizing information provided by the investment advisors and the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Postretirement Benefit Obligations

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Colleges and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Colleges.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes at June 30, 2025, the medical trend rate for Ripon was assumed to be 6.10%, decreasing to an ultimate rate of 3.70% in 2074, and the medical trend rate for MSOE was assumed to be 6.10% for pre-Medicare and 5.10% for post-Medicare, both decreasing to an ultimate rate of 3.70% in 2074. For measurement purposes at June 30, 2024, the medical trend rate for Ripon was assumed to be 6.80%, decreasing to an ultimate rate of 3.70% in 2074, and the medical trend rate for MSOE was assumed to be 6.80% for pre-Medicare and 5.20% for post-Medicare, both decreasing to an ultimate rate of 3.70% in 2074.

The health care cost trend assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed healthcare cost trend rates increased by one percentage point for each future year, the obligation as of June 30, 2025 and 2024, would increase by approximately \$384,000 and \$442,000, respectively.

Other significant assumptions used in the valuations as of June 30, 2025 were as follows:

- Weighted average discount rate of 5.50% for both Ripon and MSOE.
- Retirement rates vary by age representative rates, ranging from 2% at ages 55-59, 10% at ages 60-61, 25% at age 62, 15% at ages 63-64 and 100% at age 65+ for Ripon and 20% at age 62, 10% at ages 63-64, 25% at age 65, 20% at ages 66-69 and 100% at age 70+ for MSOE.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Postretirement Benefit Obligations (Continued)

- Mortality table used was the Pri-2012 Projection Scale MP 2021 for both Ripon and MSOE.

Other significant assumptions used in the valuations as of June 30, 2024 were as follows:

- Weighted average discount rate of 5.50% for both Ripon and MSOE.
- Retirement rates vary by age representative rates, ranging from 2% at ages 55-59, 10% at ages 60-61, 25% at age 62, 15% at ages 63-64 and 100% at age 65+ for Ripon and 20% at age 62, 10% at ages 63-64, 25% at age 65, 20% at ages 66-69 and 100% at age 70+ for MSOE.
- Mortality table used was the Pri-2012 Projection Scale MP 2021 for both Ripon and MSOE.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Should the Plan terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postemployment benefit obligations.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,

3. FAIR VALUE MEASUREMENTS (Continued)

Level 2: (Continued)

- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual funds and money market mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market mutual fund held by the Plan are open-ended mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market mutual fund held by the Plan are deemed to be actively traded.

Demand deposit accounts: Valued at the deposit account balances, payable on demand.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. LINE OF CREDIT

As of June 30, 2024, the Plan had a line of credit financing agreement with a bank, under which \$750,000 was available. Interest was payable monthly at the AMERIBOR Term-30 rate (6.869% at June 30, 2024). There was no outstanding balance on the line of credit as of June 30, 2024 and it was closed on January 19, 2025.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Robert W. Baird & Co. and Park Bank, the custodians of the Plan; therefore, these transactions qualify as party-in-interest.

Additionally, certain administrative functions of the Plan are performed by officers or employees of WAICU as described in Note 1.

6. PLAN TERMINATION

Although they have not expressed any intention to do so, the Plan administrator has the right under the Plan to modify the benefits provided to participants and dependents, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, any covered expenses which have been incurred prior to the date of termination will be payable in accordance with the terms and conditions of the Plan. Plan assets will first be allocated to the payment of claims and thereafter in a manner that is for the exclusive benefit of the participants, except that any taxes and administration expenses may be made from the Plan assets.

7. TAX STATUS

The Plan obtained its latest determination letter on November 12, 2004, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) and was tax-exempt under the provisions of Section 501(c)(9) of the IRC as a VEBA. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended subsequent to the date of the Plan's determination letter; however, the plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
