INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
International Longshoremen's Association Local 1969 Retiree Health Fund Plan
Portage, Indiana

Opinion

We have audited the accompanying financial statements of International Longshoremen's Association Local 1969 Retiree Health Fund Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of International Longshoremen's Association Local 1969 Retiree Health Fund Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits and changes in benefit obligations for the years ended December 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of International Longshoremen's Association Local 1969 Retiree Health Fund Plan and to meet our other ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about International Longshoremen's Association Local 1969 Retiree Health Fund Plan to continue as a going concern for the year ended December 31, 2024.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of International Longshoremen's Association Local 1969 Retiree Health Fund Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about International Longshoremen's Association Local 1969 Retiree Health Fund Plan's ability to continue as a going concern for a reasonable period of time.

NOTE A - DESCRIPTION OF PLAN

The following brief description of the International Longshoremen's Association Local 1969 Retiree Health Fund Plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution plan operated under the terms of collective bargaining agreements between the International Longshoremen's Association Local 1969 AFL-CIO (the Sponsor) and participation employers. The Plan is subject to the provisions and regulations of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan provides subsidies for post-employment health benefits to eligible participants when they retire on or after January 1, 2011. Beginning in 2006, every participant who completes 1,000 hours of service in a calendar year shall be eligible to receive a retiree health benefit upon completion of a total of five or more such years, including the initial year of eligibility.

Contributions

The entire cost of the Plan is funded by investment income and by the employers who contribute to the Retiree Health Fund Plan in accordance with their collective bargaining agreements with Local Union 1969. No employee contributions are required or accepted. The effective contribution rate as of December 31, 2024 and 2023 was \$1.50 and \$1.45 respectively per hour of covered employment.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash includes amounts on hand and in financial institutions. For purposes of the statements of cash flows, the Plan considers certificates of deposit with a maturity of three months or less to be cash equivalents.

NOTE C - CONCENTRATION OF CREDIT RISK

The Plan maintains cash balances at JPMorgan Chase Bank which may at times exceed amounts covered by insurance provided by the Federal Deposit Insurance Corporation (FDIC). At December 31, 2024, the Plan's uninsured cash balances totaled \$1,675,116. The Plan has not experienced any losses in such accounts and believed it is not exposed to any significant credit risk to cash.

NOTE D - TERMINATION OF PLAN

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to modify the benefits provided to covered participants, and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement. However, no assets of the Plan shall be used for a purpose other than the benefit of employees, retired employees, and their beneficiaries, the payment of administrative expenses of the Plan, or payments in accordance with any Plan adopted by the trustees.

NOTE E - TAX STATUS

The Plan administrator believes that the trust established by the Plan to hold the Plan's assets is currently designed and being operated in compliance with Section 501(c)(9) of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE F - SUBSEQUENT EVENTS

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
