NOTES TO THE FINANCIAL STATEMENTS

JANUARY 31, 2025 AND 2024

Note 1—Description of Plan

The following description of the CAPREIT Welfare Benefit Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan Agreement for a more detailed description of the Plan's provisions.

General – The Plan is an employee welfare plan that provides group health and death benefits for participating employers, their participating employees, and their participating eligible dependents (collectively, the "Participants") of CAPREIT Construction, LLC; CAPREIT Residential Management, LLC; and CAPREIT Operating Limited Partnership (collectively, the "Employers"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Sponsor and Plan Administrator – CAPREIT Operating Limited Partnership serves as the Plan sponsor and administrator. The Plan sponsor has entered into an agreement with Cigna and the Loomis Company Administrators, health care management companies, to assist the Participants in determining whether proposed services are eligible for reimbursement under the Plan and to serve as the Plan's contract claims administrator. The Plan sponsor has also entered into an agreement with a third party consultant to assist the Participants with questions pertaining to the Plan, eligibility, limitations, and usual and customary charges. The Plan sponsor intends to fund the shortfall, if any, in net assets available for benefits needed to pay the Plan's total benefits obligation as of January 31, 2025 and 2024, and for the year ended January 31, 2025.

Contributions – Benefits under the Plan are funded by the Employers and Participants based on rates determined annually by the Plan's sponsor. The portion of the benefits to be funded by the Participants is based upon contribution rates determined periodically by the Employers.

Plan Benefits – The Plan provides benefits consisting of: (i) a partially self-funded health program providing medical, dental, and prescription benefits; (ii) a premium conversion program designed to enable Participants to pay their portion of the cost of coverage on a pre-tax basis under the Employers' self-insured health program; (iii) a life and accidental death and dismemberment ("AD&D") program; (iv) a long-term disability program; and (v) an organ or tissue transplant program. Current health claims of Participants and their participating eligible dependents are provided under a group stop-loss insurance arrangement, after certain individual and family limits of \$150,000 and aggregate claim limits which are based on an agreed-upon formula with the insurer are met. Death, AD&D, long-term disability, and transplant benefits are covered by group-term policies. Employees are eligible to participate in the Plan if they are regularly scheduled to work a minimum of 30 hours per week in a nonseasonal or contemporary capacity for at least 60 consecutive days.

Participating employees who have terminated employment can elect continued coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA"). Generally, a participating employee's dependents are eligible to be covered under the Plan for medical and dental benefits on the date the employee becomes a participant, except to the extent otherwise provided by the Plan.

Funding Policy – The Employers have voluntarily agreed to make contributions to the Plan which will be sufficient to provide assets to pay benefits to Plan Participants. In addition to Employer contributions, management has formulated a co-pay rate which employees contribute to the Plan via a payroll deduction.

Plan Termination - Although the Employers have not expressed intent to terminate the Plan, they may do so at any time. In the event of Plan termination subject to the provisions of ERISA, the Employers shall be liable for, and have agreed to, provide funds to the extent not provided by the Plan for all Plan benefits, including those that become due prior to termination of the agreement but are not yet paid at the Plan's termination. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the Participants. No assets of the Plan may be reverted to the Employers or be used for purposes other than for the exclusive benefit of the Plan's Participants.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Interest bearing cash – Interest-bearing cash consists of demand deposits held at Truist Bank. Cash balances may exceed the Federal Deposit Insurance Corporation (FDIC) insured limit of \$250,000 per depositor per institution. As of January 31, 2025, the excess uninsured balance of the Plan was \$1,204,345. The Plan monitors the creditworthiness of these institutions and has not experienced any credit losses on its bank accounts.

Payment of benefits – Premiums paid by either the Employers or the Plan trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when the third-party claims processor submits claims for reimbursement. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of benefit obligations.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Stop-loss and Reimbursement from Reinsurer – Premiums for stop-loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Amounts received from the reinsurer under a group stop-loss insurance arrangement are recognized in the period in which the underlying health claims were incurred.

Investment Valuation and Income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date. The Plan administrator determines the Plan's valuation policies and procedures. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Risks and Uncertainties – The Plan invests in an interest-bearing cash account. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

The amount of benefit obligations related to claims incurred but not reported and future health claims payable are reported based on certain assumptions, including claims history and trends in healthcare costs, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Benefit Obligations – The Plan's liability for the estimated health claims incurred but not reported and claims reported but not yet paid at January 31, 2025 and 2024, were determined by the Employers and a third party in accordance with accepted actuarial principles based on claims experience and other pertinent factors.

Administrative Expenses – Expenses incurred in the administration of the Plan are paid by the Plan.

Note 3—Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this standard are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used to value the investments at January 31, 2025 or 2024. Following is a description of the valuation methodology used for assets measured at fair value:

Interest-bearing Cash – Cash held in interest bearing demand deposit accounts are valued at cost, which approximates fair value.

Note 4—Tax status of the Plan

The Internal Revenue Service ("IRS") has determined and informed the Plan sponsor by a letter dated January 22, 1996, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of November 14, 2025, the date the financial statements were available to be issued, required nondiscrimination testing for the year ended January 31, 2025 had not been completed for the Plan. Plan management does not believe that this will have a material impact on the Plan's financial statements and will take appropriate actions, if any are required, to maintain the Plan's qualified tax status. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5—Parties-in-interest transactions

The Employers sponsor the Plan and substantially all employees of the Employers participate in the Plan. A committee of certain employees and members of the Employers serve in an advisory capacity to the Plan. Employers also serve as the trustee of the Plan.
