**1. Description of Plan**

The following description of McEntire Produce, Inc. Profit Sharing & 401(k) Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan which provides retirement benefits to employees of McEntire Produce, Inc. and certain related entities through a participation agreement (collectively, the "Company").

Eligibility to participate in the Plan is based on attainment of age eighteen and completion of six months of service with the Company. Employees may enter the Plan on the first day of the year or the first day of the seventh month upon meeting these requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Amendments**

Effective January 1, 2023, the Plan was amended to calculate safe harbor matching contributions on a Plan year basis instead of per pay period.

**Contributions**

Participants may contribute any percentage greater than or equal to 1% of eligible compensation, as pre-tax or Roth contributions, as defined by the Plan, subject to contribution limitations specified by applicable laws and regulations. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions, up to the maximum annual amount permitted by statute. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans. The Company makes safe harbor matching contributions to each participant's account equal to 100% of the first 3% and 50% of the next 2% of the individual participant's eligible compensation, subject to limitations specified by applicable laws and regulations.

The Company may make non-elective profit sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, no non-elective profit sharing contributions were made by the Company.

**1. Description of Plan (continued)**

**Vesting**

Participants are 100% vested in their participant contributions and employer safe harbor matching contributions, plus actual earnings, thereon, at all times. Vesting in the non-elective profit sharing contribution portion of their accounts is based on years of continuous service. Participants are 20% vested in the non-elective profit sharing contributions at the end of two years of continuous service with additional vesting of 20% for each of the next four years, resulting in 100% vesting after the sixth year.

**Notes Receivable from Participants**

Notes receivable from participants are not permitted under this Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, employer safe harbor matching contributions, non-elective profit sharing contributions, if declared, earnings or losses thereon, and charged with an allocation of administrative expenses paid by the Plan. Participants may elect to allocate current contributions among a variety of investment options.

Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

Upon retirement, disability, death, termination of employment, or attainment of age 59½, participants or their beneficiaries may elect to receive their vested portion of Plan assets in a single distribution or other distribution methods as allowed under the Plan. Upon termination of employment for reasons other than retirement, disability, or death, the participant's vested interest in the Plan will be paid to the participant as soon as administratively feasible upon participant request of a distribution.

Upon termination of service, participants with account balances less than \$5,000, who have not elected a distribution in accordance with Plan provisions, will have their account rolled into an Individual Retirement Account ("IRA") sponsored by Charles Schwab Trust Bank ("Charles Schwab"), the trustee of the Plan, for the benefit of the participant. Participants with balances greater than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or may choose among various installment options provided for by the Plan. Distributions may be made at the participant's election on or after the valuation date following termination of employment.

**Payment of Benefits (continued)**

Hardship distributions are permitted upon determination of financial hardship.

All fully vested balances are available for in-service distributions after the participant reaches age 59 ½.

**Administrative Expenses**

Fees related to the administration of the Plan are charged directly to the participants' accounts and are included in administrative expenses.

**Forfeitures**

Forfeited nonvested accounts may be used to reduce employer contributions or pay administrative expenses of the Plan. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$5,700 and \$7,500, respectively, were used to reduce administrative expenses of the Plan. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

**Plan Termination**

On December 31, 2024, the Company began the process of terminating the Plan, at which time contributions were discontinued and participants became 100% vested in their accounts. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis effective December 31, 2024. The termination process was completed and all plan assets were distributed out of the Plan in August 2025.

**2. Basis of Presentation and Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan holds investments that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits. There were no material valuation changes in investment securities held by the Plan upon changing to the liquidated basis of accounting as of December 31, 2024.

**Payments of Benefits**

Benefits are recorded when paid.

**3. Certified Investments**

Information presented in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, net appreciation in fair value of investments, and interest and dividends was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab.

#### **4. Fair Value Measurements**

The methods used to measure fair value may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair values of certain financial instruments could result in a different fair value measurement at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

All of the Plan's mutual fund and money market investments were valued using Level 1 inputs, based on quoted market prices of the shares held by the Plan. The Plan's mutual funds totaled approximately \$7,179,000 and \$6,824,000 as of December 31, 2024 and 2023, respectively. The Plan's balance in its money market fund totaled approximately \$135,000 and \$230,000 as of December 31, 2024 and 2023, respectively.

The Plan invests in a MetLife Guaranteed Annuity Contract, which is a collective trust fund that invests in a variety of fully benefit-responsive investment contracts. The collective trust fund is valued at the net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the account provider reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner. The Plan's investment in the collective trust fund totaled approximately \$357,000 and \$315,000 as of December 31, 2024 and 2023, respectively.

#### **5. Party-in-Interest Transactions**

All of the Plan's investments were held and managed by Charles Schwab as of and for the years ended December 31, 2024 and 2023. Fees paid by the Plan for these services amounted to approximately \$49,000 and \$58,000 during the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**6. Income Tax Status**

The Plan is a non-standardized pre-approved profit sharing, money purchase, cash or deferred arrangement plan, provided by TD Ameritrade Trust Company (a subsidiary of Charles Schwab), designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Internal Revenue Service ("IRS") has determined and informed TD Ameritrade Trust Company by a letter date June 30, 2020, that the pre-approved profit sharing, money purchase, cash or deferred arrangement plan, as then designed was in accordance with applicable sections of the IRC.

Although the Plan has been amended and restated since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. During 2024, operational errors were discovered related to the calculation of employer match. As of the date the financial statements were available to be issued, management has not quantified the impact on the Plan's 2024 financial statements but does not believe the impact is material. Management does not believe these operational errors will have an impact on the Plan's tax status.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**7. Subsequent Events**

Management has evaluated events and transactions after December 31, 2024 through November 13, 2025, the date the financial statements were available to be issued, for subsequent events. Other than completion of the Plan's termination process and liquidation of the remaining Plan assets discussed in Note 1, no subsequent events were identified.
