**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of 401(k) Profit Sharing Plan for Employees of Community Action Corporation of South Texas (CACOST), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended January 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CACOST's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended January 31, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

**Basis for Opinion**

NOTE A -- DESCRIPTION OF PLAN

The following description of the 401(k) Profit Sharing Plan for Employees of Community Action Corporation of South Texas provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of the Company who have one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to 100% or \$23,000 whichever is less, of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Generally, the maximum contribution amount may then be indexed for inflation increments in subsequent years. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes 3% of the participants' compensation to the plan. Additional amounts may be contributed at the option of the Company's board of directors to be allocated in proportion to the compensation of those participants eligible to share in the allocations. The Plan is limited on combined employee/employer contributions as defined by Internal Revenue Code.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charges with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Eligibility Requirements: To enroll in the Plan, employees must meet the following criteria:

- Age 18 or older
- Completed 1,000 hours of service within the twelve-month time period following the employee's employment commencement date.
- Eligible employees may enroll the first day of each month.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service.

A participant is 100% vested after five years of credited service, vesting as follows:

Years of Vesting Service	Vesting Percentage
Less than 2 years	0%
2 years	25%
3 years	50%
4 years	75%
5 years or more	100%

Notes Receivable from Participants: Participants may borrow the lesser of \$50,000 or 50% from their total vested account balance. The minimum loan amount is \$1,000 and a participant has up to 5 years to re-pay the balance. Loans made for the purchase of their primary residence may be for a longer term. The loans are secured by the balance in the participant's account and bears interest, which is commensurate with local prevailing rates as determine quarterly by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reason, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts: At January 31, 2025 and 2024, forfeitures applied to reduce current employer contributions were \$39,508 and \$45,827, respectively. The closing balance of unused forfeitures at January 31, 2025 was \$39,373 and is included in plan investments.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review: Subsequent events were evaluated through November 13, 2025, which is the date of the financial statements were available to be issued.

Basis of Accounting: The financial statements of the plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Fully Benefit-Responsive Investment Contract: The interest accumulation account is a cash equivalent account and not included in the fair value measurements.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Participant Loans: Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for doubtful accounts is reported. All loan balances are secured by employee vested balance. No past due balances. Interest income is recorded on the accrued basis. Delinquent participant loans are recorded as a distribution based on the terms of the plan.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Except for loan origination fees associated with notes receivable from participants, administrative expenses of maintaining the plan are paid by the Plan.

NOTE D -- FAIR VALUE MEASUREMENTS

The following information, included in the accompanying financial statements and supplemental schedule, was obtained from data that has been prepared and certified as complete and accurate by the custodian.

Mutual of America values its investments at fair value in accordance with U.S. generally accepted accounting principles. Fair value is an estimate of the price the Separate Account would receive upon selling a security in an orderly, arms-length transaction (i.e., a transaction among parties, each of whom acts in his or her own best interest). The pricing information measured by quoted market prices in an active market by two independent subservice organizations used to provide pricing information.

Investments are categorized based on a three-level valuation hierarchy for measurement and disclosure of fair value.

The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 - Asset value is based on actual quoted prices active markets for identical securities (market-to-market)

Level 2 - Other significant observable input is used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.)

Level 3 - Significant unobservable inputs (including the Fund's own assumptions in determining the fair value of investments)

Mutual of America determined that the fair value inputs for all the Separate Account investments as of January 31, 2025 are considered Level 1. Separate Account investments consist solely of investments in mutual funds registered with the Security and Exchange Commission and is carried at the net asset value at which the mutual fund shares are actively traded. Please note that the inputs used for valuing securities are not an indication of the risk associated with investing in those securities.

NOTE E -- PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F -- INCOME TAX STATUS OF THE PLAN

The Internal Revenue Service has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC), by the letter dated November 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE G -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.
