Opinion

Notes to Financial Statements

NOTE 1 - PLAN DESCRIPTION

The following description of Koury Corporation Employee Health and Welfare Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established February 1, 1987, provides health benefits, dental benefits, short- and long-term disability insurance, and life and accidental death insurance covering substantially all employees of Koury Corporation (the "Corporation"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). Koury Corporation is the Plan Sponsor.

Benefits and Eligibility

The Plan provides benefits (hospital, surgical, dental, medical, short- and long-term disability), prescription drug coverage and life and accidental death insurance to employees who work a minimum of 30 hours per week and have been employed by the Corporation for the respective waiting period (90 days for medical benefits, two months for dental benefits, and six months for life and accidental death and disability). The Plan has optional coverage for dependents of qualifying employees. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act.

Contributions

The Corporation offers employees the choice of a high deductible, standard, or premium plan. The plan document provides the following employee and employer contribution scale for medical coverage:

Contributions (Continued)

Dependent dental coverage is paid by employees. The plan document offers both short- and long-term disability insurance coverage to all eligible employees. Short- and long-term disability insurance premiums are paid by all employee classes with the exception of the executive class, which is 100% employer paid. The plan document also provides 100% employer contributions for qualifying employees in all classes for life and accidental death insurance. Vision insurance is also offered at the employee's expense for employee, spouse, dependent, or family coverage. Coverage rates are determined annually.

Claims-Paying Agents

Medical insurance claims are processed and paid by the third-party administrator, United Medical Resources, Inc. Life insurance claims and short- and long-term disability insurance coverage were processed and paid by the insurer Unum Group ("Unum"). Dental claims were processed and paid by the third-party insurer, Sun Life Financial ("Sun Life").

Insurance Premiums

The Plan purchased short- and long-term disability insurance as well as life insurance from Unum. The Corporation is self-insured for health benefits with a stop loss of \$85,000 per individual, an aggregating specific deductible of \$160,000, and a \$1,000,000 maximum aggregate benefit. Sun Life Assurance Company of Canada is the Plan's stop-loss carrier. The Plan was fully insured for dental insurance through Sun Life. It is the present intention of the Corporation and the Plan to continue obtaining such insurance coverage.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Sponsor's management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, benefit obligations and changes therein, health claims payable and claims incurred but not reported, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claim payments are recorded when paid. Amounts due to claims processors that have yet to be reimbursed by the Plan are included in accounts payable in the accompanying statements of benefit obligations and net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Stop-Loss

Premiums for stop-loss insurance are included in insurance premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits. Stop loss refunds totaling \$5,127,300 and \$595,170 for the years ended January 31, 2025 and 2024, respectively, have been included in health claims reimbursement in the accompanying statement of changes in benefits obligations and net assets available for benefits.

Expenses

The Plan has absorbed administrative fees relating to its claims-paying agents. The Corporation has absorbed all other costs, including internal administrative costs.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through November 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Corporation has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 4 - TAX STATUS

The Plan is intended to qualify as an employee welfare benefit plan as defined in ERISA. The Plan benefits are funded out of the general assets of the Corporation and employee contributions.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of January 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 5 - HEALTH CLAIMS PAYABLE AND CLAIMS INCURRED BUT NOT REPORTED

Plan benefit obligations at January 31, 2025 and 2024, for health claims payable and claims incurred but not reported are estimated by the Plan Sponsor's management based on data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payments.

NOTE 6 - RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Koury Corporation is the Plan Sponsor; therefore, transactions with the sponsor qualify as parties-in-interest transactions. Certain administrative functions are performed by officers or employees of the Corporation. No such officer or employee receives compensation from the Plan. The Corporation provided contributions to the Plan to fund costs in excess of the related participant contributions and paid certain administrative expenses of the Plan.

NOTE 7 - CONCENTRATIONS OF CREDIT RISK

The Plan maintains cash in financial institutions insured by the Federal Deposit Insurance Corporation. These accounts, at times, may exceed federally insured limits. Financial instruments that potentially subject the Plan to concentration of credit risk consist principally of cash deposits.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's benefit obligations, health claims payable, and claims incurred but not reported are reported based on certain assumptions, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
