Opinion

We have audited the accompanying financial statements of SRC Benefits Programs Trust Health Insurance Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and the statements of benefit obligations as of January 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and the statements of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of the SRC Benefits Programs Trust Health Insurance Fund (the Plan) sponsored by SRC Holdings Corporation (the Company) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Company established a self-funded insurance program in the form of a Voluntary Employee Benefit Association (VEBA) trust on February 1, 1994 to care for and distribute contributed funds to the plan participants and their beneficiaries. The Plan provides eligible participants and their qualifying dependents with health, dental, vision, life, accidental death and dismemberment, and disability benefits as determined by the Plan and the various insurance policies in effect. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: An employee is considered to be eligible if on the regular payroll of the Company or one of the following subsidiaries (the Employer): Springfield Remanufacturing Corp., The Great Game of Business, Inc., Southwest Missouri Investments, Inc., Remanufacturing Sales Company, SRC Logistics, Inc., SRC Logistics – Illinois, Inc., SRC Automotive, Inc., and Global Recovery Corp. The employee must normally work at least 30 hours per week, be in a class eligible for coverage, and complete the applicable employment waiting period. A family member of an employee will become eligible for dependent coverage on the first day that the employee is eligible for coverage.

Contributions: The VEBA is funded by contributions from both the Employer and participants. Employer contributions are discretionary based on the funding needs of the Plan. To the extent assets in the VEBA are not sufficient to fund such health benefits, such benefits shall be contributed by the Employer. In addition to the deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Employer pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance.

Benefits: The Plan provides medical, dental, vision, life, accidental death and dismemberment and disability benefits for all eligible participants and their qualifying dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only arrangements. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan's trust or the general assets of the Employer. This processor is considered a party-in interest under ERISA. Despite the utilization of the third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Reinsurance agreements: The Plan has entered into a stop-loss reinsurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting. Plan assets can be used only for the payment of benefits and related costs and are not the assets of the Employer.

Other plan obligations: The assumptions used to determine the amount of outstanding claims for medical and dental benefits subject to self-funding are based on claims filed by Plan participants, past processing experience of filed claims and the number of individuals enrolled in the Plan as well as industry data.

Use of estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Parties-in-interest: Certain employees of the Company serve as the Plan's trustees. The trustees do not receive any compensation for services rendered to the Plan. Audit fees are paid by the Company.

Payment of benefits: Premiums paid by either the Employer or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as accounts payable in the accompanying statements of net assets available for benefits.

Refunds: Refunds due from the Plan's PBM are recorded when received. Rebates totaling \$318,870 and \$321,238 have been netted with benefit claims paid in the accompanying statements of changes in net assets available for benefits for the years ended January 31, 2025 and 2024, respectively.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and November 14, 2025, the date the financial statements were available to be issued.

3. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, all claims incurred as of the termination date will be paid. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

5. Claims Incurred but Not Reported

Health claims payable at January 31, 2025 and 2024 represent claims incurred during the year, but paid and reported in the following year. At January 31, 2025, the Plan had outstanding claims payable of \$1,479,524 with reinsurance receivable related to these outstanding claims of \$101,291, resulting in net health claims payable in the amount of \$1,378,233. At January 31, 2024, the Plan had outstanding claims payable of \$2,102,215 with reinsurance receivable related to these outstanding claims of \$806,195, resulting in net health claims payable in the amount of \$1,296,020. These amounts are included in the statements of benefit obligations as of January 31, 2025 and 2024, respectively. The Plan's total benefit obligation at January 31, 2025 and 2024 is estimated by the Plan's actuary in accordance with actuarial principles based on claims provided by the Plan's third-party claims administrators. Claims incurred but not reported are paid by the Plan only if claims are submitted and approved for payment.

6. Tax Status

The Internal Revenue Service has determined that the Plan meets the requirements of Section 501(a) of the Internal Revenue Code and is exempt from Federal income tax under Sections 501(c)(9) of the Code. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service dated October 4, 1995. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Reinsurance Agreements

The Plan has purchased excess loss reinsurance coverage from an unrelated insurer for individual claims in excess of specific deductibles for the years ended January 31, 2025 and 2024. Premiums paid for such coverage are expensed ratably over the policy period. To the extent the reinsurer is unable to meet obligations under the agreement, the Plan remains contingently liable. The specific deductible for excess loss reinsurance was \$160,000 for the years ended January 31, 2025 and 2024.

8. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and the actuary. These expenses are reported on the statements of changes in net assets available for benefits as contract administrator fees, commissions, and other member benefits. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.
