Opinion on the 2025 Financial Statements

We have audited the accompanying financial statements of Rivermark Community Credit Union Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of January 1, 2025, and the related statement of changes in net assets available for benefits for the period then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Rivermark Community Credit Union Retirement Savings Plan, as of January 1, 2025, and the changes in its net assets available for benefits for the period then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2025 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2025 Financial Statements section of our report. We are required to be independent of Rivermark Community Credit Union Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the 2025 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rivermark Community Credit Union Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Plan Description

The following description of Rivermark Community Credit Union Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2022.

General

The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Rivermark Community Credit Union and is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Rivermark Community Credit Union (the Credit Union) is the Plan's sponsor and serves as Plan Administrator.

Plan Year

The Plan period ended January 1, 2025 was a single day Plan year, reflecting the effective date of the merger and transfer of assets to the Advantis Credit Union 401(k) Plan. For the year ended December 31, 2024, the Plan year was a regular, full calendar-year Plan year.

Eligibility

All employees of the Credit Union were eligible to participate in the Plan on the first of the month following three months of employment and upon reaching age 18, except for temporary employees who must attain the age of 18 and work 1,000 hours in a 12-month period to be eligible to participate in the Plan. Once eligibility was met, the employee was able to enter the Plan on the first day of the following month. Eligibility for employer Safe Harbor, matching, and non-elective contributions requires one year of service during which 1,000 hours are worked and attaining age 18.

Contributions

Participants were able to elect annually to contribute, on a pre-tax basis or a post-tax basis designated as Roth Elective Deferrals, up to 60 percent of their annual compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Participants were also able to contribute rollover amounts, representing distributions from other qualified plans. These contributions are fully vested at all times. Individuals who attain age 50 by the end of the Plan year may make additional pre-tax "catch-up" contributions. The Credit Union has an Automatic Contribution Arrangement (ACA). When eligible, a participant was automatically enrolled to defer 2 percent of eligible compensation, unless the participant affirmatively declined to participate. After two years, deferrals would automatically increase by 2 percent each year until a maximum of 4 percent under the arrangement.

Employer Safe Harbor match contributions – The Credit Union matches 100 percent of the first 4 percent of eligible compensation deferred. For the year ended December 31, 2024, the employer Safe Harbor matching contribution totaled \$753,824.

Employer discretionary profit sharing and match contributions – The Credit Union may elect to make discretionary profit sharing or additional discretionary matching contributions to the Plan. There were no additional discretionary match contributions for the year ended December 31, 2024.

As a result of the merger of the Plan, effective January 1, 2025, all contributions are made to the Advantis Credit Union 401(k) Plan and therefore no contributions are recorded for the period ended January 1, 2025.

1. Plan Description, continued

Participant Accounts

Each participant's account is credited with the participant's contribution and the Credit Union match contributions and allocations of (a) the Credit Union's profit sharing contribution, if any; and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their salary deferrals and employer Safe Harbor contributions plus actual earnings thereon. Vesting in Credit Union discretionary matching and profit sharing contributions is based on years of service which begins after two years of service at 20 percent. Thereafter, employees are 40 percent vested after the third year, 70 percent vested after the fourth year, and 100 percent vested upon five years of service. Upon termination of employment due to death, total disability, attainment of normal retirement age, or early retirement (with five year of service), an employee becomes 100 percent vested as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are secured by the balance of the participant's account and bear interest at a rate of 2 percent above the prime rate at origination. The maximum loan term is five years unless the loan term qualifies as a home loan, in which case the term of the loan is not to exceed ten years. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024 the rates of interest on the outstanding loans ranged from 5.25 percent - 10.50 percent with various maturities through June 2031.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or their designated beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or in installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Withdrawals from full vested accounts may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan Document. In-service withdrawals are permitted from fully vested accounts once the participant has reached 59½ years of age.

Forfeited Accounts

The non-vested account of a participant shall be forfeited if a participant is terminated. These accounts are used to pay Plan expenses and future Credit Union contributions. During the year ended December 31, 2024, forfeitures were \$28,858. During the year ended December 31, 2024, forfeitures used to offset Credit Union contributions were \$35,184. At December 31, 2024, the unused balances in the forfeiture account was \$20,274, which was transferred to the Advantis Credit Union 401(k) Plan effective January 1, 2025.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The investments are reported at fair value and contract value.

Fair value is the price that would be received to sell an asset or pair to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive interest contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 1, 2025 or December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Certain expenses of administering the Plan are paid directly by the Credit Union and are therefore excluded from these financial statements. Certain other administrative and participant transaction fees are paid by the Plan directly from participant accounts. Investment-related expenses are included as a reduction from net change in the fair value of investments.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited monthly based on a fixed percentage, which is used to pay investment advisory expenses. For the year ended December 31, 2024, \$44,899 of revenue sharing was credited to the account and used to pay investment advisory expenses. Investment expenses in the accompanying statement are stated net of this amount. There was no ending balance in the Plan's revenue sharing account as of December 31, 2024. There was no revenue sharing activity or ending revenue sharing balance for the period ended January 1, 2025.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. The fair value hierarchy is determined by the Plan at December 31 of each Plan year. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Collective trust – Units held in the collective trust (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments measured at fair value as of January 1, 2025. The following table set forth by level, within the fair value hierarchy, the Plan's investments carried at fair value as of December 31, 2024:

4. Contract with Empower Annuity Insurance Company of America

In 2012, the Plan entered into a fully benefit-responsive guaranteed annuity contract under a group fixed deferred annuity contract with Empower Annuity Insurance Company of America, the Key Guaranteed Portfolio Fund. Empower Annuity Insurance Company of America maintains the contributions in their general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Empower Annuity Insurance Company of America but may not be less than 0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The group annuity contract does not permit Empower Annuity Insurance Company of America to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit responsive investment contract (FBRIC) criteria and therefore is reported at contract value. Contract value is the relevant measure for the FBRIC because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemptions from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

5. Tax Status

The Plan document is a defined contribution prototype plan, sponsored by Empower Retirement, LLC, that received a favorable opinion letter from the Internal Revenue Service on November 14, 2022, which stated that the Plan, as then designed, was acceptable for use by employers for use by employers for the benefit of their employees with respect to the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan Administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Information Certified by the Custodian and Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the year ended December 31, 2024. This election was not made for the period ended January 1, 2025. Accordingly, Empower Annuity Insurance Company of America, the custodian of the Plan, and Empower Trust Company, LLC, the trustee of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from the participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024.
- Net appreciation in fair value of registered investment companies, dividends, interest from guaranteed annuity contract, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

8. Related Party and Party-in-Interest Transactions

Certain Plan investments are maintained and managed by Empower Insurance Annuity Company, an affiliate of the Trustee. The Plan's investments are also managed by Empower Advisory Group, LLC, an affiliate of the Trustee. Empower is the fiduciary and the trustee of the Plan. Total fees for administration paid to Empower for the year ended December 31, 2024 were \$46,774. There were no fees paid to Empower for the period ended January 1, 2025. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Plan Termination and Merger

The Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become 100 percent vested in their accounts.

In connection with the merger of the Plan Sponsors, the Plan has executed documents in November 2024 to merge the Plan effective January 1, 2025 into the Advantis Credit Union 401(k) Plan. Upon merger, until Participants are 100 percent vested under the Advantis Credit Union 401(k) Plan, Participants will be vested based on credited years of service earned under the Plan. Substantially all assets, excluding insurance contracts with transfer restrictions, were transferred from Empower (the Plan's custodian) to Standard Insurance Company (the Advantis Credit Union 401(k) Plan custodian) on January 7, 2025.

10. Reconciliation to Form 5500
