## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ASK Chemicals, LP 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution retirement plan with salary reduction features established for all eligible employees of ASK Chemicals, LP and its affiliates, and ASK Chemicals Hi-Tech, LLC (collectively, "the Sponsor"). The Plan was established effective February 1, 2009 and is subject to the provisions of ERISA.

Effective February 1, 2019, the Plan was amended to include an automatic deferral contribution arrangement of 4% of eligible compensation unless a Participant makes an affirmative election to opt-out or elect a different deferral rate as of that date. The Sponsor provides safe harbor matching contributions equal to 100% of the first 4% of participant compensation contributed to the Plan.

**Administration:** The Plan is administered by Pentegra Retirement Services (Pentegra) for the period October 1, 2024 through December 31, 2024 and by Actuarial Consulting Services, Inc. (ACSI) for the year ending December 31, 2023 and for the period January 1, 2024 through September 30, 2024. The Investment Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors performance, and reports to the Board of Directors. The assets of the Plan are maintained in investment funds held by ADP Trust Company (ADP) for the period of October 1, 2024 through December 31, 2024 and Voya Retirement Insurance and Annuity Company (Voya) for the year ending December 31, 2023 and for the period January 1, 2024 through September 30, 2024, the trustees and custodians.

**Contributions:** Each year, participants may contribute up to 90% of annual pre-tax compensation or Roth contributions, as defined in the Plan, provided total additions to the account of the participating employees for any plan year shall not exceed the amount permitted by Internal Revenue Service (IRS) regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct contributions into various investment options offered by ADP. Participants may also contribute amounts representing distributions from other qualified plans.

In addition, the Plan allows for fixed percentage employer contributions to be made by the Sponsor based on a participant's years of service. The Sponsor contributes a percentage of the participant's eligible wages in accordance with the following table:

Less than 11 years of service	1.5%
At least 11 years of service, but less than 21	3.0%
21 or more years of service	4.5%

The Plan also allows for discretionary non-elective employer profit sharing contributions, determined by the Sponsor, and allocates them to participants based on eligible compensation. In 2024, the Sponsor made discretionary contributions of 1.91% of eligible compensation to participants employed by the Sponsor at the end of the year (1.60% - 2023).

**Participant Accounts:** Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions, the Sponsor's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Sponsor's fixed percentage and discretionary employer contribution portion of participant accounts is based on years of continuous service. A participant is 20% vested per year and 100% vested after 5 years of credited service. All employees hired prior to January 1, 2011 are not subject to this vesting schedule and are considered 100% vested in both fixed percentage and discretionary employer contributions.

#### NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Notes Receivable from Participants:** Participants may borrow from their fund accounts amounts equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. Participants may not have more than two loans outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at a rate 1% above the prime rate. Principal and interest is paid ratably, generally through regular payroll deductions.

**Payment of Benefits:** On termination of service due to death, disability, hardship, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows participants to withdraw from their individual accounts upon or after attaining the age 59½.

**Forfeited Accounts:** Forfeitures of employer contributions that are not vested in participants' account balances because of participant termination are used to reduce qualified administrative expenses of the Plan or reduce future employer contributions. Forfeitures remaining in the Plan at December 31, 2024 amounted to \$222,183 (\$110,069 - 2023).

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits:** Benefits are recorded when paid.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation on investments.

**Subsequent Events:** The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

#### NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** These investments are public investment vehicles valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

**Pooled separate accounts:** The separate accounts are stated at fair value based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value (NAV), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares. The net asset value is used as a practical expedient to determine fair value for these accounts.

#### NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 6. TAX STATUS

Effective October 1, 2024, the Plan adopted a non-standardized form of a prototype plan sponsored by ACSI. The prototype plan has received an opinion letter, from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended after this date, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in process.

#### NOTE 7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 8. FINANCIAL CERTIFICATION

#### NOTE 9. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a Fixed Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. For each calendar year, a minimum guaranteed annual interest rate is set which will apply to amounts held in the Fixed Account during the calendar year. The crediting rate is based on a formula established by the contract issuer and may not be less than 1%. Interest is credited daily to all amounts held in the Fixed Account. Lincoln, in its discretion, may credit interest at a rate greater than this one-year rate. Lincoln will make available to the Contract Holder the rate currently being credited to amounts held in the Fixed Account.

The guaranteed investment contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.
