INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Rich Logistics 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rich Logistics 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rich Logistics 401(k) Plan's financial statements performed in accordance with the ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rich Logistics 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1: Description of Plan

The following description of the Rich Logistics 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan and Trust Agreement for more complete information.

General

The Plan is a defined contribution plan which was adopted effective September 15, 2020 by the plan sponsor, Rich Logistics, Inc. (the “Employer”). The Plan covers all employees of the Employer who are age eighteen or older and who have completed sixty days of service. After satisfying the age and service requirements, employees will be eligible to participate in the 401(k) employee deferral contributions and the Employer contributions on the first day of the first month following the satisfaction of the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute a portion of their compensation to the Plan each year not to exceed the limit set by the Internal Revenue Code, which was \$23,000 in 2024 and \$22,500 in 2023. Employees are automatically enrolled in the Plan upon meeting age and service requirements with employee deferral contributions starting at 3% of compensation, unless the employee elects a different deferral percentage or opts out. The automatic elective deferral contribution shall increase by 1% as soon as administratively feasible on or after each subsequent January 1 up to a maximum automatic elective deferral of 10%. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions of up to an additional \$7,500 in 2024 and 2023, respectively. The Plan also permits participant rollover contributions from other qualified retirement plans and a percentage of compensation as a Roth 401(k) deferral. Compensation is defined as total compensation paid to the employee by the Employer that is subject to income tax withholding, including any salary reduction contributions and excluding any expense repayments or other allowances, fringe benefits, moving expenses, deferred compensation and welfare benefits.

The Employer made a discretionary matching contribution equal to 50% of the participant’s elective deferrals up to 6% of the employee’s compensation in 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s 401(k) contribution and allocations of the Employer’s matching contribution plus earnings or losses thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants’ accounts will also be charged with an allocation of the Plan’s administrative expenses. Allocations are based on participants’ earnings or account balances, as defined in the Plan agreement.

Vesting

Participants are immediately vested in their contributions and any earnings thereon. Vesting in the portion of their account attributable to the Employer’s discretionary matching contributions is based on each participant’s years of service. Participants are 100% vested after three years of service based on a graduated vesting schedule. A participant will also become fully vested upon death, disability, or retirement at age 65 or older.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Loan terms range from one year to five years. Participants are limited to one loan at any time. The loans are secured by the vested balance in the participant's account. The interest rate is based on the rates available for similar loans from commercial lending institutions. Principal and interest are paid through payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive payments of his or her vested account in a lump-sum distribution or direct transfer to an eligible retirement plan. Participants are entitled to receive in-service distributions of all or any portion of their fully vested account balances upon the attainment of age 59 ½. Upon proof to the Plan administrator of an immediate financial need permitted by the Plan documents, a portion of any fully vested account balance may be withdrawn for a hardship purpose. Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Investment Options

Participants may direct their accounts among various investment options offered by the Plan and may change their investment options at any time. The Plan currently offers 16 mutual funds, 3 pooled separate accounts, 12 common collective trusts, and a guaranteed investment contract as investment options for participants.

Plan Termination

Although it has not expressed the intent to do so, the Employer has the right under this Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested with respect to the employer contribution portion of their accounts. Employee contributions and their related earnings are always 100% vested.

Forfeitures

The portion of a participant's account to which they are not entitled upon termination of participation is deemed a forfeiture. The Plan document allows the Plan to use forfeited balances first to pay plan expenses, with any remaining amounts used to reduce employer contributions. If any forfeitures still remain, such forfeitures may be reallocated to participants accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$126,097 and \$85,664, respectively. During 2024 and 2023, the employer matching contribution was reduced by \$77,662 and \$51,736, respectively, from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues and expenses, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred.

In accordance with accounting principles generally accepted in the United States of America, investment contracts held by a defined-contribution plan are required to be reported at fair value. However contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants should receive if they were to initiate permitted transactions under the term of the plan.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan administrators to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The Plan Administrator's most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated all subsequent events for potential recognition and disclosure through November 13, 2025, the date these financial statements were available to be issued.

Note 3: Plan Tax Status

The IRS has determined and informed the Employer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 4: Fair Value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following section describes the valuation methodologies the Plan uses to measure financial instruments at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued based on the underlying investments, (i.e. money market funds, common stock, mutual funds, short term securities). While the majority of the underlying asset values are based on quoted prices, the net asset value (NAV) of the pooled separate account is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. The use of NAV as fair value is deemed appropriate as the PSA does not have a finite life, unfunded commitments related to this type of investment or significant restrictions on redemption.

Common Collective Trusts (CCT): Valued at the NAV per unit as of the close of business on the valuation date. The CCT accounts are valued using the NAV as a practical expedient, which represents the price at which the CCT is able to initiate a transaction. The CCT may be redeemed as of any valuation date. The Trustee may elect withdrawals in cash, ratably in-kind, a combination of cash and ratably in-kind, or in any other manner the Trustee determines to be appropriate.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net change in fair value of investments. The Plan's investments (including realized gains and losses on investments bought, sold, and held during the year as well as unrealized appreciation (depreciation) of the investments held at the end of the year) appreciated in value by \$498,001 and \$573,607 in 2024 and 2023, respectively.

Note 5: Fully Benefit-Responsive Investment Contracts

In September 2020, the Plan entered into a traditional fully benefit-responsive investment contract with Principal Life Insurance Company ("Principal") totaling \$24,674 and \$85,867 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

The contract meets the traditional fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA
2. Premature termination of the contract
3. Amendments to the Plan document (including complete or partial Plan termination or merger with another plan)
4. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions
5. Bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

Note 6: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any persons who provide services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employee association or relatives of such persons and the Plan Employer.

Certain Plan investments are shares of mutual funds, pooled separate accounts, common collective trusts, and guaranteed investment contract managed by the Principal Life Insurance Company and Principal Trust Company who are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Employer and custodians are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid directly to the custodians \$70,382 and \$62,435 for their services during 2024 and 2023, respectively. The transactions are exempt from being prohibited transactions under ERISA.

Note 7: Information Prepared and Certified by Custodians

The Plan's investments and notes receivables from participants were held by the Principal Life Insurance Company and Principal Trust Company, the custodians. The amounts set forth in the accompanying financial statements for investments and investment income, notes receivables from participants and the information shown in the supplemental schedules were summarized from information furnished by the custodians. The Plan administrator received from the custodians certification that information furnished by the custodians is complete and accurate for the years ending December 31, 2024 and 2023, respectively. As permitted by 29 CFR 252.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the information certified as complete and accurate by the custodians was not subjected to any audit procedures except for comparing the information with the related information included in the financial statements and supplemental schedules.

Note 8: Reconciliation with Form 5500

Certain amounts reported in the Plan's annual Form 5500 for changes in net assets available for benefits are different from the amount reported in the accompanying financial statements. These differences are due to these financial statements being reported on the accrual basis of accounting and the Form 5500 being reported on the cash basis of accounting.

Note 9: Delinquent Participant Contributions

During the year ending December 31, 2024, the Employer failed to remit certain employee deferrals and loan payments to the Plan aggregating \$18,845 in a timely manner according to DOL regulations.
