#### (1) Description of Plan

The following description of the American Asphalt Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan originally effective January 1, 1999, covering substantially all employees of American Asphalt Company, Inc., American Blacktop Co., LLC, American Paving Materials Co., LLC, Mainstreet Properties, LLC, American Bituminous Co, Inc., and Tri-State Asphalt, LLC (collectively, the Company). The Plan has been restated effective September 1, 2021. The Plan excludes union employees, leased employees, nonresident aliens, and employees hired on a temporary or seasonal basis. Eligible employees can begin participation in the plan after two months of service and attaining age 21. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for the oversight of the Plan. They also determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Plan's Board of Directors.

Effective January 21, 2025, in connection with the acquisition of the Company, the assets of the Plan were transferred to The Earle Operating Holding Company, Inc. 401(k) Profit Sharing Plan.

##### *Contributions*

Each year, participants may contribute a portion of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also make contributions to the Plan on an after-tax (Roth) basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

The Company may, at its discretion, elect to make a qualified matching contribution to the Plan. Participants are eligible for discretionary contributions after completion of 1,000 hours of service and must be employed on the last day of the plan year. For the year ended December 31, 2024, the Company elected to match 20% of the first 6% of eligible compensation that a participant contributed to the Plan. There was no Company match for the period ended January 21, 2025. Employees of the Company are eligible for prevailing wage contributions as described under the Davis-Bacon Act. There were no Company prevailing wage contributions for the period ended January 21, 2025.

#### (1) Description of Plan, Continued

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company contributions, as well as plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their contributions and the Company's prevailing wage contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts, plus earnings thereon, is based on years of continuous service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death or permanent disability. Vesting in both the Company's discretionary and profit-sharing contribution and earnings thereon is as follows:

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participants' accounts and bear interest at rates commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions. Loan terms shall not exceed five years, with the exception of a loan for the purpose of purchasing a primary residence.

##### *Payment of Benefits*

Upon termination of service due to death, disability or retirement, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### (1) Description of Plan, Continued

##### *Forfeited Accounts*

As of January 21, 2025 and December 31, 2024, forfeited non-vested accounts totaled \$0 and \$4,275. These accounts may be used to pay plan expenses and to reduce future employer contributions. During 2025, the forfeiture balance was included as part of the asset transfer.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the loan is deemed to be in default per the terms of the plan document, the participant loan balance is reduced and a benefit payment is recorded.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments. Participants pay an annual fee for administrative costs associated with the recordkeeping and trustee fees, as well as transaction charges for loan and benefit payment transactions which are paid by the Plan by reducing the balances of those participants initiating the transactions.

##### *Subsequent Events*

The Plan has evaluated subsequent events through November 13, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at January 21, 2025 and December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2025 through January 21, 2025, was obtained by management and agreed to or derived from the information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosure*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 21, 2025 and December 31, 2024.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. Registered investment companies are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

*Collective investment fund:* Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### (5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies, a pooled separate account and a collective investment fund managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments.

#### (6) Plan Termination

Effective January 21, 2025, in connection with the acquisition of the Company, the assets of the Plan were transferred to The Earle Operating Holding Company, Inc. 401(k) Profit Sharing Plan.

#### (7) Tax Status

The Plan uses a prototype plan document sponsored by Principal Life Insurance Company. The IRS has determined and informed Principal Life Insurance Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
