The financial statements comprise the statements of net assets available for benefits as of December 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2024 and 2023, stating that the certified investment information, as described in Note (2) to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

(1) Plan description and summary of significant accounting policies:

(a) Plan description:

The following description of GFR Media, LLC Retirement Savings Plan for Union Employees (“the Plan”) provides only general information. Participants should refer to the Summary Plan Description or the Plan Document for a more complete description of the Plan’s provisions and amendments.

i. General -

The Plan is a defined contribution plan that covers all union employees of GFR Media, LLC (formerly known as El Día, Inc. and as successor sponsor for the employees of El Día, Inc. and Editorial Primera Hora, Inc.) (“the Plan Sponsor”). Union employees with at least 90 days of service and 18 years of age are eligible to participate in the Plan.

The Plan qualifies under Section 1081 of the Internal Revenue Code for a New Puerto Rico (“IRC-NPR”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of December 30, 2024, and 2023, there were 258 and 298 participants, respectively, with account balances in the Plan.

ii. Contributions -

Each year, participants may contribute up to \$15,000 of pre-tax annual compensation, as established by Act No. 1 of January 31, 2011 of the IRC-NPR. Participants who have attained age fifty (50) before the end of the plan year are eligible to make additional catch-up contributions of \$1,500 per year.

Total annual contributions made by the Plan Sponsor and participants are limited to the lesser of \$69,000 or the total compensation paid by the Plan Sponsor to participants during the plan year.

Compensation for matching purposes means the total compensation included for income tax purposes. It excludes contributions to a plan of deferred compensation, severance payments, overtime, bonuses, short, mid or long-term incentives and allowances, and non-exhausted vacations and sick leave. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plan (rollover contributions).

Pursuant to the Collective Bargaining Agreement, entered into the Plan Sponsor and the United Steelworkers of America (“the Union”), effective February 1, 2022, the Plan Sponsor is required, whether or not the employee contributes to the Plan, to make monthly contributions, as follows:

iii. Investment options -

Upon enrollment in the Plan, a participant may direct contributions into various investment options. The Plan currently offers various mutual funds, fixed annuities and collective trust funds as investment options for participants. Contributions to a participant account who has not chosen an investment option are invested in a default portfolio of funds, which may be changed by participants at any time thereafter. The Plan also allows participants to change their investments options.

iv. Participant accounts -

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution, (b) plan earnings, and (c) at the discretion of the benefit committee as designated by the employer, forfeitures of terminated participants' non-vested accounts. Accounts are charged with withdrawals and an allocation of the Plan investment earnings, as well as, with an allocation of administrative expenses. Allocations are based on the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

v. **Vesting** -

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contributions portion of their accounts is based on years of service. A participant is 100% vested after 5 years of credited service. The vesting schedule based on years of service is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
At least 1 year, but less than 2 years	20%
At least 2 year, but less than 3 years	40%
At least 3 year, but less than 4 years	60%
At least 4 year, but less than 5 years	80%
5 years or more	100%

vi. **Payment of benefits** -

Immediate distributions may be made at participant's election upon termination of employment. The forms of distributions are to be made, as elected by the participants, in a lump sum payment or in monthly installments over a period up to 20 years if the account balance exceeds \$5,000. Participants who have chosen to receive monthly installments may request a change in the installment amount once in every year. The normal retirement age is the date a participant attains their 65th birthday. Pre-retirement distributions are permitted at the participant's election from any accounts which are 100% vested if a participant has reached the age of 59 ½ years. A participant may withdraw amounts at any time from the salary after tax contributions account.

Under the provisions of the former El Día, Inc.'s union employees plan, effective on July 1, 2007, withdrawals upon reaching 59 ½ years are permitted only to participants that were born before January 1, 1950. Participants that were born thereafter may request pre-retirement distributions upon reaching the age of 67 years. Effective July 1, 2007, participants with account balances over \$5,000 may elect to leave their funds at the Plan until the participant reaches the age of 70 ½ years or for an additional period if requested in writing 60 days before the end of fiscal year when the participant reaches such age.

Participants upon termination or resignation, or retirees, upon retirement, may elect to transfer their savings to/from other plans qualified by the Puerto Rico Treasury Department.

Under the provisions of the Plan, participants are permitted to make hardship withdrawals for an amount, not to exceed 50% of the balance of the participant's pre-tax, catch-up and rollover contributions, reduced by any loan outstanding as of the financial hardship distribution date. Hardship withdrawal is only permitted if: (a) financial hardship is demonstrated, (b) the withdrawal is approved by the Plan administrator and (c) the withdrawal is allowable under the IRC-NPR. Hardship withdrawals for the purchase or construction of a participant's principal residence are limited to once in a lifetime.

Any participant who makes a hardship withdrawal cannot contribute to their participant tax-deferred contribution account for a period of one year thereafter.

vii. **Notes receivable from participants** -

Under the terms of the former El Día, Inc. Union Employees Plan, participants may borrow from their accounts a minimum of \$1,000 up to \$25,000 or 25% of their vested account balance, whichever is lower. For the former Editorial Primera Hora, Inc. Union Employees Plan, this provision is applicable only in the occurrence of certain hardship events, as defined under the Plan's provisions. The loans are collateralized by the balance in the participants' accounts and bear interest at a rate commensurate with local market rates for similar loans. Interest rates are within a range from 3.25% to 8.50% at December 30, 2024. Principal and interest are paid through payroll deductions. A \$25 loan origination fee is charged to the participant's account.

viii. **Forfeitures** -

The portion of a participants' account not vested at the date of his/her termination of employment is forfeited immediately. Forfeitures of non-vested account balances in any given year are used to reduce future employer contributions. At the Plan Sponsor discretion, forfeitures may also be redistributed to active participants in the Plan as of December 30th of the year in which forfeitures were made. As of December 30, 2024, and 2023, forfeitures of non-vested accounts amounted to \$9,930 and \$4,866, respectively. During the year ended December 30, 2024, forfeitures used to reduce Employers' matching contributions amounted to \$13,624.

ix. **Administrative expenses** -

Administrative expenses are assumed by the Plan and the Plan Sponsor. Custody, trustee, and investment advisory fees are paid by the Plan. Other costs for administering the Plan such as audit, legal advice, use of other specialists, among other charges are paid by the Plan Sponsor.

(b) **Summary of significant accounting policies:**

i. **Basis of accounting** -

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

ii. **Basis of presentation** -

The Plan's fiscal year ends of December 30th of each year. All references to years in these notes to financial statements represent years ended on December 30th unless otherwise noted.

The Plan has evaluated subsequent events through November 12, 2025, the date the financial statements were available to be issued.

iii. **Use of estimates** -

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

iv. **Investments valuation and income recognition** -

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (3) and note (4) for discussion of fair value measurements and contract value, respectively. Net appreciation in the fair value of investments includes the plan's gains and losses on investments bought and sold, as well as, held during the year. Realized gains or losses on the disposal of investments are

determined by specific identification and recognized on the trade date basis. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

v. **Notes receivable from participants** -

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

vi. **Risks and uncertainties** -

The Plan invests in various investments securities. Investments securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

vii. **Benefits** -

Benefit payments to participants are recorded when paid.

viii. **Administrative expenses** -

The Plan's expenses are either paid by the Plan or the Plan's Sponsor, as provided by the plan document. Expenses that are paid directly by the Plan's Sponsor are excluded from these financial statements.

Certain administrative expenses were paid by the Plan for the year ended December 30, 2024. Administrative expenses that are allocable to a participant account are paid from that account. Investment related expenses amounted to \$33,199 for the year ended December 30, 2024.

(2) **Information certified by qualified institution:**

The Plan Administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investments and notes receivable from participants' information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) were obtained or derived from information obtained by the Plan Administrator and certified as complete and accurate by Great-West Trust Company, LLC, qualified institution, and in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Great-West Trust Company, LLC, the trustee of the Plan, held the Plan's investment assets and executed investment transactions as of December 30, 2024 and 2023, and for the year ended December 30, 2024.

(3) **Fair value measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability; and
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 30, 2024, and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end, based on quoted market prices in active markets, adjusted for fees and expenses.

Collective trust funds: The Plan holds an interest in a collective investment trust (Putnam Large Cap Value Trust I) valued at NAV of units held, which are generally obtained directly from the fund or other investment provider. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Guaranteed investment contract with insurance company:

The Plan entered into a fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company (the Insurance Company). It covers its Key Guaranteed Portfolio Fund, which is a general account product. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The average interest earned by the Plan was 1.60% for the year ended December 30, 2024. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the fully benefit-responsive contract criteria, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 30, 2024, and 2023 was \$5,082,071 and \$4,997,530, respectively. The crediting interest rate is compounded daily to the effective annual interest rate. The interest rate to be credited during the calendar year will be determined by Great-West Trust Company, LLC prior to the last day of the previous calendar year and shall be reset annually. The effective annual interest rate will never be less than 1%.

Certain events might limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor's events that cause a significant withdrawal from the Plan, (iv) premature termination of the contract, among others. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

(5) Tax status:

The Plan has received its latest determination letter from the PRTD dated August 22, 2019, stating that the Plan is qualified under section 1081 of the IRC-NPR, and therefore, the related trust is exempt from taxation.

The Plan administrator and the tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC-NPR.

Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

(6) Plan termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to reduce, suspend or discontinue its contributions at any time and to terminate the Plan subject to compliance with certain ERISA provisions. In the event of Plan termination, the interest of each participating employee in the Plan will become 100% vested and such termination shall not reduce the interest of any participating employee or their beneficiaries accrued under the Plan up to the date of termination.

(7) Party-in interest investments and prohibited transactions:

The Plan's investment transactions are managed by the custodian, whose subsidiary is the record keeper of the Plan; therefore, transactions qualify as party-in interest transactions, as defined by ERISA.

In accordance with the Department of Labor's Regulation 2510.3-102, an employer is required to segregate participants' contributions from its general assets as soon as practical when amounts are contributed by participants or withheld from their wages for a pension benefit plan such as the Plan.

The costs incurred by the Plan as a result of the unintentional untimely remittances of participants' contributions and loans, as shown in the ERISA-required Schedule of Delinquent Participant Contributions, are absorbed by the Plan Sponsor.

During the years ended December 31, 2020 and 2021, there were unintentional delays in the remittance of participants' contributions withheld amounting to \$444,313 and \$421,172, respectively. The Plan Sponsor remitted lost earnings to correct late remittances as follows:
