## **INDEPENDENT AUDITORS' REPORT**

**To the Morrison Cohen Retirement and Savings Plan:**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Morrison Cohen Retirement and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Morrison Cohen Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## NOTES TO THE FINANCIAL STATEMENTS

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Morrison Cohen Retirement and Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution profit sharing and 401(k) plan which was established January 1, 1993, covering all employees of Morrison Cohen LLP (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Investment Committee has engaged an ERISA 3(38) fiduciary investment advisor to assist in monitoring investment performance.

#### **Contributions**

All employees (which includes partners of the Employer) except for union employees, leased employees and non-resident aliens are eligible to participate in the Plan after completing one year of service (at least 1,000 hours). Plan entry dates are the first day of the subsequent month after employees become eligible for employee contributions and January 1 and July 1 for employer contributions.

Eligible employees may elect to make contributions, either tax deferred or Roth, up to the maximum allowable under the Internal Revenue Code (IRC). Only partners and non-attorney employees (as defined) are eligible for non-safe harbor non-elective contributions, for which there is an eligibility requirement of one year (at least 1,000 hours) of service and being employed on the last day of the year. If the participant is not employed on the last day of the plan year due to death, total and permanent disability or termination of employment on or after normal retirement age of 65 the last day of year condition is waived. In years where the Plan is deemed top-heavy, certain minimum contributions are required to eligible associates, as defined, and to partners who are not key employees (as defined) and have not received the top-heavy minimum allocation. Eligible employees also can receive a discretionary matching contribution equal to a uniform percentage of the amount of salary reduction. There were no discretionary matching contributions for the years ended December 31, 2024.

Participants direct the investment of contributions credited to their accounts into various investment options offered by the Plan.

### NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Employer's contribution, if any, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Employees are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts plus actual earning thereon is based on years of service at a rate of 20% after two years of service, which increases by 20% for each year of service thereafter. If a participant reaches normal retirement age, becomes disabled, or in the event of death, the participant becomes fully vested.

#### **Notes Receivable from Participants**

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested portion of their account balance. Loan terms may not exceed five years unless the loan is for the purpose of acquiring a principal residence in which case the term of the loan may not exceed twenty years. The loans are secured by the vested balance in the participants' account and bear interest at the prime rate in effect plus 1%, as defined. Loans outstanding during the year had interest rates which ranged from 4.25% to 9.5%. Principal and interest are to be paid ratably through semi-monthly payroll deductions or directly from the borrower and credited to the borrower's account balance.

#### **Payment of Benefits**

The Plan provides for in service distributions of benefits once a participant has attained age 59 ½. Additionally, the Plan provides for benefits to be paid upon termination of service, death, disability or retirement. All claims must be made in writing. Payments can be made in the form of installment payments, lump-sum payments or required minimum distributions as prescribed in the plan document. In the event of a serious financial hardship, a participant may withdraw a portion of their participant account not to exceed the amount required to meet the immediate need.

### NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

#### **Forfeited Accounts**

On termination of employment, Employer contributions which are not vested, together with any earnings attributable thereto, become forfeitures. As of December 31, 2024 and 2023, forfeited non-vested accounts totaling \$182,313 and \$32,225, respectively, were available to be used to reduce either quarterly management fees, professional fees or future Employer contributions. For the year ended December 31, 2024, Employer contributions deposited relating to the 2023 plan year were reduced by \$32,205 from forfeited non-vested accounts.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee/custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

### NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value (“NAV”) per share. Accordingly, the Plan estimates the fair value of an investment using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan’s investments have been classified, the Plan has assessed factors including, but not limited to, price transparency, the ability to redeem at NAV at the year-end, and the existence or absence of certain restrictions at year-end.

### NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED) (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Money market and mutual funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Money market funds are valued at the NAV of shares held by the Plan at year end.

***Common collective trusts:*** Valued at the NAV of the units held by the Plan at year end. The NAV, as provided by the trustees/custodian, is used as a practical expedient to estimate fair value. The Columbia Trust Dividend Income fund totaling \$11,032,217 seeks to target total return consisting of current income and capital appreciation and primarily invests in a diversified portfolio of dividend-paying equity securities, which consist primarily of common stocks but also may include preferred stocks and convertible securities. Putnam Stable Value fund totaling \$8,226,214 seeks to preserve principal and achieve high current income through a diversified portfolio of high-quality investment contracts, by investing in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. There are no restrictions on a participant's ability to redeem their investment in the common collective trusts. There are no unfunded commitments with respect to the common collective trusts. The funds generally provides for daily redemptions by the Plan at reported NAV per share, without any advance notification. The funds may, in its sole discretion, impose restrictions on issues and redemptions of units.

***Self-directed brokerage accounts:*** Includes mutual funds and money market funds valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds and money market funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded. Also includes common stocks, preferred stocks and exchange traded funds valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and common collective trust funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee/custodian and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments as they are paid through revenue sharing, rather than a direct payment. Direct fees paid by the Plan to the trustee/custodian for administrative services amounted to \$55,600 for the year ended December 31, 2024.

### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination or partial termination of the Plan, participants' accounts shall be fully vested as of the date of such termination. The Employer determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

### **NOTE 7 - TAX STATUS**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 9 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 13, 2025 which is the date the financial statements were available to be issued.
