## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees  
Oncology Specialties, P.C. Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Oncology Specialties, P.C. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 31, 2025 (Date of Plan Merger), December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the one month period ended January 31, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 31, 2025, and December 31, 2024 and 2023, and for the one month period ended January 31, 2025 and the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## **1. DESCRIPTION OF THE PLAN**

The following description of Oncology Specialties, P.C. Retirement Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective January 31, 2025, the Plan merged into the OneOncology, LLC OneRewards Retirement Plan as such the transfer is reflected within the statement of changes in plan benefits for the one month period ended January 31, 2025.

The following note to the financials and key provisions are reflective prior to the Plan merger.

### **General**

The Plan was established on May 1, 1988, to provide retirement benefits for the eligible employees of Oncology Specialties, P.C. (the Company). The Plan is a defined contribution plan covering substantially all employees who are at least 21 years of age. Eligible employees are immediately eligible to participate in the Plan on the first day of the month following hire date. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Fidelity Management Trust Company (the Trustee) is the Plan's Trustee. Fidelity Workplace Services, LLC is the recordkeeper.

### **Contributions**

Each year, participants may elect to contribute up to 100% of eligible annual compensation as pretax or Roth contributions, as defined by the Plan and subject to the Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set at 6% of eligible compensation. Absent an election by the participant, the 6% pretax contribution deferral will automatically increase 1% per year up to 10% on the fourth anniversary date.

The Company, at its discretion, may also make contributions to the Plan. For the year ended December 31, 2024, the Company made a discretionary matching contribution equal to 100% of employee deferrals up to 6% of total eligible compensation. The Company may also elect to make a discretionary nonelective contribution based on an integrated allocation formula, as defined by the Plan. Employees must complete at least 1,000 hours of service to be eligible to receive discretionary matching contributions. Employees must have at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to receive the discretionary nonelective contribution. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$2,020,939 and discretionary nonelective contributions of \$1,189,287. Contributions are subject to certain IRC limitations.

**Participant Accounts**

Individual accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan, which includes an individual brokerage account that allows participant-directed investments in individual stocks and mutual funds.

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and Plan earnings, and reduced for Plan losses, charges related to participant withdrawals, loan disbursements and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings which have been credited to their account. Vesting in the Company's matching contribution portions of their accounts plus actual earnings thereon is based on years of service. The following details the Company's vesting schedule:

**Notes Receivable from Participants**

Participants may borrow from their compensation deferrals balance up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and as of December 31, 2024 and 2023, interest rates ranged from 4.25% to 9.50%. The Plan administrator shall determine the appropriate interest rate at any given time by following procedures that consider interest rates issued by lending institutions under similar circumstances. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of services due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of their vested account balance. For termination of service due to other reasons, a participant may receive the value of the vested interest in the account as a lump-sum distribution or defer the distributions until retirement age. In-service withdrawals are permitted after age 59½ or due to financial hardship.

**Forfeited Accounts**

At January 31, 2025, December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0, \$2,494 and \$80, respectively. Forfeitures may be made available to reinstate previously forfeited

account balances, to satisfy any contribution that may be required, or to pay any administrative expenses of the Plan. The remaining forfeitures shall be used to reduce the contribution of the Company for the Plan year in which such forfeitures occur. During the one month period ended January 31, 2025 and during the year ended December 31, 2024, forfeitures totaling \$0 and \$130,566 were used to reduce employer contributions, respectively.

**Administrative Expenses**

Certain expenses of maintaining the Plan, including transfer and investment fees, have been paid by the Plan. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the Trustee and investment advisors. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently,

management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Reclassifications**

Certain prior year amounts have been reclassified to conform to the current period presentation. Such reclassifications had no impact on the Plan's previously reported net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management has evaluated subsequent events through November 13, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under Financial Accounting Board Standards (FASB) Accounting Standards Codification (ASC) Topic 855, *Subsequent Events*.

**3. INFORMATION CERTIFIED BY TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of January 31, 2025, December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the one month period ended January 31, 2025 and the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee of the Plan.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.  
If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common stock (held in the self-directed account):* Valued at the closing price reported on the active market on which the individual securities are traded.

*Common collective trust funds (CCT):* Valued at the NAV of units held by the Plan at year end. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments relative to this fund.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. There were no Level 2 or 3 investments as of December 31, 2024 and 2023.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan terminates, participants become fully vested in their accounts.

**7. TAX STATUS**

The Plan adopted a prototype defined contribution plan FMR, LLC. The IRS has determined and informed FMR, LLC by an opinion letter dated June 30, 2020, that the prototype plan document satisfies the applicable provisions of the IRC. The prototype plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Accordingly, no provision for taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, including the IRS. The Plan is not currently under IRS examination for any Plan years.

We have audited the financial statements of Oncology Specialties, P.C. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the one month period ended January 31, 2025 and the year ended December 31, 2024, and we will issue our report thereon dated November 13, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by institution or insurance carrier that is regulated, supervised, and subject to period examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated October 22, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### **Significant Audit Matters**

#### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the one month period ended January 31, 2025 or the year ended December 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair value of investments held by the Plan is based on the valuation methods as described in Note 4 of the financial statements for each investment type. We obtained confirmation from the trustee certifying the fair value of the investments and agreed the Plan's financial statements to these amounts.

The financial statement disclosures are neutral, consistent, and clear.

### **Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### **Difficulties Encountered in Performing the Audit**

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### **Corrected and Uncorrected Misstatements**

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

### **Disagreements with Management**

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### **Management Representations**

We have requested certain representations from management that are included in the management representation letter dated November 13, 2025.

### **Management Consultations with Other Independent Accountants**

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### **Other Audit Findings or Issues**

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### **Other Matters**

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and

methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedules to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

During our testing of new hires, benefit payments, and participants, we noted several discrepancies between the date of hire per the participant's I-9 as compared to the third-party administrator's participant data. Since information recorded in the third-party administrator's database is used as a source for determining eligibility and calculating the participant's vested balance, failure to ensure accuracy of the participant data could potentially result in participants not being notified to enroll when eligible or not receiving correct distributions. We recommend that in the future, any new or updated employee data provided to the third-party administrator be reviewed to make sure it agrees with supporting documents in the personnel files.

During our testing of new hires, we noted one participant that was not automatically enrolled into the Plan in a timely manner. This resulted in the participant missing the opportunity to contribute for two months, and forgo earnings that could have potentially accumulated during this period. We recommend that in the future, new hires are compared to the autoenrollment report provided by the third-party administrator to ensure that all eligible employees are properly enrolled into the plan in a timely manner.
