## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of  
Aureon Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Aureon Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 8, 2025 and December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the eight-day period ended January 8, 2025 and the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Emphasis of Matter – Plan Merger**

As discussed in Note 1 to the financial statements, the Aureon Retirement Savings Plan Committee of Aureon Network Services, Inc., the Plan's sponsor, approved the merger of the Plan into the SuccessWise Pooled Employer Plan which was completed on January 8, 2025. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## **Other Matter**

### *Supplemental Schedule Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTE 1 — DESCRIPTION OF THE PLAN**

The following brief description of the Aureon Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document (Agreement) for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that covers substantially all employees of Iowa Network Services dba Aureon Network Services (the Company and Plan Administrator) who have 3 months of service and 6 months of service for employees and consultants, respectively, and are age 21 or older. Eligible employees may enter the Plan on the first day of the month following their meeting of the eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Merger**

In September 2024, the Aureon Retirement Savings Plan Committee of the Company adopted a resolution to merge the Plan into the SuccessWise Pooled Employer Plan (the Successor Plan) effective January 1, 2025 (Plan Merger). The final phase of the transfer process occurred on January 8, 2025 and the Plan ceased operations.

#### **Plan Administration**

Prior to the Plan Merger, the Company contracted Fidelity Management Trust Company (Fidelity) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Agreement, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to 100% of pretax annual compensation, as defined in the Agreement, subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additional discretionary Company profit-sharing amounts may be contributed at the option of the Company's Board of Directors. In order to maintain the Plan's safe harbor status, the Company commits to make 100% vested matching contributions for the first 3% of compensation deferral, and 50% of the next 2% of compensation deferral. Participants may elect to contribute to either a Roth or traditional 401(k) account, or both. There were no discretionary Company profit sharing contributions during the eight-day period ended January 8, 2025 or either of the years ended December 31, 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contribution, allocations of the Company's discretionary profit-sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

As of January 8, 2025, all participant accounts had been transferred to the Successor Plan due to the Plan Merger.

**Vesting**

Participants are vested immediately in their contributions, Company safe harbor and qualified matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary and nonelective contribution portion of their accounts is based on years of continuous service and vest fully after 3 years of vesting service. Participants become fully vested in the other Company contributions after 2 to 6 years of vesting service, as defined in the Agreement.

**Notes Receivable from Participants**

Participants may borrow from their account up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Outstanding loans are limited to 2 per participant at any given time, are secured by the balance in the participant's account, and bear a reasonable interest rate. Principal and interest are paid ratably through payroll deductions.

On January 1, 2025, all notes receivable from participants were transferred to the Successor Plan due to the Plan Merger.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum of any amount equal to or less than the value of the participant's vested interest in his or her account. In-service withdrawals are available as defined. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over the vested balance to another plan, as defined.

**Forfeitures**

Forfeited accounts may be used to pay administrative expenses or to offset the Company's matching contributions. Employer contributions were reduced by \$2,143 and \$3,558 for the years ended December 31, 2024 and 2023, respectively. No employer contributions were reduced for the eight-day period ended January 8, 2025. As of December 31, 2024 and 2023, there were \$5 and \$449, respectively, available to offset future expenses and Company contributions. Forfeitures of \$5 were transferred as of January 2, 2025 to the Successor Plan.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of the fair value measurements utilized by the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the period.

**Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the period in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are recorded at the unpaid principal balance, plus any accrued but unpaid interest. Related interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The cost of administering the Plan is shared among the Plan participants and the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included as net appreciation in fair value of investments. Expenses paid by the Plan include administrative and recordkeeping fees and certain investment advisory fees.

**NOTE 3 — INFORMATION CERTIFIED BY FIDELITY**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the following unaudited information included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023 and for the years then ended:

Level 2, defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and

Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.
- *Money market funds*: Valued based on quoted prices of identical assets in active markets.
- *Participant-directed brokerage accounts*: These investments include a money market fund and common stocks which are valued at quoted prices in active markets and classified as Level 1.

**NOTE 5 — INCOME TAX STATUS**

The Plan was created from a prototype plan developed by Fidelity. The IRS has issued an opinion letter, dated June 30, 2020, that the prototype plan is qualified, and the trust established under the Plan is tax-exempt under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC under the prototype.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. Plan management has not identified any uncertain tax positions.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include shares of mutual funds managed by Fidelity. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Fidelity of \$1,500, \$56,161 and \$45,887, for the eight-day period ended January 8, 2025, years ended December 31, 2024 and 2023, respectively, and are included in administrative expenses. Fees paid by the Plan to Strategic Advisors, Inc. for investment advisory services for the years ended December 31, 2024 and 2023 were \$8,613 and \$5,461, respectively, and are included in administrative expenses. The Plan made direct payments to their Plan advisor, Creative Planning LLC, of \$42,000 for the year ended December 31, 2024, and are included in administrative expenses. The Plan did not pay Strategic Advisors, Inc. and Creative Planning LLC during the eight-day period ended January 8, 2025. The Plan did not pay Creative Planning LLC for the year ended December 31, 2023. Additionally, a participant who acquires a participant loan is a party-in-interest. However, these transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 — SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through November 14, 2025, the date the financial statements were available to be issued.
